Journal of the 40th Annual Convention.

DIOCESE OF MISSOURI.

CHRIST CHURCH, ST. JOSEPH,

Tuesday, September 23d, 1879.

In accordance with the provisions of Article II of the Constitution of the Protestant Episcopal Church of the Diocese of Missouri, a number of the Clergy and Laity assembled this day in Christ Church, St. Joseph, the place appointed by the Rt. Rev. the Bishop of the Diocese.

At 10 o'clock the usual religious services were had, at which the Rev. F. B. Scheetz, of Monroe, delivered a short address, after which the Holy Communion was celebrated.

At 3 o'clock P.M. the Convention assembled for organization. The Rt. Rev. the Bishop called the Convention to order and the Secretary of the last Convention proceeded to read the roll of Clergy canonically resident in the Diocese, and twenty-seven clergymen answered to their names.

The Rt. Rev. the President then appointed the Rev. Messrs. Curtis, Valiant and Waterman, the Committee on Lay Credentials.

Recess taken for ten minutes.

Convention reassembled after recess. The Committee on Lay Credentials reported that credentials in regular form had been presented from eighteen parishes, and upon calling the roll of Lay Delegates, Delegates from ten parishes answered to their names.

The Rt. Rev. the President then announced a quorum of both orders present, and the Convention ready for business.

Rev. Herman C. Duncan moved that the rules of order of the last Convention be adopted as the rules of order of this Convention.

—Adopted.

On motion of Rev. H. D. Jardine, Mr. John R. Triplett was reelected Secretary of the Convention, with authority to appoint an Assistant. The Secretary appointed Mr. F. J. McMaster his Assistant.

Rev. J. M. Curtis moved to take up that portion of the report of the Committee on Lay Credentials in regard to the admission of Delegates from St. Mary's or St. Luke's Church, Kansas City.—Adopted.

Rev. W. A. Masker moved that the name of St. Luke's Church, Kansas City, be changed to St. Mary's on the rolls of the Convention.

On motion Convention took a recess until 7.30 P. M. to hear the Convention Sermon, and then stand adjourned until 9.00 Wednesday morning.

After calling the roll of Clergy and Lay Delegates, the first day's proceedings were read, and, on motion, approved.

The Rt. Rev. President extended an invitation to all visiting clergymen to seats in this Convention. Rev. John Woart, Chaplain U. S. A., the Rev. Messrs. F. O. Osborn, of Atchison, T. W. Barry, of Leavenworth, and T. E. Dickey, of Nebraska City, presented their cards to the Secretary.

The Rt. Rev. the Bishop then read his annual address, which, together with a summary of the episcopal acts of the past year, were laid on the Secretary's table. (Both will be found at the close of the Proceedings.)

The Rt. Rev. President then appointed the following Standing Committees:

On Admission of New Parishes.—Rev. Messrs. Scheetz and Dunlop and Mr. John D. Pope.

On Unfinished Business.—Rev. Dr. Berkley, Rev. Mr. Duncan and Mr. E. H. Lycett.

On Finance.—Messrs. J. W. Branch, F. B. Haff and J. W. Luke.

On Assessments.—Messrs. M. W. Alexander, Gen. J. H. Simpson, U. S. A., W. A. Ross, H. Levin, J. M. Armstrong, Jos. C. Hull and J. D. S. Cook.

The Convention then resumed the discussion of the resolution offered by Rev. Mr. Masker on the first day.

Rev. R. A. Holland offered the following resolution:

Resolved, That the subject matter of discussion be referred to the Bishop and Standing Committee, or such members thereof as may be present, to report to this Convention, and that their report shall be final.—Adopted.

The Committee made the following report, which was adopted:

Whereas, St. Luke's Parish, Kansas City, with the consent of the Bishop, has changed its name to St. Mary's, and

Whereas, there is no canon law in the Diocese prescribing the method of such action, permission is given to St. Luke's, Kansas City, to change its name on the rolls of this Convention to St. Mary's Church, provided that this action by this Convention shall not be construed as prejudicing the legal rights of any claimants to the property left by Mrs. Troost, to a parish to be known as "St. Mary's Parish."

Convention assembled after recess.

The Secretary read the Treasurer's report of Board of Trustees of St. Luke's Hospital, which, with the report of the Secretary of the Board, were received and filed. (See Appendix, No. 1.)

The Secretary read the Treasurer's report of the Orphans' Home, which, with the Secretary's report, was received and filed. (See Appendix, No. 2.)

The Secretary read the report of the Bishop in account with Trust Funds. Received and referred to Committee on Finance. (See Appendix, No. 3.)

The Secretary read the report of the Treasurer of Permanent Fund. Received and referred to Committee on Finance. (See Appendix, No. 4.)

The Committee on Lay Credentials made a supplemental report, recommending the admission of Lay Delegate from St. Paul's Church, Carrollton. On motion, the delegate was admitted, and Mr. C. J. J. Martyr answered to his name.

Rev. H. C. Duncan offered the following resolution:

Resolved, That the Bishop be respectfully requested, in calling for the annual statistics, to include blanks for the number of free seats in each church and the method of its support.—Adopted.

Rev. A. Leonard offered the following resolution:

Resolved, That that part of the Bishop's address which referred to the subject of Missions be referred to the Standing Committee on Missions, with instructions to consider the recommendations of the Bishop, and to report as speedily as possible to this Convention.—Adopted.

On motion, the rules of order were suspended, and the Secretary read the report of the Treasurer of the Laymen's Co-Operating Missionary Society, which, with the report of the Secretary, was received and referred to Committee on Missions. (See Appendix, No. 5.)

The Secretary then read the following report of the Registrar:

To the Rt. Rev. C. F. Robertson, Bishop of Missouri.

Rev. E. F. Berkley, D. D., Chairman of the Committee on Unfinished Business, presented their report, which was, on motion, received.

Mr. J. M. Armstrong offered the following resolution:

Resolved, That Canon IV, Section 6, be amended, by striking out the words "two hundred and fifty dollars," and insert in lieu thereof, "fifty dollars."

Laid over under the canon for one day.

Committee on Admission of new Parishes made the following report:

The Committee on Admission of new Parishes, in the case of the application of St. Paul's Church, Maryville, report, that the papers presented are all correct, except that neither the legal nor canonical articles of association have been presented to them, though the existence of both is proven by the certificates of the Bishop and the clerk of the Circuit court, both of which are submitted. Also in the case of application of St. Mary's Church, Kansas City, Mo., all the papers required by Canon are presented; and hence offer the resolution, "That said St. Mary's Church, Kansas City, be admitted to union with this Convention."

The Rev. R. A. Holland offered the following amendment to the resolution appended to the report of the Committee on new Parishes:

Resolved, That St. Mary's Church, Kansas City, meaning the same which was organized by the election of J. O. Bradenbaugh and F. C. Lee, as Wardens, be admitted to union with this Convention.—Adopted.

On motion of Rev. F. B. Scheetz, St. Paul's Church, Maryville. was admitted to union with this Convention.

By supplemental report of Committee on Lay Credential, Mr. J. F. Ramage was accredited as delegate from St. Mary's Church, Kansas City, and answered to his name.

Rev. M. Schuyler, D. D., chairman of Committee on Constitution and Canons, made the following report:

Canon XXVIII. A Standing Committee on Finance shall be appointed at each regular Convention, by the Bishop or Presiding Officer, to hold office until their successors are appointed—to consist of three laymen, and in addition, the Treasurer of the Diocese shall be *ex officio* a member of the Committee. The duties of the Committee

shall be: 1st. To act and report upon the business that may be referred to it during the session of Convention. 2d. To serve as a Board of Advice, as such counsel shall be called for in the course of the year, upon financial matters to the Treasurer of the Diocese, to the Bishop, to the Standing Committee, and the managers of the several Trusts of the Diocese. 3d. To audit, before the date fixed for the meeting of the Convention, the reports of the various Treasurers, whose duty it is to report to the Convention, and examine the balances and the value of the investments, and to report such recommendations as they may deem fit with reference thereto.

Canon XXIX. To enable a parish to change its name, it shall be necessary that an application for this purpose be made, in case it is six months or more before the time for the meeting of the Convention, to the Bishop, with a full statement of the causes leading to this desire, who, by and with the advice and consent of the Standing Committee, shall have power to give consent to such change of name. On evidence thereafter that the change of name has been legally consummated, then ame shall be altered accordingly on the roll of the Convention, and it shall be known thereafter by its new title. All applications within six months of the time of the meeting of Convention shall be made directly to Convention, and it shall be lawful, if it seems best, for any application to be referred to the Convention for its action.

That Section 2, of Canon IX, be repealed.

Canon XXX, Sec. 1. The Diocese shall be divided into seven Missionary Convocations, as follows: The Convocation of St. Louis, consisting of the counties of Saint Louis, Franklin, Gasconade, Jefferson, Washington, Crawford, Phelps, Ste. Genevieve; St. Francois, Iron, Reynolds, Perry, Cape Girardeau, Scott, Mississippi, New Madrid, Pemiscot, Dunklin, Stoddard, Bollinger, Madison, Wayne, and Butler, -23. The Convocation of Springfield, consisting of the counties of Greene, Barton, Dade, Jasper, Newton, McDonald, Lawrence, Barry, Polk, Christian, Stone, Taney, Webster, Laclede, Wright, Douglass, Ozark, Pulaski, Texas, Howell, Shannon, Oregon, Ripley and Carter, -24. The Convocation of Sedalia, consisting of the counties of Pettis, Saline, Cooper, Moniteau, Cole, Osage, Henry, Vernon, St. Clair, Benton, Morgan, Miller, Maries, Camden, Hickory and Cedar, -16. The Convocation of Kansas City, consisting of the Counties of Jackson, Platte, Clay, Lafayette, Cass, Bates and Johnson,-7. The Convocation of St. Joseph, consisting of the counties of Buchanan, Andrew, Holt, Atchison, Nodaway, Clinton, Caldwell, De Kalb, Gentry, Worth, Harrison, Daviess, Mercer, Grundy, Livingston, Ray, Carroll, Chariton,-18. The Convocation of Hannibal, consisting of the counties of Ralls, Monroe, Marion, Lewis, Clark, Shelby, Knox, Scotland, Adair, Schuyler, Linn, Macon, Sullivan and Putnam,-14. The Convocation of Mexico, consisting of the counties of Audrain, Boone, Howard, Randolph, Callaway, Montgomery, Warren, St. Charles, Lincoln and Pike,-10.

Sec. 2. The Convocations shall be organized under the direction of the Bishop, who shall preside in them, when present. Each Convocation shall have a Dean, to be annually appointed by the Bishop, on the nomination of the Convocation. The Dean shall perform such duties as may be appointed him by the Bishop or Convocation, and shall report to the Convention, through the Bishop, at each regular session, concerning the missionary work in his Convocation. The Dean shall be ex officio a member of the Board of Missions.

Sec. 3. Each Convocation shall meet, if possible, at least twice during the year, and shall consist of the Clergy, residing within its limits and having seats in Convention, and of Lay Communicants, one from each Parish and Mission Station, chosen by the Vestry, if there is one, or by the Congregation, at a regular meeting or a meeting called for the purpose.

The Committee on Missions made their report, which was on motion recommitted to the Committee for revision.

On motion of Rev. Mr. Leonard, the Convention took a recess until 7.30 o'clock P.M., to receive the report of the Committee on Missions, and for matters in the interest thereof, then to stand adjourned to 9.00 o'clock to-morrow morning.

Convention reassembled 7.30 P. M. after recess.

After religious services, the Rt. Rev. the Bishop presented to the Convention the claims of the Missionary Interests of the Church in this Diocese, and called upon Rev. Mr. Talbot, Chairman of Committee on Missions, to read his report.

The report was then read, and the resolutions enbodied therein were adopted seriatim.

Resolved, That a fuller and more systematic presentation of the work of Diocesan Missions be made by the Cooperating Missionary Society and the Missionary Board, in order to bring to the knowledge of all in every possible way, especially through the Church News, what is being done, and setting forth the imperative needs in various parts of the Diocese.

Resolved, That it be recommended that each parish and mission station organize a branch of the Laymen's Missionary Society, in order to diffuse missionary knowledge, and make effective missionary zeal, and that, hereafter, greater efforts be made to interest the Sunday Schools in the work.

Resolved, That inasmuch as each year the Bishop and Missionary Board are rendered anxious on account of the uncertainty of the amount to be depended on for missionary purposes, and the permanence of the entire work thereby endangered, one evening during the session of each Convention be set apart exclusively for the consideration of this

subject, and this meeting be considered a regular part of the business of Convention, and that at such meeting the roll of parishes and stations be called in order to receive their pledges for the amount which, as a minimum, they will contribute towards the missionary work of the Diocese during the next year.

The Secretary then called the roll of parishes, and a number responded, and the sum of \$1,070 was pledged. Several of the Clergy and Missionaries delivered short addresses, setting forth their work, when the services were closed by singing the *Gloria in Excelsis*, and the Convention stood adjourned until 9.00 o'clock Thursday Morning.

THIRD DAY.

CHRIST'S CHURCH, ST. JOSEPH,

Thursday, September 25, 1879.

The Convention was opened with religious services, after which the Rt. Rev. President took the Chair and called the Convention to order.

After calling the roll of Clergy and Lay Delegates, the second day's proceedings were read and approved.

The following report of the Committee on Incorporation of "Bishop and Standing Committee," was then read by the Rev. G. C. Betts:

Your Committee, to whom was referred the preparation of Articles of Association, and a petition to the Circuit Court of St. Louis, for the incorporation of a body which shall take charge of Trust Funds for the Diocese, has completed the same, and herewith present such articles and petition in form approved by legal authority, and recommend the adoption of resolution appended to this report.

STATE OF MISSOURI, Ss. CITY OF ST. LOUIS.

First.—We, Charles F. Robertson, Montgomery Schuyler, P. G. Robert, George K. Dunlop, Silas Bent, Harry I. Bodley and John W. Luke, hereby associate ourselves as an organization, under the name of

"THE PAROCHIAL TRUST FUND OF THE DIOCESE OF MISSOURI,"
For the religious purposes hereinafter set forth.

Second.—The purposes of this organization are, and shall be, to take title to real and personal property which shall be from time to time conveyed, transferred, devised or given to it, in aid of the Protestant Episcopal Church in the Diocese of Missouri; to hold the same in trust for the purposes of such conveyance, transfer, devise or gift; to sell, convey and transfer the same in accordance with the terms of such trusts, and to execute any trusts connected therewith, and any other trusts not inconsistent with the purposes of said church, that shall be devolved upon it; and this organization shall continue for the term of one hundred years.

Third.—The affairs of this organization shall be managed by a Board of Seven (7) Trustees.

Fourth.—The Bishop of the Diocese of Missouri and the several members of the Standing Committee of said diocese of said church, from time to time, shall be severally ex-officio members of said Board of Trustees and Trustees, and they shall together constitute and be the said Trustees and the said Board of Trustees.

Fifth.—The officers of this organization shall be a President, Vice-President, Secretary and Treasurer, and such other officers as the Board of Trustees shall from time to time direct.

Sixth.—The duties of the President shall be to preside at the meetings of the Board of Trustees, and to exercise a general supervision over the affairs of this organization;

Of the Vice-President, to perform the duties of the President in case of his inability, from absence or other reason, to perform them;

Of the Secretary, to keep a written record of the proceedings of the Board of Trustees, to conduct, so far as directed by the President or Board, the correspondence of this organization, and to file and preserve all the deeds, documents and other papers of this organization, except as otherwise directed by the President or Board; and

Of the Treasurer, to collect, care for and disburse, under the direction of the Board of Trustees, all moneys which shall belong to this organization or come under its control.

Seventh.—During the first year of the existence of this organization said Charles F. Robertson shall be President thereof; said Montgomery Schuyler shall be Vice-President thereof; said Silas Bent shall be Secretary thereof, and said Silas Bent shall be Treasurer thereof. After the first year aforesaid the Bishop of the Diocese of Missouri aforesaid, from time to time, shall be ex-officio President of this organization. All the other officers aforesaid, except the Trustees, shall be chosen annually, by the Board of Trustees.

Consented to the election of the Rt. Rev. J. H. D. Wingfield, of Northern California, to be Bishop of Louisiana, and to the consecration of the Rev. S. S. Harris, D. D., Bishop elect of the Diocese of Michigan.

Resolved, Also, that this Convention, especially its clerical members, will cherish the example he has left us of a pure life, a reverent love, and a martyr-like devotion to duty. He was a knight of the Faith, who wore white armor, and to him we believe it has been given to see the Holy Grail and drink of its sacramental joys.

Remarks were made pertinent to the report. The Convention then sung the 507th Hymn, and, standing, adopted the report, when the Rt. Rev. the Bishop offered prayers appropriate to the occasion.

The Report of the Committee on Finance was read, received and referred to Committee on Assessments, (See Appendix No. 9,) and the resolutions therein contained adopted, as follows:

Resolved, That the Treasurer be instructed to publish in the Church News every month, an account of the indebtedness to the Diocese of each Parish and Mission Station, also the receipt of any payment made on account of same.

Resolved, That the Parishes cannot be too forcibly reminded of the necessity of prompt payment at least once a quarter, of all assessments made against them, that the current expenses of the Diocese, which are always maturing, may be provided for without the humiliation and expense of borrowing money for that purpose.

Mr. J. W. Luke offered the following resolution:

Resolved, That the next Annual Convention of this Diocese meet in St. George's Church, St. Louis.—Adopted.

On Motion of Rev. M. Schuyler, D. D., the following resolution was adopted:

Resolved, That the thanks of this Convention be returned to the Rev. R. A. Holland for his able and eloquent sermon delivered before this body on the evening of the first day of its session.

Resolved, That the thanks of this Convention be tendered to the officers of the St. Louis, Kansas City & Northern Railway, for their

courtesies in reducing the railroad fare of Members and Delegates in attendance upon this body at its present session, and that the Secretary communicate this resolution to said officers.

On motion of Rev. Mr. Leonard, a committee of three was appointed by the Rt. Rev. President, to nominate members of such Board.

The Chair appointed Rev. Messrs. Dunlop and Leonard and Mr. Haff.

The Committee reported the names of Rev. R. A. Holland, Rev. J. P. T. Ingraham, D. D., and Rev. A. Batte.

On motion, the Secretary was instructed to and did cast the vote of this Convention for persons thus nominated to constitute the clerical members of the Missionary Board.

Committee on Missionary Travelling Expenses submitted their report, which was adopted.

On motion, Mr. Joseph Franklin was re-elected Treasurer of the Diocese.

On motion, Messrs. Silas Bent, G. H. Gill and C. S. Freeborn were elected Trustees of the Permanent Fund for the Support of the Episcopate.

On motion, the number of copies of the Journal to be published, was referred to the Committee on Publication of the Journal.

Recess taken until 1 o'clock.

Convention assembled after recess.

Committee on Assessments presented their report, which was, on motion, adopted. (See Appendix, No. 10.)

The Amendment to Section 6, Canon IV, presented on the second day, was called up, and, on motion, the words "one hundred" were inserted for word "fifty," and the amendment passed.

On motion, the minutes of the third day's proceedings were read and adopted, and the Convention then took a recess until 7.30 o'clock.

Annual Address

OF

THE BISHOP OF THE DIOCESE

TO

FORTIETH ANNUAL CONVENTION.

My Dear Brethren of the Convention:

It is always a very great pleasure to meet you for counsel at these annual assemblages. It is a double pleasure this year, because it was not my privilege to be with you at the last Convention, on account of my absence from the country. Our gathering together now is made noteworthy by the fact that, for the first time since 1867, and during my Episcopate, the Convention meets outside of St. Louis. You are all probably aware, from the letter sent out at the time, of the circumstances which occasioned the change of locality from Kansas City to St. Joseph.

I resumed my duty in the Diocese about a month after the adjournment of the Convention, and have continued, with only the interruption of a single week, ever since. I need hardly add anything to what I said in my short communication last year as touching the proceedings and the results of the Lambeth Conference. Speaking now, after the lapse of a twelve-month, I am quite as persuaded of the very substantial benefits which have resulted from the assemblage, in a manner so august and significant, of so many Bishops. To us, as giving a more clear impression of the vastness and comprehension of the Church, of the singular simplicity of purpose, and of the large learning and ability with which, at least in this generation, the English Episcopate is addressing itself to social conditions of unusual delicacy and difficulty. To them, as being brought into contact with the representatives of Churches carried on under circumstances, political and social, wholly different from their own; and as being compelled to consider the necessity, in the spread of

the English race and the new positions assumed by Romanism, of modifying a policy which needed before to have been little more than insular. Many other principles were concluded upon besides those which have immediate interest to our own Church; but those which announced the bonds of unity of the widely scattered branches of the vast Anglican Communion, and the method by which that unity should manifest itself and become more effective; the principle by which liturgies should accommodate themselves to national and social habits, while maintaining exactness in the administration of the sacraments; the principle of reference to the Bishop in disputed matters of ritual; the digesting of means by which all the energies of a vast body can be called into use without the elaboration of rules too minute: all these principles were worthy of the occasion and justified the time spent. There was much else, beside, that was done, of very positive value to those who were present, but which would elude description and recapitulation. The kindness which met us on the moment of our arrival, and followed us to the close, making the visit profitable and agreeable, was what can never be forgotten. I have in different occasions since my return, made addresses, giving some of the results of my observations in various countries.

The House of Bishops, during my absence, found itself called upon to perform the very painful duty of accepting the resignation of his Diocese by the Bishop of Michigan, and of deposing him from his high office and the ministry. There were circumstances in the conditions of the case which were novel; but, however distressing the situation, I quite think that the action taken so unanimously by the Bishops was the only course which was left to them. Within a few days past a Presbyter, who had made himself a distinguished name for vigor, ability, and good judgment, has been consecrated to the Episcopate of the vacant Diocese.

In the death of Bishop Odenheimer the Church in this country lost one of its most sterling, straight-forward, able Bishops; bold and outspoken in his convictions, but gentle as a child in his tender consideration of the feelings of others. All who knew him grieved as over a personal loss when the intelligence came of the sudden death of the loved and venerated Bishop of Louisiana. His simplicity and directness, his wonderful sweetness and unworldliness, were combined with a width of learning and incisive good sense, which made all that he said of the greatest weight. In every way he was a most beautiful pattern of a Christian Bishop, and worthy of the best ages of the Church.

It is surely not out of place, even now when months have elapsed and accustomed us to our loss, and when his place has been, so far as it was

possible, supplied, to speak of the death of the Warden of Racine. I have before this, and in another place, expressed my estimate of Dr. De Koven's character. No one came in contact with him without being elevated and rested by the profound spirituality and humility and freshness and fervor of the man. He leaves many places vacant which will wait long for one who can fully fill them; but he gave to the position of a Christian educator of youth such a dignity by repeatedly turning his back upon distinguished places offered him elsewhere still to hold this, that it became worthy of the proudest man's efforts to secure and retain.

Our own clerical family has not remained unbroken by death this year. Any one who saw the emaciated form and the spent strength of our dear brother Buck of Kansas City, at the last Convention would have to admit, however unwillingly, that, in spite of the unconquered will and energy of the man, he could not remain much longer with us. His beautiful example of patience, self-sacrificing labor, and loving care for his people was maintained almost to the last, and in that city, throbbing with feverish life, he might be seen, when no longer able to drag his steps slowly along the streets, carried still to perform his work. It was a life of silent consuming devotion to high ends, which hushed all cavils, and will long live as an inspiration to his people and to his brethren.

I have visited all the parishes and mission stations in the Diocese, and many of them two or three times, besides employing time not otherwise occupied, both Sundays and week days during the year, in giving service to parishes which were vacant, as far as I was able. The confirmations, I am very sorry to say, have fallen in number below those of last year, and are below those of any year since I have been in the Diocese. I have, in fifty-seven different places, and on seventy-three occasions, confirmed three hundred and sixty-eight persons. It is fair to say that, compared with last year, there are very decided gains in the portion of the Diocese outside of our larger cities, and the losses in this department of the Church's work are in the greater centres, where it is usually presumed that the Church's growth is the largest. I recognize, too, as a very important element in the matter, the long continued vacancies in several very considerable parishes, from which, in consequence, no candidates have been presented.

I do not think that any of the clergy have been remiss in this matter; indeed, look where I will, I see most faithful, persistent and often self-sacrificing labor. I do not think we have a laggard in the Diocese. But I see the influence, as affecting this department of our growth, of the debts which rest upon many of our Churches, and take the heart and the

ed and it was spirituality out of many of our clergy. I have had too many occasions for expressing myself on this subject to require that I should at this time give my views on it at length. The spirit of worldliness comes in upon us by too many ways when all is propitious, deadening the enthusiasm of minister and people, cheapening the value of heavenly motives and spiritual things, making light of our horror of sin, and our desire to build up the Church of Christ; but the case is made much more difficult where there is the anxiety on the minister, and, whenever they think of it, the fret on the people, acting in a score of ways to depress the vitality and impede the aggressive action of the Church.

This cause acts in other ways, as well to restrict our confirmations and affect all other modes of growth, but it has especially done so, in preventing our entering upon new openings all the time presented in our growing cities and in the new towns made by the advancing railways. It has not been our policy in the Diocese to organize parishes prematurely, but to be content with the creation of mission stations, until greater strength and assurance of permanence should be acquired. But it has not been possible for us to begin either in St. Louis or here, or in Kansas City, in new sections, where population is rapidly increasing, those missions under the fostering care and support of the older parishes, such as the need requires, and there would have been ability and disposition for, if there had not been the preoccupation of existing obligations first to be There has been as the natural result, from the cause which we are considering, almost a hostile attitude towards the beginning of any new work, involving, as it might, a withdrawal of some of the strength required to meet existing obligations on the older parishes. This enforced abridgment of our aggressive efforts in town and country has had its effect in reducing the number of confirmations.

u

The number of clerical changes in the Diocese since the last Convention has been greater than usual. Christ Church, Springfield, which was vacant a year ago, still remains so, in spite of my efforts to induce them to call a clergyman. Here, as often, the parish falls behind in its current expenses; it pledges too much, or else it fails to collect up its accounts promptly at the time. The amount is borrowed when the clergyman resigns, and the parish does not care to call another until this debt is paid. And as little is ever done during a vacancy, and interest of all kind declines, months go by and not only is the debt not paid, but there is less disposition to rally and secure a clergyman. The canon recognizing the Bishop's power to send a clergyman to a vacant parish is virtually inoperative, as he has not the means to secure his support while in duty.

For a cause very similar Grace Church, Carthage, has been vacant since the resignation of the Rev. Mr. Wall, more than a year ago. The Rev. Mr. James, of Tennessee, visited them last spring, but no arrangement was completed: the Rev. Mr. Dunn, of Lexington, has visited them within a few weeks. This very thriving place should by no means remain longer without services. Often where local circumstances prevent a combination with any other parish or station within reach, the amount of salary offered is not sufficient, together with any practicable amount of missionary help which our treasury can afford to offer, to secure the quality of talent which alone the parish is content with, or indeed a living support for any one.

The Rev. Mr. Wall still resides in Carthage, having, since his resignation of the parish there, given his time, until within a few weeks, to Neosho and Joplin. Circumstances have, however, lately compelled him to discontinue his services at Neosho. At Joplin, under his care, an unusual degree of interest has been manifested.

All Saints, Nevada City, has finished the payment of the debt upon its Church, but it has had to be content with only occasional services during the year. The same is true of the interesting mission in Butler, Bates County. Calvary Church, Sedalia, fell vacant on the first of December last by the resignation of the Rev. J. Wood Dunn, who found our climate too rigorous for him; and the parish, to my great regret, has since that time remained vacant. The Rev. Mr. Curtis, of Boonville, gives them occasional services.

The parishes at Warrensburg and Pleasant Hill have remained vacant during the year; the latter having become very much depressed by the removal of the larger part of the congregation. Trinity Church, Independence, which has finished its Chapel during the year, fell vacant when the Rev. Mr. Holeman returned to Florida on the first of December last, and since then, owing to the debt incurred in building, has not felt itself able to have clerical services. The Rev. Mr. Valliant removed into the Diocese from Tennessee shortly after the last Convention, and took charge of the parish at Weston, and the stations at Platte City and Liberty. The work in the latter place is particularly interesting, and a very neat Church has been built and paid for there during the year.

The Rev. Mr. Jardine, of the Good Shepherd in St. Louis, shortly after Easter entered upon the rectorship of St. Luke's Church, Kansas City, made vacant by the lamented death of the Rev. Mr. Buck. St. Luke's has changed its corporate name during the year to that of St. Mary. I have also, by and with the consent of the Standing Committee, given permission for the organization of a new parish in Kansas City by the name of St. Mary's.

The Rev. Mr. Sherman took charge in July of the parish in Mary-ville, and has been engaged in the difficult task of restoring the work after the complications caused by the misconduct of his predecessor, and the consequent vacancy. It has not yet been possible for him to undertake duty at Savannah and Amazonia. The Rev. Mr. Bennett has recently resigned his charge of the stations at Cameron and Plattsburg. The Rev. W. W. Corbyn, who was engaged in school work at Macon, and occasional duty in the vicinity, has removed to Texas. The Rev. Robert Talbot and F. W. Henry have been ordained during the year, and are engaged, under the supervision of the Rev. Ethelbert Talbot, the first in charge of Grace Church, Brookfield, and the latter of Trinity Church, Kirksville. In the former place a Church, most eligibly located, has been purchased, and very neatly fitted up for our purposes. The former work of the Rev. Mr. Huntington, beyond that which Mr. Henry has charge of, is under the efficient care of the Rev. Mr. Scheetz.

The Rev. Mr. Matrau has been ordained, and taken charge of the Churches in Pike County; and the Rev. Mr. Gay has come to us from Kansas, and has charge of St. Mary's Church, Fayette, and the work at Glasgow. The Rev. Mr. Gray has come to us from Tennessee, and has the charge of Calvary Church, Columbia, and St. Paul's, Mexico, as well as Montgomery, where a very pretty Church has just been completed. Trinity, St. Charles, still feels itself unable, on account of its debt, to offer any salary for a clergyman. Trinity Church, Marshall, is about to begin the erection of a parsonage, which will involve Mr. Woodruff's removal from Miami, and another arrangement for the care of Carrollton.

The Rev. Mr. Moore has removed to Tennessee, and his work at Cape Girardeau and Jackson still remains unsupplied. The Rev. Mr. Staples was compelled to resign the charge of St. Paul's, South St. Louis, on account of the increasing infirmities of age, but still resides in the parish, honored for the beautiful traits of his character. Ironton, where I have recently consecrated an exceedingly neat Church, and De Soto, still feel themselves unable to sustain a clergyman. The Rev. Mr. Batte has added to his duties at Emmanual Church the care of Holy Innocents, Oak Hill. The return of the Rev. Mr. Lawrance to England last spring left St. James' Church, Elleardsville, without a pastor.

The Rev. Dr. Ingraham is just closing a rectorship of eleven years of faithful service in St. John's Church, St. Louis. This, and the removal of the Rev. Mr. Jardine from the Good Shepherd to Kansas City, are the only changes this year in the St. Louis Churches. The Rev. Mr. Thompson will, next month, remove from the charge of our colored Church of the Good Samaritan to Tennessee, and his place will be taken by the Rev. Mr. Cummings, who has been recently ordained.

It will be noticed that the number of vacancies which I have reported is very large, much larger than it ought to be. I do not dare to compute what amount of loss to every religious interest, to the young and to the old, results from this. In most cases the Sunday School is maintained; in a less number lay reading is kept up; and, in a few, some other parochial activities are continued: but in all the withdrawal of parochial visiting, the absence of the sacraments and other ministrations works carelessness in personal and family and parochial habits and duty, which is only recovered from, if at all, after a long time. Besides this, the sick have not the consolations of religion, the dead often go without Christian burial, and churchmen removing into the place, not being looked after, decline into other associations.

And yet the vacancies have continued in spite of my constant offers to help in supplying them, of the proposing of names, or the proffer, where needed, of such modest missionary help as we were able to afford; this was without response, except in one or two cases where the desire for a clergyman was expressed, but such a small salary named as has put it beyond my power, so far, to secure a minister for them. To accuse the vestry and the vestry system is generally aside from the point; because, while in some cases very evidently the vestry does not respond to the strong desire of the people for action and for services, yet generally the fault extends beyond and includes the people as well as the All are alike indifferent. In some cases there is a sensible willingness, considering the amount of salary offered, to desire simply good sense, devotion to his calling, and patience; but not unfrequently the choice is delayed because of the impossibility to find, in one person, all the qualities demanded, at the salary which is named. The bishop is asked to provide that which can probably never be found, and in the meantime useless hopes are excited, and valuable time is lost.

Then, too, it is certain that, while the supply is ample for any of the larger vacancies as they occur in the church, the numbers are inadequate of those who are willing and fitted for the weaker and more scattered places where the beginnings of our church work must be laid. The compensation is small, the opportunities for retirement and study are few; dealings must be had with many who are not church people, and others who have an inadequate notion of the church; the requirements are often exacting and capricious. Scholastic habits and training, of the importance of which I would be far from expressing disparagement, often render a minister accustomed to habits of theological expression and to a range of topics, and to modes of worship which are only modified to actual necessities with difficulty and a shock of feeling.

Early engagements of marriage have perhaps been formed, which cause impatience to secure settled work, before one has done his full share of that frontier labor which, if done at all, must be done by those who can contentedly make their home where they happen to be, and who, with the fresh enthusiasm of their ordination vows upon them, are willing to be thrust into the very forefront of the work.

But a cause more potent than any other in causing an inadequate supply of ministers for our needy places, and a general condition of unrest among the clergy, is the irregularity in meeting the engagements respecting salary, on the part of the church to the clergyman. There doubtless may be causes further back leading up to this-diminished piety, bad business, and a lack of good understanding. But the anxiety for the last few years in almost every parsonage about the common needs of life—the struggle to maintain position, and honorable meeting of obligations, and keep up to one's work-resulting from failures or delays to meet what had been reckoned on as the honest wage of labor fairly done, has caused in some broken health, in others halfhearted work, in still others a secularized, worldly tone; in others a throwing up of the ministry altogether. The fault goes back from one person to another, and almost everyone is involved. I cannot take time to urge how grave it is in its results, and on the other hand how gladly the best of services will be given and all hardships shared, if honest good faith all round will only be brought into the dealings of a people with their minister.

The number of our clergy is just the same as it was a year ago. Three persons have been ordained Deacons and the same number have been advanced to the Priesthood, while the number of Candidates for Orders has increased to five. The burden of debt, while very pressing in certain quarters, has very greatly diminished in volume during the year. The very large amount of nearly sixty thousand dollars, which, by an extraordinary effort, St. George's Church, St. Louis, has raised during the past year and paid, to relieve itself wholly from debt, places that important parish at a singular advantage. It witnesses to the devotion of the congregation to the interests of their spiritual home, and it will not fail to promote greatly their religious prosperity. In no case in the Diocese, so far as I am aware, has new debt been created: two churches, other than St. George's, built several years since, have this year at length finished paying themselves out of debt; one, St. Paul's, Ironton, has been consecrated, the other, All Saints', Nevada, awaits consecration. The two churches begun and finished during the year,

at Liberty and Montgomery, were completed without debt. In all quarters there is a wholesome desire to restrict outlay by the ability to pay, and an honest purpose to pay what is due, at the earliest moment.

I have a very grave solicitude over the condition of our missionary Not at the results produced by the outlay, because the most cheering indications of growth and of the strong, solid advance of the Church, have been shown in those communities in which the services are maintained by help from missionary sources; nor in the failure to redeem promises made to the missionaries; these, though insufficient, have been always met at the time. But I cannot forbear disquiet in the very serious shrinkage, both in the amounts received, and in the degree in which, as judged by parish meetings and parochial interest, attention to this primary matter of church growth and life has diminished. I am the more called upon to speak of this matter now, because it is only in this form that our missionary work is really presented to the Convention. The Co-operating Missionary Society makes no report, except the bare recital by the Treasurer of his receipts. It does not, by a bold sketching out of the missionary situation of the Diocese, hold the attention and fasten the thought of the Convention on this vitally important department of our work, if we are to be a living, growing body. The Missionary Board of the Diocese makes no report beyond the meagre enumeration by the Treasurer of his payments. I could wish that there was disposition to make statements as to the nature and condition of the work, independent of that made by me. The Standing Committee of Convention on the subject of Missions, has for several years, to my regret, refrained from making any other than a verbal report; and thus the matter has not detained the mind of this body, beyond what has been said of it in this address. I would have been willing that our methods had been criticized, that our slowness had been reproved, that our accounts had been questioned, rather than this easy acquiescence, which shows and arouses no interest.

The original purpose of the Laymen's Society has been sedulously maintained, in encouraging and maintaining itinerant missionary work; but the appellation of Laymen's Society, which was meant to signify that its work was to be taken in hand and managed by laymen, as distinguished from clergymen, does not seem to me to be realized in fact. There are but few parochial missionary societies, and those, I fear, are mainly urged and kept to their work by the ministers. The parent society has no existence in the course of the twelvemonth, except for the hour of its annual meeting in Convention week. So far as I know, the Executive Committee, to which it entrusts its authority in the in-

terval between Conventions, holds no meetings and has no agency in recruiting the funds of our missionary treasury.

What is done in this matter is done by the exertions of the Treasurer, the quarterly offerings of the mission stations, the unfailing devotion of two or three parishes and the liberality of one man. Now I am impatient of unrealities. If the agency on which we have depended is no longer adapted to our circumstances, let us modify it. But for those who are charged with duty in this work, it prevents us from resorting to other methods for enlarging and having security as to our means, to have to depend upon what is really only a semblance.

The Missionary Board have to assume obligations, which stretch for a twelvementh into the future and affect vitally the convenience of a number of families and the continued operations of a number of churches. It should use all the means likely to come into its hands, because the need is very great; at the same time it must not, if possible, make pledges which it cannot fulfill. Our reliance is exceedingly vague and uncertain, and because of this we have had to restrict our work, and keep a larger balance in the treasury for the sake of safety, and that we might not fail in our promises. Some of the larger churches of the Diocese, in St. Louis especially, which could, up to within a year or two, be depended on for hundreds of dollars, have now shrunken to insignificant amounts.

What I think, among other things, is needed to be done in the matter here at Convention, is the giving of this subject a distinct consideration in the regular order of business here; that, very much as the General Convention has done with general missions, we should, as a Convention, consider the reports of the past year, the work in which we should engage for the coming year, and that, if improvements can be be suggested in our methods, they should then be proposed. To this end, an evening should be set aside for this subject. And further, it is very well worthy of consideration, whether business exactness and the securing of ability to make and meet engagements, do not require that we should adopt the means found necessary and every way practicable in many Dioceses, of securing at Convention the pledges of what the parishes will do for our Diocesan missionary work during the year.

I hope that this whole subject will receive from you the attention which is its due. Of course, I need not suggest, that no improvement in our methods will avail us anything, unless there is a deep and abiding conviction among clergy and people of the utter importance of this branch of the Church's work, and a purpose to widen the interests and use the means and liberality needed to make the interest effective and useful.

I think that we may fairly mark a distinct advance this year in the matter of our Church Schools. No new ones have been established, but those existing are in a much firmer condition than they were a year ago. St. Paul's College, under the wise management of the Rev. Dr. Wainwright, is gaining the recognition which is its due, and with its full force of teachers, its healthful locality and its long established character, it must, I think, with our returning prosperity, soon find its building filled. The General Convention, at its last session, very wisely, in my judgment, recommended that a deeper interest in our public schools should be shown by the clergy in order to make as useful as possible what is for us in this country a necessity. At the same time this is wholly consistent with a strong advocacy of those schools of ours, which, without sacrificing thoroughness in the least, add to this an attention to the spiritual growth and morals and the manners of our children.

The school of the Good Shepherd has opened this year with double the number of last year and with prospects which take away all present anxiety. The benefits of the school can never be wholly available to our people, however, until, both on the score of permanence and cost, we have a building of our own for its home. No Church work before us is more important and no expenditure will pay back better results for the outlay, than the thorough establishment of our Church School for girls.

Many of you have heard with pleasure of the public interest shown in Mr. Talbot's Academy, at Macon, by the giving of such generous amounts for its permanent foundation there. I can testify to the painstaking honesty of the drill and instruction imparted, and this is being naturally responded to by persons in many of the towns around coming to Macon to enable their children to have the exceptional advantages there to be secured.

The year has been an anxious one for the Orphan's Home, made so in part by the anxiety of the parishes on which it chiefly depends for aid, about their own support. The institution is of diocesan interest, as almost constantly the orphans are being sought for by families through the State; and as I meet them frequently in my travels, I hear very excellent accounts of their habits and temper. If we could follow the work of the Home and see how many hundreds of children have been taken from the ruins of desolated families, or as waifs been seized as they were drifting into want and vice; and after a few years care, been placed in positions where now they are happy and useful and respected, we could begin to measure the blessings resulting from the work at the Home.

and and St. Luke's Hospital has ended this year with prospects and in a situation much brighter than that with which it began; its advantages and care were never so much sought for; its pecuniary affairs were never so carefully attended to, or in a better state; it never approached so nearly the condition of self-support, or was less of a burden on the Church. This is much to say. You may some of you be aware of the fact that Mr. Henry Shaw, whose public spirit and wide and intelligent benefactions St. Louis delights to honor, has this year purchased in an eligible location sufficient ground for the permanent building of the Hospital, deferring the conveyance of the property only until the Managers shall have in hand \$15,000, with which to proceed with the building. It is not thought that there will be any great delay in accomplishing this result and going on with the building. It is of the greatest moment to the prosperity and economical administration of the charity.

Both in the Hospital and School, the Sisters, with characteristic unselfishness, are patiently and persistently prosecuting their excellent work. They need a home, however modest, separate from the crowded and inadequate apartments, which they have at the Hospital and the School, in which may be taken and trained for future work those who are from time to time offering themselves to replenish the force of those worn out in their exacting service. Only thus can the failing numbers of qualified workers be kept up.

This address and the business of the Convention is necessarily concerned mainly about questions of methods and details. occupation is to see to the joints and the bands of the spiritual body, that the agencies adapted for the furthering of its work shall, at our hands, in the portion of the church which is under our care, have the greatest possible efficiency. Underneath all our action here and elsewhere, giving it its motive and continuing inspiration, is the strong sense of the gravity of the trust which we are set to administer, and of the large blessings, religious and social, which will follow upon a wide application of the doctrine, and sacraments and discipline of Christ, as the Lord hath commanded, and as this church has received the same. We do not hold our heritage in the past any the less really or cheaply for our not frequently asserting it. The highest glory and the greatest use of the past to us is that we use its legacy of doctrine, order and worship for the greater efficiency of our work in the present. The fact of our possession of it ought to be quite as conspicuous as the means of our wider success and adaptation to present emergency, as the occasion of boasting of inherited advantage.

It was a very remarkable impetus that was given to the church thirty-five years ago, at first in England, and then at length communicating itself to us in this country, when a revived consciousness of its origin and power, and duties, seized upon clergy and members. quickened every activity, revealed new meanings and depths in truths that had long been tamely rehearsed; enlivened devotion; enlarged liberality and opened new avenues for its exercise; incited to greater self-denial and bolder ventures of faith, as the awfulness of the trusts given to the church gradually made themselves known. As usual, in the fulness of new life, there were excesses and losses to the church. But the benefit has been organic and permanent. The movement had for its entire motive to deepen the consciousness of the church as to its divine character and mission, to quicken the faith of the church, and to reassert the fact that the order and functions of the church had Any variation held or taught by heavenly and apostolic sanction. individuals as to the faith, being amenable and referable to well-defined creeds and standards, were immediately susceptible of amendment or discipline. Any overt acts, also, in reference to the order of the church, were met and corrected by very full and exact law on this subject.

But in reference to the matter of worship there has been, both in England and still more in this country, a greater indeterminateness in the law, and consequently in the practice and procedure in administering the law. And this for various reasons. It is not, as with the faith and order of the church, in its details, a matter of revelation or of apostolic prescription. It is largely affected by place and circumstance. And moreover the law on the subject is obscure and litigated, while particular interest in the matter is of such recent date that there has neither been time to secure the enactment of law, nor the adjudication of all disputed uses.

To enter into a consideration of the law of ritual in England, or of the judgments pronounced there recently, would be aside from the present matter, and involve tedious length. We are in certain, clear, historic descent from the church in England, and through it have a part in the traditions and devotional accumulations and treasures of all the ages. At the same time we are a national church, having now a century of age, and competent to establish a ritual for our needs. In part this was explicitly done a hundred years ago; but because of the habits prevailing then, making law in many respects needless, and also because of an absorption in other interests and an indifference to this, there are many matters which have come to the front within the last few years, which are not settled in any written law of ours.

Whatever force of law may have attached to the canons of the English church on ritual or other matters at the commencement of our separate church life in this country a hundred years ago; I cannot but think that, with regard to such as have not by us been distinctly or by implication re-enacted, the lapse of a century has caused them to lose any force as law. However interesting they may be as historical illustrations, the long lapse in use, and the failure, when there was a competency to do so, if there was any disposition, to re-enact them, would ,in my judgment, prevent us here and now from appealing to those old canons as law. It would be seen, on a moment's thought, to what a difficult alternative any other proposition would lead us; and how, if the early English canons and rubrics are of force with us after long disuse and deliberate omission of re-enactment, simply because we are of the same historical lineage, there could an equally good plea be made in favor of the binding obligations of the earlier service books out of which the English Prayer Book had its rise.

There are changes going on in the community, in the standards of taste respecting architecture and music, and painting, of which the church and religious services feel the effect, as does everything else. That which an elevated sentiment and a fine taste, and an enlarging knowledge of other places and times shows to be fitting, the devout Christian desires to render to the worship and the church of God, that it may be of the best. This makes it impossible that, with regard to these matters of æsthetical taste, a hard and fast line, for all times and places, should be made.

But about these matters, as well as those which are more grave, which are meant to be expressive of doctrine, particularly as connected with the Holy Communion, differences at times arise between the clergyman and his congregation. He has traveled further, with these subjects in mind, and seen other usages; he has read more on the matter, and therefore is not so fixed to former habit; his studies make him dwell upon the past, while his people are mainly concerned with the present. Complications of all kinds follow from these parochial differences. The clergyman thinks that he is standing for a principle, and vindicating the historical position and rights of the church: The congregation think that in objecting to change they are standing for imperiled faith. All interests suffer; hardships are endured; pastorates are broken up; people are alienated; congregations go without ministers; suspicions tend to restrict liberality; confirmations, especially of men, become fewer; each side becomes more narrowly partizan; the church loses many opportunities. It is certain that the percentage of our gain in

clergy, confirmations and communicants, has, for the past ten years, been very considerably less than it was twenty-five years ago.

As this matter has risen into prominence, in so far as the complications have been caused by the uncertainty and defects in the church's law on the subject, it is of importance that a clear determination, not on all minute details, but on certain general principles, should be reached by our General Convention. The general dissuasives thus far uttered by it seem to have settled nothing. However difficult, and in some aspects, petty, the matter is, our peace and prosperity are involved in its settlement. It is to be presumed that when distinct law is made, it will be obeyed.

In the meantime, with whom lies the determination, in cases of difference between minister and people, in respect of those matters of ritual about which the law of this church has left no explicit directions, and which difference is declared to be disturbing the peace and prosperity of the congregation? Certainly I must hold that such determination must lie, in a church like ours, with the Bishop of the Diocese, acting with the counsel of his constitutional advisers. He may not, except on grave occasion, institute action in reference to irregularity, when the congregation, which may be supposed to be most concerned and best acquainted with the facts, does not declare itself to be aggrieved. But otherwise, when determination has been invoked, on every ground, the bishop, because of his possesssion of apostolic authority, and acting under the anxious constraints of a life-long office, removed from local prejudices, learned as to the principles which enter into the matter, desirous of the welfare of all—the Bishop is the one with whom the settlement of such questions can most safely The hundred bishops assembled at Lambeth were wholly unanimous in the judgment that no alteration from long-accustomed ritual or usage should be made without the sanction of the bishop first being obtained.

And such submission to the Bishop's godly judgments, even with a glad mind and will, has been pledged by each clergyman in the hour of ordination. I need not stop to say how unworthy of the time and the occasion it is to suppose that in this declaration, apparently so open and full, there is a pledge uttered in a double sense,

"That keeps the word of promise to our ear, But breaks it to our hope;"

so that the term "godly judgments" may be vacated of any particular meaning, and the obedience promised be only that which can be enforced by penal law.

I am wholly aware that there are inconveniences and conflicting interpretations of law possible from this; but this is inevitable wherever the indefiniteness allows any play of discretion. But there are the fewest dangers of this sort likely, when the authority is placed where, by the apostolic regimen of the church, it belongs, than in making every elergyman and every congregation the supreme arbiter, at a time when the judgment is disturbed by heated disputes. Furthermore, to vest the authority of decision in an anxious emergency in the Bishop, is to compel in him a caution, and solicitude for full justice all around, which gives the best guarantee for the most satisfactory result. And if it should happen that an unwise ruling is made, assurance may be had in the fact that there is a larger jury sitting on the case, whose verdict will in the end prevail, that in that

"Fierce light which beats upon a throne And blackens every blot,"

no bishop can possibly fulminate a judgment which shall long stand when it offends the common judgment of the church, and a bishop would naturally be slow in inviting such a contingency.

And then the very uncertainty and variation of ruling, supposing it to be so, will hasten what, after all, is the best thing to be desired, that the range of even episcopal discretion as to law, be reduced to the lowest possible point, and that exact direction, so far as possible, take its place. Certainly the Bishop is the last person to desire to enlarge the range of his own discretion and power; it is anxious enough as it is. But he must accept the duty, difficult and delicate as it is, which is put upon him by the uncertainty and deficiencies of the Church's law.

These are the principles by which my action will be governed in any emergencies that may arise. All things are capable of a solution happy for the Church, if all our work and all our life is passed in the near-felt presence of a loving Father, and all our judgments about each other are moderated by the consciousness that we all hope for mercy only as large allowances are made to us; and we remember that all our estimates of value are soon to be revised in a larger judgment, where we all, ministers and people, must answer for the several trusts committed to us.

I welcome you to this council, and hope that its results will lead to the furtherance of the Gospel of peace and to the building up of the Church of our dear Lord.

The people are generally in very narrow circumstances, and—excepting the two or three older families who have been there for several years, and who still continue faithful—are not able to contribute much towards the support of the Church. Mr. Abbott, candidate for orders, has most faithfully served the Mission since March last. I have given them occasional services.

"It shall be the duty of the minister of every congregation in this Diocese to make the following collections annually: I.
