Journal of the Convention.

St. Paul's Church, St. Louis,

Friday, May 25, 1860.

This being the time and place appointed for the assembling of the Annual Convention of the Protestant Episcopal Church in the Diocese of Missouri, the Rt. Rev. C. S. Hawks, D.D., the Bishop, with several of the Clergy and Lay-Delegates, met in St. Paul's Church, St. Louis, at half past ten o'clock, A. M.

Morning Prayer was begun by the Rev. John T. Worthington, D.D., Rector of Calvary Church, Louisiana, and St. Mark's Church, Bowling-Green. The Lessons were read by the Rev. Geo. P. Giddinge, D.D., Principal of the Palmyra Female Academy, and the Litany and Collects by the Rev. S. Y. McMasters, D.D., LL.D., President of St. Paul's College, Palmyra.

The Ante-Communion Service was read by the Rt. Rev. the Bishop of the Diocese.

The Annual Convention Sermon was delivered by the Rev. William Rawlins Pickman, Rector of Christ Church, St. Joseph.

After which, the Bishop proceeded to administer the Holy Communion, being assisted in the administration of the cup by the Rev. J. W. Dunn, Rector of Trinity Church, Hannibal.

The congregation having retired, the Bishop took the chair and called the Convetion to order.

Resolved, That the following be adopted as the

RULES OF ORDER.

- 1. That the business of the day shall be introduced with prayers.
- 2. The minutes of the Journal for the day preceding shall be read every morning at the opening of the Convention.
- 3. The President shall appoint the several Committees unless the Convention shall otherwise order.
- 4. When the President takes the chair no member shall continue standing, or shall afterwards stand up, except to address the Chair.
- 5. No member shall absent himself from the service of the House, unless he have leave, or be unable to attend.
- 6. When any member is about to speak in debate, or deliver any matter to the House, he shall, with due respect, address himself to the President, confining himself strictly to the point in debate.
- 7. No member shall speak more than twice, in the same debate, without leave from the House.
- 8. When a question has been once determined, it shall stand as the judgment of the House, and shall not again be drawn into debate, except on motion for reconsideration, which must be made by a member who had previously voted in the majority.
 - 9. When a motion is under consideration, no other motion shall be

made except to amend, to divide, to commit, to postpone, or to lay it upon the table; but a motion to adjourn shall always be in order, and shall be decided before the original motion.

10. Every member who shall be in the House when any question is put, shall, on a division, be counted, unless he be excused by the Convention.

11. No motion shall be considered as before the House unless it be seconded, and, when required, reduced to writing.

12. All questions of order shall be decided in the first instance by the Chair, without debate; an appeal, however, may be made from his decision to the Convention by any member of the same.

13. The President shall, in his discretion, select within the limits of those pews allotted for the use of the members, pews for the accommodation of visiting Clergymen and students of Theology, who may be invited to the same by the President without any special application to the Convention.

14. None of the Rules of Order shall be suspended without the concurrence of two-thirds of the members present.

15. Immediately after the organization of the Convention, the following Standing Committees shall be appointed, each to be composed of three members, except the Committee on Assessments, which shall be composed of seven members, viz:

A Committee on the Admission of New Parishes;

A Committee on the Constitution and Canons;

A Committee on Unfinished Business;

A Committee on Finance;

A Committee on Assessments;

A Committee on the State of the Church.

The Rev. H. Hooker, D.D., of the Diocese of Pennsylvania, present in Convention, was invited by the President, under Rule of Order 13, to take a seat in this Convention.

The Bishop then delivered the following Address.

THE BISHOP'S ADDRESS.

Dearly Beloved:—Once more I congratulate you that we are allowed again to convene, and greet you all with warm affection. In a Diocese of more than sixty thousand square miles, in which the Clergy and Parishes are, for the most part, widely separate, it is not often that we have the privilege of thus assembling. It is rare, too, that we come together thus with our ranks unbroken by death. It is our privilege now to measure our joys and sorrows and struggles, to commune with each other as to the past and the future, and to mingle our prayers. Thus are we comforted and strengthened while "striving together for the faith of the Gospel." Next to the consciousness of doing that which is well pleasing in the sight of the Lord, is the consciousness that we have in all our struggles the prayers and sympathies of those who love our Lord Jesus Christ and look for his coming.

Another year has passed over us and added, I trust, to our grace and wisdom. May Gon's Holy Spirit be every present with us, and especially at this time, as we convene in His name and presence.

Since the meeting of our last Convention, I have visited the following parishes and places. More places would have been gladly visited by me had the ability been allowed, viz: St. Mary's Church, Fayette; St. Paul's Church, Palmyra; Trinity Church, Hannibal; St. Jude's Church, Sharpsburg; Calvary Church, Louisiana; St. Mark's Church, Bowling-Green; St. John's Church, Prairieville; Grace Church, Kirkwood; Grace Church, Chilicothe; Christ Church, St. Joseph; St. John's Church, Savannah; St. John's Church, Weston; St. Luke's Church, Kansas City; Trinity Church, Independence; Christ Church, Lexington; St. Ann's Church, Brunswick; Christ Church, Boonville; Grace Church, Jefferson City; Trinity Church, St. Charles; Christ Church, La Grange; and St. Paul's Church, Trinity Church, Christ Church, Calvary Church, St. John's Church, St. George's Church, and Grace Church, St. Louis ;-also, the towns of Canton, Utica, Waverly, Miami, Westport, Platte City, and the settlement of Grandpass in Saline county.

The rite of Confirmation was ministered by me as follows:—In St. Mary's Church, Fayette, to 2 persons; in Trinity Church,

Hannibal, 1; in St. Jude's Church, Sharpsburg, 3; in Calvary Church, Louisiana, 1; in St. John's Church, Prairieville, 4; in Christ Church, St. Joseph, 15; in St. John's Church, Weston, 3; in St. Luke's Church, Kansas City, 2; in Christ Church, Lexington, 4; in Utica, 1; in Grandpass meeting-house, 2; in Miami, 1; in St. Ann's Church, Brunswick, 1; in Trinity Church, St. Charles, 6; in Calvary Church, St. Louis, 6; in St. Paul's Church St. Louis, 27; in St. John's Church, St. Louis, 16; in Christ Church, St. Louis, 27; in Trinity Church, St. Louis, 8; in Grace Church, St. Louis, 11; in St. George's Church, St. Louis, 32.

No new candidates for orders have presented themselves during the year; and Mr. Christopher Kyle has been allowed by me to withdraw his name as a candidate.

The number now in the Diocese is four, viz: Mr. Philip Mc-Kim, admitted Aug. 17, 1856; Mr. Frederick D. Lewin, admitted Dec. 18, 1857; Mr. Asher P. Crouch, admitted July 6, 1858; Mr. George W. Fleming, admitted May 14, 1859. Messrs. McKim, Lewin and Fleming are attending the Berkley Divinity School in Connecticut, and Mr. Crouch is prosecuting his studies in Cambridge, Saline county.

Mr. Crouch has been a very earnest and active Lay Reader for the past year in Cambridge, and I have reason to hope has done good service. In the absence of a Clergyman, a suitable Lay Reader may accomplish much. Mr. H. I. Bodley has during the year, regularly, as Lay Reader, kept our little flock at Kirkwood together, and the fruit of his good work we shall all, I trust, see on Sunday next, when I shall, God willing, consecrate the beautiful new Church edifice in that interesting neighborhood. It is of stone, and one of the most beautiful Church buildings in the Diocese, and you will be surprised and gratified as you look upon it as the work of a handful of zealous and loyal Church people.

During the year I have transferred no Clergyman from the Diocese—while I have had the satisfaction of increasing our small number. The Rev. John Coleman, D.D., has been received from the Diocese of Pennsylvania, the Rev. John W. Clark from the Diocese of Illinois, the Rev. Theodore J. Holcomb from the Diocese of Wisconsin, and the Rev. P. R. Johnson from the Diocese of Illinois.

The Rev. Dr. Coleman has become the Rector of St. John's

Church, St. Louis; the Rev. Mr. Clark the Rector of Calvary Church, St. Louis; the Rev. Mr. Holcomb has entered upon duty as a Missionary at Springfield; and the Rev. P. R. Johnson has become the Missionary of Chilicothe and Utica.

It is always gratifying to report, that the changes of residence among the Clergy have been few; the relationship between Pastor and people is very sacred, and where most permanent is usually most profitable. The ordinary causes of dissolution should be so thoughtfully and prayerfully watched by both parties, that

these changes may be made less frequently still.

The Rev. George P. Giddinge, D.D., has removed from Boonville to Palmyra, where he has in charge a Church School for girls. The Rev. William N. Irish has resigned the Rectorship of St. John's Church, Prairieville, and become the Rector of Trinity Church, St. Charles; the Rev. Charles F. Loop has resigned Grace Church, Chilicothe, and become the Missionary of Fayette, Columbia, and Huntsville; the Rev. Joseph I. Corbyn has resigned as Missionary to St. Luke's Church, Kansas City, and is now the Missionary in Trinity Church, Independence; the Rev. F. B. Sheets has resigned the Rectorship of St. Jude's Church, Sharpsburg, and accepted the position of Assistant Minister in the same Parish where his aged father, the Rev. George Sheets, has become the Rector; the Rev. Theodore J. Holcomb has resigned as the Assistant in Christ Church, St. Louis, and become the Missionary in Springfield, and the Rev. Dr. Massoch has resigned his Mission to the foreign population in St. Louis, and removed to Nebraska Territory.

My consent has been given to the organization of three new Parishes, viz: Calvary Church, St. Louis; Christ Church, Springfield; Grace Church, Liberty. Their applications will come be-

fore you for admission into union with the Diocese.

One clergyman has been ordained to the Priesthood. On Sunday, August 14th, in the Methodist house of worship, in Chilicothe, I ordained to the Priesthood the Rev. Charles F. Loop. There were with me upon that interesting occasion the Rev. Dr. McMasters, President of St. Paul's College; the Rev. Mr. Dunn, Rector of Trinity Church, Hannibal; the Rev. Mr. Irish, Rector of St. John's Church, Prairieville; the Rev. George Sheets, and the Rev. Carter Page, of the Diocese of Kentucky. They all united with me in the laying on of hands. The service was one of more than

ordinary interest, as this was the first ordination of a Church clergyman ever witnessed in that city.

The corner-stones of three new Churches have been laid. On Sunday, August 7th, 1859, in the presence of a large congregation, I laid the corner-stone of Grace Church, Kirkwood. There were present and taking part in the services the Rev. Dr. Coleman, Rector of St. John's Church, St. Louis; the Rev. Mr. Terry, Rector of St. Paul's Church, St. Louis; the Rev. Mr. Berkley, Rector of St. George's Church, St. Louis; the Rev. Mr. Clerc, Rector of Grace Church, St. Louis; the Rev. Mr. Holcomb, Assistant Minister of Christ Church, St. Louis, and the Rev. Mr. Merrick, of the Diocese of Kentucky. This Church is now completed, and, at the, request of the Wardens and Vestrymen, I shall proceed to consecrate it on next Sunday.

On the 14th of March, 1860, the corner-stone of Trinity Church St. Louis, was laid, on the corner of Washington avenue and Eleventh street. A large crowd witnessed the ceremony. Of my clerical brethren there were present with me at that time the Rev. Dr. Schuyler, Rector of Christ Church, St. Louis; the Rev. R. E. Terry, Rector of St. Paul's Church, St. Louis; the Rev. E. F. Berkley, Rector of St. George's Church, St. Louis; the Rev. F. J. Clerc, Rector of Grace Church, St. Louis; the Rev. John W. Clark, Rector of Calvary Church, St. Louis, and the Rev. E. Carter Hutchinson, D.D., Rector of the Parish. The location of the new Church is very fine, and the building, which is to be of stone, will, when completed, afford sittings for five or six hundred people, and be an ornament to that already beautiful part of the city.

On Sunday, April 22d, in the presence of an immense crowd of people, I laid the corner-stone of the new Christ Church, St. Louis, on the corner of Locust and Thirteenth streets. There were present with me and taking part in that service the Rev. R. E. Terry, Rector of St. Paul's Church, St. Louis; Rev. E. F. Berkley, Rector of St. George's Church, St. Louis; Rev. John Coleman, D.D., Rector of St. John's Church, St. Louis; Rev. F. J. Clerc, Rector of Grace Church, St. Louis; Rev. John W. Clark, Rector of Calvary Church, St. Louis, and the Rev. Montgomery Schuyler, D.D., the Rector of the Parish. This event awakened a deep interest in the community, and I hope the work may proceed promptly onward, and result in great spiritual good to all.

Naturally enough, strong associations clustered around the old

building that they have just left, and the flock was divided in feeling as to the construction of a new edifice. Still the new house was called for by the majority of that flock, and the expanding growth of a great city. The work was decided on by themselves-the work is begun, and I pray God that in harmony and peace it may proceed to its completion. Let every man do his part; let the congregation keep unbroken, and we shall all find comfort when its courts are opened, and the work of the Lord goes on more prosperously. Christ Church, as you are aware, is the mother Church not only of this Diocese, but of this whole region of country. It was the first parish organized west of the Mississippi river; and the new building, when completed, will be the third Church edifice erected for that congregation. parish was organized in 1819, and its first church edifice was completed on the corner of Third and Chestnut streets, in 1830, and consecrated in 1834, while yet Missouri had no Bishop, by the Rt. Rev. Benjamin B. Smith, D.D., Bishop of Kentucky. Its second Church edifice, which you will all remember on the corner of Chestnut and Fifth streets, was consecrated in 1839, while still Missouri had no Bishop, by the Rt. Rev. Jackson Kemper, D.D., the Missionary Bishop of the Northwest; and now we have laid the corner-stone for the third building. This work is the gradual result of a twofold progress: 1st, the great growth and progress of the city of St. Louis; 2d, the growth and progress of the Church. In 1819, St. Louis was a small village; now it is a city of 200,000 souls. In 1819, the Church had not six communicants regularly at her altar; now she has 1,000 in her seven Churches. While we are comforted as we mark our Church progress, we may well ask if we have kept up with the growth and demands of our expanding city.

While speaking of these new Church edifices, let me say something as to the cost of Church buildings. Grace Church, Kirkwood, is a good building, costing about \$10,000. Trinity Church, St. Louis, will cost, as I am informed, about \$25,000. Christ Church, St. Louis, will expend about \$175,000. Some persons complain that Churches are too costly. While I would not encourage extravagance, I would say that the temple of Jerusalem was costly, and that man should dedicate the best that he can give to the Lord of Hosts. There are differences of ability in congregations as there are among men. What is wrong in one is not

wrong in another. We do not blame the man of wealth who builds according to his ability. Why should we blame a congregation that keeps within the bounds of its means? The right law of duty is to do our duty as God has given us the power and privilege. Ten thousand dollars was a heavy expenditure for the little flock at Kirkwood, but by an effort they will meet it. Trinity Church is working according to its power, and it is doing well. and Christ Church has the ability to accomplish all she has undertaken. Let her go on in the good work, and let not her people be

backward in giving to this temple of the Lord.

But some will say, in a large and almost missionary country like ours, why not divide these sums so large, and build many Churches in city and country? In reply I would say, that if you had the absolute control of all the amounts, you might reason thus. But remember we have not this control, nor can we have it entirely. The people who build these churches would give the amounts for no other purpose, and we must reap for the good God as best we Then, too, in giving largely for such a purpose we may hope that the hearts of people will become enlarged, and that they will learn to give the more liberally to any good object. It is a remarkable truth, that the more people give to a good purpose the more they learn and love to give.

To the record of new buildings I may add that if the Convention had assembled a week later, I might have reported the cornerstone of another new Church edifice in our city. Calvary Church has made a beginning, on the corner of Morgan and Twenty-first streets, and the corner-stone will be laid on the 3d of the next month.

Four Churches have been consecrated. On the 19th of June, 1859, I consecrated to the worship and service of Almighty God, St. Paul's Church, St. Louis, the beautiful building in which we are now assembled. There were with me taking part in the services the Rev. Mr. Clerc, Rector of Grace Church, St. Louis; Rev. Mr. Weller, Rector of Grace Church, Jefferson city; Rev. Mr. Dunn, Rector of Trinity Church, Hannibal, and the Rev. Mr. Terry, the Rector of the Parish. The completion of this house, which reflects such credit upon the taste and energy of the earnest and indomitable Rector and his coadjutors, will, I trust, open a new era of wider usefulness for this interesting congregation.

Christ Church, St. Joseph, was consecrated by me on Sunday, August 21st, 1859, there being present with me and assisting at the time the Rev. Dr. McMasters, President of St. Paul's College; the Rev. C. F. Loop, Rector of Grace Church, Chilicothe; the Rev. Mr. Bruce, of Alton, Ill., and the Rev. W. R. Pickman, the Rector of the Parish. This edifice, erected according to the ability of the congregation, is already too small for the flock attending the ministry of its earnest Pastor. In a little time in the growing city of St. Joseph, we must have a larger edifice or an additional house

for another congregation.

On the 24th of August, 1859, accompanied by the Rev. Dr. McMasters, President of St. Paul's College; the Rev. Mr. Pickman, Rector of Christ Church, St. Joseph; the Rev. Messrs. Stone and Henderson, of Kansas Territory, and the Rev. Mr. Holeman, the Rector, I proceeded to consecrate St. John's Church, Weston. This is one of the most beautiful village Churches I have ever seen, and is a model for any of our smaller towns designing to erect a house of worship. It affords 400 sittings. Too much credit cannot be bestowed upon the self-denying Pastor, who, at great sacrifice to himself, has accomplished, without much aid in the town of Weston, the good work of building this house. My only regret is, that he has burdened himself with too much responsibility in his zeal for the Church, and I trust that his brethren, both at home and abroad, will help him to bear his burden, by affording him substantial evidences of their sympathy. Weston is one of those towns from which there has been a large immigration for a few years past, and with this immigration has floated away a great part of our Church population, and to this fact is owing, in a great degree, the embarrassment of the Rector.

On the 15th of April, 1860, I consecrated to the same holy purpose Grace Church, St. Louis. The Rev. Dr. Schuyler, Rector of Christ Church, St. Louis; the Rev. Dr. Coleman, Rector of St. John's Church, St. Louis; the Rev. Mr. Terry, Rector of St. Paul's Church, St. Louis; the Rev. Mr. Berkley, Rector of St. George's Cuurch, St. Louis; the Rev. Mr. Clark, Rector of Calvary Church, St. Louis, and the Rev. Mr. Clerc, the Rector of the Parish, were with me assisting in the services. At my request the consecration sermon was preached by the Rev. Dr. Coleman. This Parish is now in a very flourishing condition. Its history is peculiar. Soon after I became your Bishop, and my home was made in St. Louis, I found an opportunity for establishing this parish. Three wealthy gentlemen—Messrs. Chambers, Wright and Christy—had made an addition to

the northern part of the city of St. Louis, and had platted their ground, and filed the plat, prior to selling their lots in the new addition. In their plat they had made three open squares, one for a school, one for a public square, and one for a Protestant Church edifice, whenever the inhabitants of North St. Louis should call for it. The property was considered so far from the centre of business, that none had thought of availing themselves of the Church site. Acting by the advice of my friend, that learned member of the bar, Mr. Josiah Spalding, then Senior Warden of Christ Church, of which I was Rector, and with the hearty cooperation of the Rev. P. R. Minard, then Rector of St. Paul's Church, St. Louis, and Mr. Calvin Case, a zealous layman in North St. Louis, all of whom are now deceased, I caused a subscription to be raised in North St. Louis, to which two-thirds of the inhabitants subscribed to build an Episcopal Church upon that ground. Having obtained this, I filed the record, and enclosed the ground. Grace Church was then organized, and soon a small Church building was erected. Messrs. Cressy, Weller and Woodward were the successive Pastors in this weak enterprise. At length, the Rev. Mr. Clerc became the Rector, and under him the old edifice was beautifully enlarged, and thus enlarged, it was my comfort to consecrate it. The property, in the day when it was given, was considered of little value, but with the growth of our city has become very valuable. It is not far, too, from our Orphan's Home, and, from its position alone, has become almost the Chapel and the guardian, as to spiritual things, of that Institution. The parish is one of great promise, and, with its present excellent Pastor, will, I think, produce very happy results.

To this record of consecrated houses, I may add, that in a few

days I expect to consecrate Trinity Church, Hannibal.

The Board of Missions, I am happy to say, has again, at my request, appropriated \$2,000, for the year 1860, to the Diocese of Missouri. This sum is divided for the benefit of the following places, viz:

There are Missionaries now employed at all these points. Need I say again, that I hope the liberality of the Board to Missouri will be remembered, and that in every Parish in this Diocese a contribution will be gladly given to its funds? Let us not receive benefits without remembering them-let not ingratitude be one of our sins. I can readily understand the difficulties of the Board, under their large and burdensome trust. The work is to cover an immense continent. Already Missionary Bishops are in the Northwest and South-west, reaching in their immense yet feeble jurisdiction towards the shores of the Pacific, while still the new States of the Confederacy are calling for aid. Weighing their trust, and desirous of meeting it, the Board of Domestic Missions, at its meeting during the session of our last General Convention, resolved to raise this year for our domestic field, at least the sum of \$100,000. I can not believe they will be disappointed; and I shall be greatly mortified if Missouri does not do her part well to forward this dutiful resolution. The Church will hardly be so cruel, especially to the two new Bishops of the North and South-west, as to forget them. She will not send them into a barren wilderness, only to break their hearts, in their desolate and lonely wanderings. Much as my wants in Missouri may be, I feel for these Missionary Bishops more than for myself. I honor them both, for their noble and self-sacrificing devotion to the Church of God, in accepting their positions, and I hope the great heart of the Church will beat warmly and steadily in their behalf. Let us pray for them, and help them.

Our own Diocesan Missionary Society, also, should be more loyally sustained. The Board of Missions has in this Diocese eight Missionaries, while our own Society has but two, and these I am sorry to say are not liberally provided for. I do not think there is any defect in the constitution of the Society, but the fault is with ourselves, that its object and purpose, are not better made known among us. If the Clergy will act promptly in its behalf, I am confident the Laity will readily co-operate. In addition to keeping alive the work already in hand, our work should be largely increased. In many directions the field is inviting, but especially, now, we should have Missionaries in Platte City, Plattsburg, Savannah, Fillmore, Liberty, Fulton, Warsaw, Canton, Lagrange, Mexico, Hudson, Parkville, and in Johnson county. We have long since warmly approved, by resolution, the subject of itiner-

ating missions in Missouri. I would be glad if we would practically carry out that resolution. In no other way can the wants of many parts of Missouri be reached, and such good results would follow upon the labors of our itinerants that we should be greatly comforted. On our lines of railroad too, just now, one or two itinerants might be very profitably employed. The judicious distribution of Bibles, Prayer Books and Tracts, if nothing more was done, would do very great good.

The wants of our Society have been so pressing, that in December last, acting with the advice of the Standing Committee, I issued to the Diocese a Pastoral in its behalf, and appointed an agent to visit all our Parishes, and make known its wants. The agent has partly accomplished this work, and his report will be laid before you. He was much encouraged in his efforts, especially in the interior of the State, and feels satisfied, that it is only necessary to make the Society known, to secure for it an income that will enable us to quadruple its work immediately. I can not press the claims of this Society more earnestly than I have already in the words of my late circular.*

To the Clergy and Laity of the Diocese of Missouri.

DEARLY BELOVED: Our Missionary work in this Diocese languishes. Our Diocesan Missionary Treasury is empty. How is this? Have we forgotten the work of Christ? Have we forgotten the words of the Lord Jesus, how He said, "It is more blessed to give than to receive."

Missouri covers an area of 62,000 square miles. In view of the extent of the field, and the emptiness of the Treasury, the Missionary Committee of the Diocese have appointed an Agent to solicit funds of you all; and I gladly send this letter among you, to tell you how you can aid him. (See Resolutions of the Standing Committee.)

Every individual contributing the small sum of \$3 per annum is a member of our Diocesan Missionary Society; and the money thus raised is subject to the disposal of the Bishop, for Missions in Missouri, with the advice and consent of the Standing Committee of the Diocese. Every individual contributing is at liberty, also, to say to what peculiar object his amount shall be given. Then let me ask you to receive the agent gladly, and let every member of the Church at once become a member of this Society. In this way we shall readily raise the sum of \$4,000 as an income for the Society.

I would say a word in behalf of this Society, and at the same time in behalf of all Missionary work. When we plead in behalf of city Missions, or Missions in our rural districts, we hear men say that the Churches in the city are not all tull, and the people in the country are not asking for the Church; why give

But to aid this and all good purposes, we must act systematically. Impulsive efforts and appeals do not bring in a steady sup-

until it is needed? In answer, let me say, that the work of Missions is unlike any other work. In worldly policy or trade, we wait until the demand is cre. ated, and then send in the supply. In spiritual things the law is different. We there send the supply, and create the demand. This we learn from the blessed Gospel. This was the way of our blessed Saviour. He waited not till He was called for by a sinful world. Alas! if he had thus waited, He had never come. He came to "seek and to save that which was lost," and the multitudes came to him. Under the same law, we send the heralds of the cross, to preach the glad tidings of Salvation, and to gather in the wanderers wherever they may be found. This is the law of Christian Missions—this is the work of the disciples of the Lord Jesus. In this work, the supply must ever precede the demand.

But in Missouri they are calling for the Church, in her holy and conservative teaching. My last tour through the Diocese was most cheering; and never since I became your Bishop, have I seen such fair openings in our vineyard for

God's work, if we will but enter in and do our duty.

Let then our Diocesan Missionary Society have your full, hearty, loyal, and prayerful support, that so the "comfortable Gospel of Christ may be truly preached, truly received, and truly followed among us."

RESOLUTIONS OF THE STANDING COMMITTEE.

WHEREAS, the 19th Annual Convention of the Diocese of Missouri "Resolved that, hereafter, instead of the annual sermon on Missions during the first evening of the Convention, there shall be held at that time a meeting of the Society

for propagating the Gospel in Missouri;" and

Whereas, the form of subscription, which is the Constitution of this Society, fixes the sum of three dollars per annum as the condition of membership, and provides for the disposal of the Society's funds for the spread of the Gospel in Missouri, by the Bishop of the Diocese, with the advice of the Standing Committee thereof, unless the objects be specified by the donors; and

Whereas, there has long been and still exists a great neglect of this Society, while the need of money and of effort in its behalf, for the support of Missionaries already engaged in preaching the Gospel and for the employing of new

missionaries is constantly increasing,

Therefore, be it Resolved, by the Standing Committee of the Diocese, that, if the Bishop approve, the Rev. R. H. Weller be and he is hereby requested to act as Agent in behalf of the Diocesan Missionary Society, and prior to the next Diocesan Convention, with the consent of the several Rectors, to solicit subply to any cause. Let us have again, as in times past, certain fixed days for contributions in every Parish, toward certain good purposes. It may be necessary for an agent, just at this time, to make a special effort to place our Society on proper footing; but after that, let us feed it with a regular supply.

The annual reports from our Orphan's Home on Easter Tuesday last, from St. Paul's College and the Clergy in their respective Parishes, are laid by me upon the Secretary's table for your information. You will perceive by these, that the condition of the Diocese is more healthy and prosperous than usual.

Of our Orphan's Home, I need only say that its blessed work goes on gently and quietly, under the tender care of the Lady Managers, and that the hearts of our people give constant evidence, that they are never weary, in sustaining this most touching of all charities. The Institution has this year added to its grounds, and made other improvements for the comfort of its inmates. Its receipts for the year closing on Easter Tuesday last, were \$4,413 $\frac{9.5}{10.0}$; its expenditures \$4,354 $\frac{6.3}{10.0}$.

Of St. Paul's College, I am glad to say that its condition is prosperous, indeed more so than we have a fair right to expect under its present circumstances. Without an endowment, no college can exist long, as I have said before; and until we have some endowment, the institution can barely live. President and Professors may do their duty as best they can, but they can not, alone, make a successful work. I shall be glad, if some practical steps may be taken towards raising an endowment for St. Paul's. If this however can not now be done promptly, then I would respectfully suggest the wisdom of closing the College for the present, while we keep open only the grammar department under a good master. During such period, let a vigorous effort be made for endowment at home and abroad, and when we can properly do so, let us open our College again. I speak thus because I do not think it right that we should, from year to year, be embarrassing ourselves by an outlay greater than our receipts. This year

scriptions to the funds of this Society in all the Parishes of the Diocese, or as many as possible.

Resolved, That a copy of these resolutions be sent to the Bishop, with the request that he will forward them with his approval to the Rev. Mr. Weller; and also, if he see fit, issue a Pastoral letter to the Diocese in behalf of the Society for Propagating the Gospel in Missouri.

our pecuniary condition is better than usual, but still we shall close the term, as you will see, in debt. The grammar department under a good master would, I think, more than sustain itself.

It is my duty to lay before you the following record of acts of discipline, notices of which have reached me during the past year:

The Rev. T. W. Clappe (Deacon) has been deposed by the Bishop of Ohio; the Rev. J. T. Eaton, by the Bishop of Ohio; the Rev. Abel Nicols, by the Bishop of Louisiana; the Rev. Louis Jansen, by the Bishop of Kentucky; the Rev. A. D. Spalter (Deacon), by the Bishop of Massachusetts; the Rev. T. D. Sleeper, and the Rev. Samuel L. Southard, by the Bishop of Western New York.

We are indebted again to the New York Bible and Prayer Book, and Tract Societies, for donations of their publications for gratuitous distribution—and let their liberality be suitably remembered in all our congregations.

Beloved, this closes properly my official record. I have no new work to present to you, but only to press you, to guard that which is already begun. In looking over the position of the work, I sum up as follows:

During the year there has been 1 ordination; 173 confirmed; 3 corner-stones laid; 4 Churches consecrated; 33 towns visited; 3 Parishes organized, and 3 Clergy received. There are now in the Diocese 2 authorized Lay Readers, 26 Clergymen actively engaged; 32 Parishes, and about 1600 communicants. We have at this time 3 important Parishes vacant, viz: St. Luke's Church, Kansas City; Christ Church, Boonville, and St. John's Church, Prairieville. The first named, however, has secured for its Pastor the Rev. Mr. Calloway of Kansas Territory, and he will enter upon his duties in September next; the others are making efforts to obtain Ministers. The fields are all promising. In Kansas City, the flock is engaged now in erecting their new Church edifice, upon the beautiful lot presented to them by Mr. William Gilliss of that city. This gift reminds me, also, that a beautiful site for the Church has been presented to us in the town of Utica, by Mr. Roderick Matson of that place. I record these gifts the more cheerfully, because in most of our towns where the Church is located we have had to purchase our building lots at almost unreasonable prices. Mr. Gilliss' gift, in that rapidly growing town of Kansas City, is very valuable.

All that I need urge is diligence and fidelity in prosecuting the work now in hand.

1st. Let our Diocesan Missionary Society be strengthened by our prayers and offerings, and let the waste places of the Diocese be supplied with the Gospel.

2nd. Let me say in affection to the Laity, what perhaps it becomes me to say more than another: Let your parish obligations be religiously met, and especially your obligation to your Clergymen. The most frequent cause of separation between pastors and people, in the Diocese, since I became your Bishop, has been the neglect of the Parishes to meet promptly their payments to their Pastors. Some instances have occurred, where delinquencies have been allowed to accumulate for years, and this not from unkindness, but from downright thoughtlessness and negligence. Thus the Clergyman as an honest man, with others dependent upon him, has felt compelled to seek a new home. We should all consider pecuniary obligations made by Parishes even more sacred, if possible, than ordinary business engagements.

3d. I have said, it is a comfort to come together at this time and commune together, to mingle our joys and sorrows. But we should all remember too, my beloved, that our meeting has another meaning. At this annual gathering, we are here to legislate for the good of the Church, in that portion of the vineyard committed to our trust—as God shall give us ability. Our purposes, when they assume the form of resolutions, become enactments to bind us. We are, as honest men, to be loyal to our own action. It has been a very great injury to the Church, not in Missouri only but elsewhere, that our legislation is not more sacredly regarded by the legislators. In our General and Diocesan Conventions we pass resolutions at times, which immediately after an adjournment become a dead letter. The Church is thus weakened, before the world, in her great moral power. She will be regarded as a body with no fixed, stable, uniform purpose; a body speaking what it does not mean; a body calling others to obedience, and yet not obeying its own voice and behests. It is far better to pass no resolutions, than to pass them only to forget them. Anarchy and confusion are the worst of all conditions in civil or ecclesiastical matters, and even bad laws are better than no laws whatever.

As a matter of deep interest to us all, I would say a few words to you touching the late triennial Council of the Church, that met in the city of Richmond, in October last. The meeting of that General Convention was most harmonious, and I trust that its good results will manifest themselves more and more. The hospitality of Virginia is proverbial, but the crowds of her people thronging the courts of the Lord's house, upon every occasion of public service, surprised and gratified me. At home, and from a distance of hundreds of miles in that old commonwealth, they were there, as though they felt refreshed by the presence of that great Council.

When I last parted with you, you will remember how we sighed that two of our Bishops had departed this life. Let me comfort you now, by telling you that in this Council six new Bishops had laid upon them the mitre and the cross. The Rev. Alexander Gregg, D.D., Bishop elect of the Diocese of Texas; the Rev. William H. Odenheimer, D.D., Bishop elect of the Diocese of New Jersey; the Rev. Gregory Thurston Bedell, D.D., Assistant Bishop elect of the Diocese of Ohio, and the Rev. Benjamin Whipple, D.D., Bishop elect of Minnesota, were then and there approved by the Council, and consecrated to their sacred duties. To the vast Southwestern jurisdiction, lying vacant since the death of the lamented Freeman, the Rev. Henry C. Lay, D.D., was elected and duly consecrated. To the immense region of the North-west, made vacant by the resignation of the Rt. Rev. Jackson Kemper, D.D., the Rev. Joseph C. Talbot, D.D., was called, and having since accepted, was duly consecrated in the city of Indianapolis on the 16th of February last. It was my comfort to rejoice in the elevation of all these godly and well-tried brethren, and my special privilege to act as one of the consecrators, in Richmond, of the Rev. Dr. Odenheimer, and in Indianapolis as one of those consecrating the Rev. Dr. Talbot. In this last consecration, the Rt. Rev. Dr. Kemper was the presiding Bishop. This was meet and right. For twenty-five years, with unbroken health and cheerfulness, he had carried his pastoral staff through the North-west—and Indiana, Wisconsin, Missouri, Iowa, Minnesota, and Kansas, all working now as Dioceses with their respective Bishops, save one, and that one calling now for its Bishop, were once parts of the wilderness over which he traveled. He has counted it all joy to do this large and self-sacrificing work, and now, having resigned his missionary jurisdiction, was here to consecrate his successor, and bid him Godspeed in this still expanding field. We all remember this truly

apostolic man. All that we could wish him of worldly return for his apostolic labors would be only this, that he may be as warmly cherished in all hearts, as he is cherished by some in Missouri. It comforts us to know that this good man, full of health and heart, is still active in his apostolic labors, as the Bishop of Wisconsin.

Think of that Council sending out six new Bishops, and pray with them and for them, that God's Holy Spirit may abide with them forever.

Another remarkable feature in that harmonious Convention was this: The Laity seemed moved by the great head of the Church to rise to a sense of their responsibility and duty—they resolved that they would indeed be to the Clergy their "helpers in Christ Jesus." That great Lay Committee, then created, coming with its representation from the heart of every Diocese, will, I trust, devise noble things, so that from the Atlantic to the Pacific, from the Northern lakes to the distant everglades of the South, in every portion of our common country, we may feel and know that God is with us of a truth; that the Church of the living God—which is the "pillar and ground of the truth"—not let or hindered by any of her divided children, true to her great trust, is pressing on with the Gospel of truth, to the "breaking down among us the strongholds of sin, Satan and death." May God's blessing be with them to guide and control them!

I will not close this address without the expression of my thanks to the Rt. Rev. John Payne, D.D., our Missionary Bishop to Africa, for a short visit to the Churches in St. Louis during the past winter. I met this good Bishop for the first time in October last. in the city of Richmond. I felt that Missouri should, from her very position, feel a deep interest in this African Mission, and invited the Bishop to visit our city. His visit was hurried, but I trust profitable. Indeed no one could have heard his earnest addresses in Christ Church, St. George's Church, and St. John's Church, St. Louis, without feeling his heart moved, by the simplicity and force of his statements. This mission is very near akin to us, my beloved, and I am comforted in knowing that Missouri has offered one Missionary to this distant field; Miss Hermine C. Relf has been willing, for Christ's sake, to leave the home of her friends, and become one of the teachers in that far off Mission. I trust both the Mission and Missionary will be remembered in Missouri.

I have nothing more to say than to request that this address, when printed, may be read to their respective congregations by my brethren of the Clergy, and to pray that God's Holy Spirit may now guide and control your deliberations.

REPORT:

The Committee to which was referred so much of the Bishop's Address as relates to St. Paul's College beg leave to report, that the College is now in possession of real estate and permanent improvements worth at a fair estimate \$30,000. It consists of thirty acres of land, beautifully situated within the limits of the city of Palmyra, the point of junction of the Quincy and Palmyra Railroad with the Hannibal and St. Joseph Railroad. It is exempted from all taxation for State, county and city purposes. A more healthy and beautiful situation cannot be found in the Mississippi valley. The buildings consist of a comfortable President's house, of brick, which cost over \$5,000; Matron's rooms and Infirmary; elegant brick dining room and kitchen; with servants' houses, and College building and Chapel. The College building is of brick, with ample school room and recitation rooms, and sleeping apartments for forty students. The College Library, intended for the future Theological department of the College, consists of near 3,000 choice volumes of great value. The Scientific department has apparatus, presented at different times, worth not less than \$1500.

The present indebtedness of the College, all told, is from four to five thousand dollars;—would be much less could old bills be collected, many of which are contingent. The present year is likely to come very near paying current expenses. The number of students, this year, has been eighty-one—more than have ever been in the Institution at any time previously.

The course of instruction is as thorough as that of any other Institution in the land, being in nothing a whit short of all that is set forth in the Catalogue.

Your Committee would not omit expressing its hearty approval of the indefatigable exertions of the Rt. Rev. Chancellor, the Bishop of this Diocese, and others who have co-operated in the work from its inception; and feel assured that if a proper liberality can be brought to the support of the enterprise, it must, at no distant day, yield a rich harvest to the Church, and stand forth a noble monument to the enterprise and piety of the Diocese.

Your Committee would not attempt, now, to decide how soon it will be judicious to attempt the work of endowment; but believe that at no very distant day it may be commenced with a good prospect of the most triumphant success.

The following resolutions are proposed for the action of this Convention:

Resolved, That the Convention concurs with the Bishop in the opinion that no college can be long sustained without permanent endowment; and,

hence, acknowledges the obligation of the Church, at the earliest practicable moment, to endow the Institution to such an extent as shall make it independent of board and tuition for ordinary expenses.

Resolved, That the Convention cordially acknowledges the College as part of its legitimate work, and pledges its influence and available means,

to the utmost extent, for its support.

Resolved, That in view of the present condition of the College (without endowment,) it be recommended that an earnest and vigorous effort be made to secure individual pledges, to the amount of at least two thousand dollars per annum, to meet such deficits as may arise in its annual income.

Report of the Agent of the Society for the Propagation of the Gospel in Missouri to the Twentieth Convention of the Diocese, assembled in St. Paul's Church, St. Louis.

On the 1st of February last I received, from the Bishop and Standing Committee, the appointment of Agent for the Society for the Propagation of the Gospel, with instructions to visit as many parishes as I should be able before the meeting of the Convention, for the purpose of obtaining annual subscribers, in each, to the funds of the Society. To aid me in the work the Bishop addressed a Pastoral letter to the Clergy and laity.

As the season of Lent covered the larger portion of the time between my appointment and the assembling of the Convention, I have been able to visit only nine parishes, and those the feeblest in the Diocese, with the following results:

I feel it incumbent upon me to state, in justice to the parishes I visited, that this report does not, by any means, exhibit a fair estimate of what may be accomplished in them for the support of Missions in the Diocese. The time at which I visited them was very unpropitious for a work of this kind, and I am fully satisfied, from the feeling manifested on the subject, that within two years, with very little attention, a number of annual contributors, equivalent to the actual list of communicants in each parish, can be secured. If the stronger parishes will but take hold of the work with the same interest as was exhibited by these feebler ones, we can very readily raise a fund of \$4.500, annually, for Diocesan Missions; this being an average of one subscription to each communicant, and leaving, as a margin, the two annual collections, ordered by the Convention to be made in each parish, to make up any deficiency. I think this will be evident to all, when I state that, of parishes visited by me, two were without Rectors, one had no Church edifice, and four were struggling to build, or were yet encumbered with debt for buildings just completed: and yet the fund raised in these nine parishes, only two of which are self-supporting, is sufficient to meet the present pledges of the Society. I think, therefore, that I am warranted by facts in stating that it only requires united action, on the part of the Rectors and their congregations, to increase it so largely, that we shall be able to place a Missionary at every point in the Diocese where there is an opening for the Church. There is scarcely a member of the Church who cannot contribute the small sum of 25 cents per month, or \$3 per annum, to the work of Diocesan Missions; and yet, small as is this sum, its aggregate from all the communicants will give us twenty-two Missionaries at the salaries now paid by the Society, and the balance necessary for a support can be readily raised at the different points to which the Missionaries are

There yet remains to be called upon twenty-one parishes, and among these the strongest and wealthiest in the Diocese, in case an Agent shall be appointed at this Convention.

Sunday Evening, May 27.—The Society for Propagating the Gospel in Missouri held a meeting in St. George's Church, in accordance with a resolution of the Convention. The Bishop, the Clergy, and a large congregation were present. Evening Prayer was said to the Creed by the Rev. Mr. Weller—the Rev. Dr. Schuyler reading the Lessons, and concluded by the Rev. Mr. Holcomb. Appropriate addresses were made by the Bishop, the Rev. Dr. Giddinge, and the Rev. Dr. McMasters; and after a few words of hearty commendation of the work of the Society by the Rev. Mr. Berkley, the Bishop said the concluding Prayers and dismissed the congregation.

St. Paul's Church, St. Louis, Monday, May 28, 10 o'clock, A. M.

The Convention met according to adjournment.

Morning Prayer was said by the Kev. Geo. K. Dunlop, Rector of Christ Church, Lexington, assisted in the Lessons by the Rev. George Sheets, Rector of St. Jude's Church, Sharpsburg.

The Bishop took the Chair, and called the Convention to order.

On calling the roll, a quorum of both orders was found present.

The minutes of the previous sessions were read and approved.

The President announced the order of business to be the election of Deputies to the General Convention.

Whereas this Convention has acknowledged, by resolution, that St. Paul's College, Palmyra, is a part of its legitimate work, and has pledged its influence and available means, to the utmost extent, for its support; therefore,

Resolved, That a Committee be appointed to visit said College at its ensuing examination, and to make a report to the next Convention.

The President appointed as the Committee under this resolution, the Rev. F. J. Clerc, the Rev. M. Schuyler, D.D., the Rev. George K. Dunlop, Messrs. M. Lewis Clark, Josiah Hunt, and the Hon. Gilchrist Porter.

The Committee on the nomination of Deputies to the General Convention made a verbal report, recommending to this Convention the names of the Rev. Ed. F. Berkley, the Rev. S. Y. McMasters, D.D., LL.D., the Rev. R. E. Terry, the Rev. John T. Worthington, D.D., Messrs. Richard J. Lockwood, and Harry I. Bodley.

The Chairman of the Committee, the Rev. Mr. Berkley, dissented from the Report only so far as it commended his own name.

The balloting resulted in the election of the following gentlemen, in this order:

The Committee on the Constitution and Canons made the following

REPORT:

The Committee on the Constitution and Canons respectfully report the following proposed Canon for adoption,

(Proposed) CANON XVIII.

Any parish failing to present itself to the Bishop in Convention, by representation or report, without reasonable excuse for delinquency, may thereupon, by vote of the Convention, be stricken from our list of parishes, and its Clergyman declared ineligible to any office in the gift of this Convention.

Also the following Resolution: That the present Canon XVIII. be numbered Canon XIX.

The Committee remind the Convention that by the action of the last General Convention, certain changes were made in the canon "of Congregations and Parishes" by which "the ascertainment and defining of the boundaries of existing parishes or parochial cures, as well as the establish-

ment of a new Church or Congregation, and forming a new parish within the limits of any other parish, is left to the action of the several Diocesan Conventions, for the Dioceses respectively"; and that "until a canon or other regulation of a Diocesan Convention shall have been adopted, the formation of new parishes or establishment of new Churches or Congreations within the limits of other parishes, shall be vested in the Bishop of the Diocese, acting by and with the advice and consent of the Standing Committee thereof; and in case there be no Bishop, in the Ecclesiastical authority."

The following substitute was offered in place of the above proposed Canon, and, on motion, referred to the Committee on the Constitution and Canons:

The Committee on a Permanent Basis of Assessment made the following

The Committee on a Permanent Basis of Assessment recommend the adoption of the following resolution:

Resolved, That the assessment for the support of the Episcopate shall be an amount on each parish equal to one dollar and a half for each communicant, as per last report; and any further amount required shall be assessed upon each parish in proportion to its pecuniary ability, as indicated by the amount raised the past year for the support of its Rector.

The Standing Committee made the following

REPORT:

The Standing Committee of the Diocese respectfully report the following abstract of official acts performed during the Conventional year, viz:

The Committee met in St. Louis on the 31st day of May, 1859, and organized by the election of the Rev. F. J. Clerc, President, and the Rev. J. W. Dunn, Secretary.

On the 12th of September, 1859, the Committee elected Delegates to the General Convention in the place of others resigned, and adopted the report required by Canon XII. of 1853. They also voted the payment of dues to one Missionary, and to the Treasurer of the General Convention.

On the 15th of December, the Committee adopted resolutions on the Diocesan Missionary Society, and on the Diocesan Assessments.

On the 2d of February, 1860, action was taken upon testimonials in behalf of Mr. Walter W. Weir, allowing him to withdraw them.

The Committee on the State of the Church made the following

The Committee would begin their report by congratulating the Convention upon the vigorous progress exhibited in the work of the Church, in the Diocese, at the present time. While, from the financial condition of the country, there are many serious hindrances to our work, yet never before has the field before us opened up so cheering a prospect for extension and strength. Those points where the Church is already planted have been greatly strengthened in the past year, and numerous places where heretofore the Church was unknown, are now inviting us to take possession.

The Bishop's Address contains the following list of official acts since the last Convention: Ordination, one; Confirmations, one hundred and seventy-three; Corner-stones laid, three; Churches consecrated, four; Parishes organized, three; Clergymen received into the Diocese, three.

There are several objects to which the Committee desire to call the attention of the Convention:

1. St. Paul's College, at Palmyra.—It now numbers more students than at any previous time, and only needs the sympathy and active support of the Church to become an Institution of favor among the people, and an important auxiliary to the Church's work. With the best theological library west of the mountains, we cannot cease to be reminded of the prime object of the Institution, which is, at the earliest practicable moment, the opening of the Theological Department, for training young men for the ministry. The importance of this work cannot be too strongly urged upon the consideration of Churchmen throughout the Diocese.

2. The Orphan's Home goes on gently and quietly, by the blessing of God upon the tender care of its lady managers. In the words of the Bishop's Address, "the hearts of our people give evidence that they are

never weary in sustaining this most touching of all charities."

3. The Church having no Diocesan School for girls, the Committee would recommend to the members of the Church throughout the Diocese, the Female Seminary at Palmyra, now under the management of the Rev. Dr. Giddinge, as an Institution in which their daughters may receive proper care and nurture as the children of the Church, while, at the same time, they are acquiring a thorough moral and intellectual training. Great good might be accomplished by supplying their school with the larger library of the "Church Book Society" for the use of its pupils. It would cost about \$75. Will some liberally disposed Churchmen supply it?

4. The Society for the Propagation of the Gospel.—The Treasurer's report shows an increase in the receipts for the past year, over the preceding one, of \$813 54. The wants of this Society are very pressing, and its work is one which must recommend itself to every one of us. The Society is now making an effort to obtain, from each member of the Church, a subscription of \$3 per annum to its funds, this amount constituting a membership in the Society. This falls lightly upon us all. No one among us could feel the giving of so small a sum, and yet its aggregate from our 1,500 communicants alone, will make the handsome amount of \$4,500, for Missions, per annum, supplying us at once with twenty missionaries, at a salary of \$225 each, and the points now opening in the Diocese would supply for all these fields of labor, and the balance of a livelihood. Our Diocese contains nearly one million of inhabitants; to represent the Church to this vast multitude we have but thirty-two clergymen, making an average of one to every 35,000 souls! Shall this continue any longer? Or rather, shall not the members of the Church, one and all, awaking to a sense of the vows which are upon them, for the extension of Christ's Kingdom-remembering the daily petition, in the Master's own words, for the coming of that kingdom-arise as one man to the work, and at once occupy the field which is opening before us? May the blessed spirit of our God arouse the hearts to an interest in this great work, that His blessing may rest upon us, and the Church's cords be strengthened! What we need to accomplish all our undertakings is a systematic plan of operation steadily pursued. Let us not work spasmodically, but methodically and orderly. In conclusion, the Committee offer for the action of the Convention the following resolutions:

Resolved, That this Convention recommends to the members of the Church in Missouri, the Female School at Palmyra, under the management of the Rev. Dr. Giddinge, as one in which their daughters may receive all the advantages of a thorough Christian and literary culture.

Resolved, That this Convention urgently requests of all the friends of the Church in Missouri, their hearty and zealous co-operation in the missionary work of the Diocese, through the "Society for the Propagation of the Gospel." Respectfully submitted,

The Committee to whom was referred that portion of the Bishop's Address of last year in relation to a Church and Parsonage Building Society respectfully report, that owing to the late hour of their appointment they have not had time to give the subject that deliberation which its importance demands, and ask that they may be allowed until the meeting of the next Convention to make their report.

REPORT:

Your Committee find that by assessing against each Parish a sum equal to \$1 50 for each communicant, the amount assessed is \$1,942 50; and that by assessing 7 per cent. upon the amount raised by each Parish for the support of its Rector, the sum assessed is \$1,653 75, making in all for the expenses the sum of \$3,596 25 assessed upon the basis of assessment adopted by the Convention this morning.

The amounts assessed against each Parish will appear by the list marked "A."

The Committee further ascertained a deficiency of \$1,100,* and report that the fairest way to raise the same is to assess it against each Parish in proportion to the amount raised for the support of its Rector, and for this purpose have assessed five per cent. upon such sum against each Parish.

On the 15th of April last, the first Sunday after Easter, the Bishop consecrated Grace Church, then greatly enlarged by the efforts of the Vestry, at a cost of \$1,700, of which there yet remain due about \$985. Since the last Convention this Parish has been left to its unaided resources, excepting a last instalment received from Christ Church, St. Louis, of \$35, and the generous kindness of personal friends. The present number of pews in the Church will enable us to provide for ourselves.

The Orphan's Home has been under my care as Chaplain, and the children have constantly attended Church and Sunday School. The annual reports of the Board are herewith submitted.

I have not paid the Missionary visits required by the action of the last Convention, owing to pecaliar circumstances, but will be able, I think, to do so this year. In lieu of them, I officiated a number of times in St. Charles, while the Parish there was without a pastor.

The property of Grace Church is free from encumbrance. Twelve hundred dollars and the use of the parsonage is my stipulated salary. The arrearages on the same will amount on the 1st of June to over \$900, errors excepted.

Lay reading has been kept up every Sunday but one since the last Convention, except on such Sundays as we have had a Minister with us.

We are indebted to the following Clergymen for services at Kirkwood during the year, viz: May 29, 1859, Rev. Dr. Worthington officiated; June 10, 1859, Rev. Mr. Berkley officiated and administered the Communion; June 30, Rev. Dr. Coleman officiated and administered the Communion; July 31, 1859, Rev. I entered upon the charge of this Free Church enterprise on the latter part of June, 1859, at which time there was no actual congregation beyond the five or six zealous Laymen, whose hearts the Lord had moved to this work. The effort assumed the shape of a regularly organized Parish about the middle of July, and in spite of the hindrances to growth, inseparable from the use of a public hall, the congregation has been steadily advancing in numbers, and the interest in our Free Church work enlarging. A lot of ground, 94 feet front by 144 deep, situated on Morgan street, west of Twenty-First street, has been secured, on which the foundations of a Church, with about one thousand sittings, are now nearly laid. A portion of the amount needed for the erection of the Church has been raised, but the absence of the Treasurer prevents me from giving it in figures, and for the same reason I am unable to state the sum that has been raised for the expenses of the Parish. I can only say, that they have been thus far fully met, and that the enterprise has been nobly sustained by those with whom it originated. Our confidence is the firm belief, that God will support and strengthen us in our endeavor to do His work in His way.

MANAGERS' REPORT.

The Lady Managers of the Orphan's Home hereby respectfully present to the Rt. Rev. the Bishop, and to the patrons and members of the Association, and to its friends generally, this their Seventeenth Annual Report of the condition and affairs of the Institution.

With gratitude to Him whose providence protects and whose grace inspires and sustains all christian efforts to do Him service, we acknowledge the opportunities of usefulness afforded us during the past year, and hope to show that we have endeavored to improve them faithfully, and to do the part of Church almoners towards the little children committed to our care. Many of us have, for a long time, been connected with the management of this Institution, and have become personally interested in the children of the Home; and we have made the warmth of this personal feeling an aid to the discharge of our official duties. But still we feel that as managers we have been acting in a work committed to us by the Church, which provides this mode of ministering to the necessities, temporal and spiritual, of one class of human sufferers; and of supplying, for the Master's sake, the wants of such Orphan children as He allows to depend upon us. We often wish that those who contribute the moneys we use could see, as we are allowed to see, how much good they do. They would indeed understand that "it is more blessed to give than to receive." We have watched the helplessness of many orphans. In cases of sickness we have been able to provide the kind attention of physicians and nurses, and usually have seen them avail to restore the sufferers to health. When otherwise ordered, their deaths have been attended with the offices of christian affection and piety. But usually we are cheered and comforted by knowing that your efforts are successful in training up these orphan children for God. and for usefulness in life. The majority of those whom you have aided have been rescued from want and from disgrace, and are growing up members of the Church, desirous of learning and of doing their duty. We need no stronger argument to induce the continuance of that liberality with which Church members in every parish, and the public generally, have enabled us to do this work.

There has happily been great unanimity of feeling and of action in the Board of management. Although the variety of the appeals which reach us often makes us wish for some enlargement of this charity. If our boys were separated from the girls—if we were furnished with conveniences for the sick—if our grounds were larger, we should be able to do much more good than now we can. In endeavoring to relieve distress, and to aid the worthy, we are often compelled to draw the distinction between those who are and those who are not orphan children; and sometimes, for the safety of such as are entrusted to us, are obliged to turn away from the distress of others. Thus recently we have been ordered to remove two of the little children to the City Hospital, and have suffered the pain of their deaths

there, because their disease would endanger the other children. Nothing was left undone that could be tried for those children, but we would have gladly have cared for them until death, and thus we often feel that there is great need for a hospital in connection with the Church. So, too, we are at times reminded by cases which appeal to thus for aid, that this is

not a general asylum but only an Orphan's Home.

There is another subject upon which we would be clearly understood. Applications are very often made to us for children by private families, who generally desire a healthy, active girl, old enough to be of service in the house, and for whom they promise to do well. Usually these applications cannot be answered favorably, and offense has sometimes been taken because it is so. We beg, therefore, that it may be considered how we are situated. We have an Asylum for orphan children in a helpless condition. If they had friends to afford them protection they would not be applicants for admission to the Home. If they were old enough to earn their own living they would doubtless find employment. But usually they are in the helplessness of infancy, crippled by disease, or by neglect, without much vigor of constitution, enfeebled by want, and altogether in need of constant care. If our efforts avail to restore them to health and strength, they sometimes become very useful in the Institution. The girls, especially, are able to assist the matron in the care of the younger children, in the house work, sewing, and other duties. In this way, in fact, they are being trained for the active duties of life, and have the happy feeling that they are useful. They actually do, in this way, pay their way in the Institution. But if these few who are useful, out of the many who cannot assist us, should be removed from us, we should be immediately compelled to depend on hirelings, probably not of our communion, nor caring for us, and certainly involving us in great expense. Besides, our experience leads us candidly to believe that the older children are happier with us than when placed out to service. We think, too, that we can do a better part by them than most of those who apply for them; for few are found willing to adopt a child as old as those of whom we speak. And yet in every case where we thought it would be for the good of the child, we have cheerfully consented to surrender it from the Home, at any sacrifice of interest on our part. The boys are not often retained after the age of twelve years; the girls frequently remain until after their majority. They constitute one christian household, under the Matron as the head of the family, assisted by the teacher in the culture and education of the children. They seem universally happy when well.

Our former Matron, Mrs. Simmons, and her husband, retired from her position on last July; and we feel that we are still indebted to her for the care she bestowed on the children during the four years of her connection with us. Mrs. Henriette Roberts, our present Matron, and her husband, immediately succeeded Mr. and Mrs. Simmons. They have been long and most favorably known to many of us, and we are not surprised to find our

expectations equalled by her energy and judgment in the care of everything pertaining to the internal administration of the Home. Miss D. W. Gedding has spent the year with us as teacher, and we cannot too highly appreciate her faithfulness and conscientiousness in her endeavors to imbue the childrens' minds with religious truth and with the principles of christian morality. In the school she has been assiduous and faithful, and the children have made as good progress as could be expected, considering the numbers and varying ages of the pupils. Recently, Professor S. T. Sanford has kindly instructed them in music, adding greatly to their proficiency in this respect. Some of the children have attended the Webster School for a short time lately.

Our thanks are due to Dr. Webb, whose unwearying attention throughout another year has probably saved us from recording more fatal sickness than has occurred. The children are often in need of prompt medical attendance when first brought into Institution, and until their constitutions become invigorated; and we have always found a ready will in Dr. Webb to answer our calls. Dr. Luytes has also very kindly attended one of the children in sickness.

The Daily Republican is furnished to the Home by the liberality of its proprietors, and we return them our thanks.

The accompanying report of the Treasurer will exhibit in detail the financial condition and operations of the year:

During the past year we have lost by death only those two young children of whom mention has already been made. They had inherited disease, and have been mercifully released by our Heavenly Father from a longer trial. We thank Him for the assurance that they who sleep in Christ are blessed.

Extensive improvements have been made by the purchase of twenty-five feet of ground adjoining the Institution; by painting and papering the house, and providing a second stairway from the upper stories, by which, in case of fire, our children would be much more likely to escape injury. The difficulty occasioned by a change of the grade in the streets around us, has also been remedied as far as practicable.

Commending the Institution to the favor of God, and to the liberality of churchmen, and of the public generally, we close our review of the year with thankfulness for its success. Some of its earliest friends are still active in its behalf; and we hope that as long as the poor and the orphan are to be found among us, the Church will have its organized means of ministering to their relief. The usefulness of this one is the best plea for the establishment of others.

Canons and Resolutions

TO WHICH SPECIAL ATTENTION IS CALLED.

EXTRACT FROM

CANON XII. OF 1853, OF THE GENERAL CONVENTION.

Of the mode of securing an Accurate View of the State of the Church from time to time.

SECTION 1. As a full and accurate view of the state of the Church, from time to time, is highly useful and necessary, it is hereby ordered that every Minister of the Church, or, if the Parish be vacant, the Wardens, shall present, or cause to be delivered, on or before the first day of every Annual Convention, to the Bishop of the Diocese, or, where there is no Bishop, to the President of the Convention, a statement of the number of Baptisms, Confirmations, Marriages and Funerals, and of the number of Communicants in his Parish or Church; also, the state and condition of the Sunday Schools in his Parish; also, of the amount of Communion Alms, the contributions for Missions, Diocesan, Domestic and Foreign, for Parochial Schools, and for Church purposes in general; and of all other matters that may throw light on the state of the same. And every other Clergyman, not regularly settled in any Parish or Church, shall also report the occasional services he may have performed; and if he have performed no such services, the causes or reasons which have prevented the same. And these Reports, or such parts of them as the Bishop shall think fit, may be read in Convention, and shall be entered on the Journals thereof.

RESOLUTIONS OF THE CONVENTION OF 1852.

Be it Resolved by the Convention, That an Agent shall be appointed by the Standing Committee, with the concurrence of the Bishop, whose duty it shall be to visit the State and other places, and solicit subscriptions in money, real estate, or other securities, to be invested in a Permanent Fund, the interest of which shall be appropriated to the support of the Episcopate in this Diocese.

2. Resolved, That the moneys and other means so collected or donated, after deducting the reasonable expenses of the Agent, shall be assigned or paid into the hands of a Treasurer to be appointed, whose duty it shall be to invest the same in stocks or mortgages as to him may seem best, and to report to the Convention from year to year the Fund thus collected and appropriated to the support of the Episcopate.

3. Resolved, That the interest annually accruing from this Fund shall in like manner be vested in permanent securities until the further order of the Convention.

RESOLUTION OF THE CONVENTION OF 1854 & 1858.

Resolved, That this Convention earnestly recommends to every Clergyman in this Diocese, that he call the people committed to his charge to contribute yearly as follows, viz:

At Advent Season, to Domestic Missions. At the Epiphany Season, to Foreign Missions.

On the First Sunday in Lent, to Diocesan Missions.

At Easter, to the Permanent Fund for the Support of the Episcopate. At Whitsuntide, to the Bible and Common Prayer-Book Society.

At Trinity Sunday, to the New York Tract Society.

On the Twentieth Sunday after Trinity, to Diocesan Missions.

Constitution

OF THE

PROTESTANT EPISCOPAL CHURCH

IN THE

DIOCESE OF MISSOURI.

ARTICLE I.

This Church acknowledges the authority of the General Convention of the Protestant Episcopal Church in the United States of America.

ARTICLE IT.

There shall be a Convention of the Protestant Episcopal Church in the Diocese of Missouri, on the fourth Thursday in May in each year, in such place as shall be determined by the Convention. In the event of the prevalence of any epidemic disease, or for other sufficient cause, occurring after the designation of the place of meeting of the Annual Convention, the Bishop, or in case of his inability to act, or of a vacancy in the Episcopate, the Standing Committee may appoint another place for the meeting of the Convention.

ARTICLE III.

The Bishop shall have power to call Special Conventions when he may judge it important to the good of the Church, or when applied to for that purpose by the Standing Committee hereinafter provided for; or, in the case of a vacancy in the Episcopate, the Standing Committee shall have power to call a Special Convention, and shall do so if applied to for the purpose by a majority of the Clergy entitled to seats in the Convention; and in case of the call of such Special Convention, it shall be the duty of the Secretary to transmit to each Clergyman and Parish in the Diocese, by letter, reasonable notice of the time and place thereof.

ARTICLE IV.

The Convention shall be composed of the Officiating Ministers, being regularly admitted and settled in some Church within this Diocese, which is in union with this Convention; and of lay members, consisting of one or more delegates, not exceeding four, from each Church, to be chosen by

the Vestry or Congregation. And Clergymen who shall have been employed as Missionaries of the Church within this Diocese, for six months preceding a Convention, and Clergymen engaged as professors and instructors of youth in any college, academy, or general seminary of learning, duly incorporated, and under the control of the Protestant Episcopal Church, may be members of the Convention.

ARTICLE V.

Every Convention shall be opened with prayers and a sermon; and the preacher shall be nominated by the Bishop; and in case of a vacancy in the Episcopate, by the Standing Committee.

ARTICLE VI.

In case of a vacancy of the Episcopate, or necessary absence of the Bishop, the members of the Convention shall elect a President from among the Clergy.

ARTICLE VII.

In all matters which shall come before the Convention, the Clergy and Laity shall deliberate in one body; and, in voting, the Clergy shall vote by individuals, and the Laity by Congregations; and when more than one Church or Chapel shall be united under one Vestry, the Delegates of such Vestry shall be entitled to a vote for each Church or Chapel, and a majority of votes of the two orders jointly shall be decisive; but, if in any case it be required by five votes, the two orders shall vote separately in the manner aforesaid, and the concurrence of a majority of each order shall be necessary to constitute a decision. In the case of electing a Bishop, the two orders shall always vote separately, agreeably to the mode as prescribed.

ARTICLE VIII.

A Secretary shall be chosen upon the assembling of the Annual Convention, who shall remain in office until the meeting of the next Annual Convention, and until a successor be appointed. His duty shall be to take minutes of their proceedings, to preserve their journals and records, to attest the public acts of the body, and faithfully deliver into the hands of his successor all books and papers relative to the concerns of the Convention which may be in his possession. It shall also be his duty to give due notice to each Minister and Vestry of the time and place appointed for the meeting of the succeeding Convention.

ARTICLE IX.

At least three Clergymen and the Lay-Delegates from three Parishes shall be necessary, as a quorum, for the transaction of business; provided, however, that a less number shall have power to adjourn from day to day.

ARTICLE X.

There shall be chosen, by ballot, at each Annual Convention, a Committee, consisting of three Presbyters and two Laymen, which shall be called the Standing Committee; three of whom, two being Clergymen, shall constitute a quorum.

At their first meeting they shall appoint one of the Presbyters of their body to be their President, and another of their number to be their Secretary, whose duty it shall be to keep regular minutes of all proceedings and business of the Standing Committee, to preserve them carefully recorded in a book to be provided for that purpose alone, to preserve the originals of all letters and papers addressed to the Standing Committee, to attest their public acts, to perform such other duties as they require, and faithfully deliver into the hands of his successor all books, papers and letters relative to the concerns of the Standing Committee which may have been entrusted to him.

The Standing Committee may make such regulations for the promotion of business as they may think proper, provided such regulations be not at variance with the Constitution and Canons of this Church.

The minutes of the proceedings of the Standing Committee, and all papers, and letters in their hands relating to the concerns of the Church, shall always be subject to the inspection and examination of the Bishop and the Convention.

The Standing Committee shall have power to fill vacancies in their numbers, and it shall be their duty to do so as soon as practicable after a vacancy shall occur.

ARTICLE XI.

The election of a Bishop of the Diocese shall be made in a stated Annual Convention, or in a Convention called by the Standing Committee, and stated by them to be for that purpose, and not to meet before the expiration of sixty days from the date of their resolution to call said Convention; which resolution shall, on the day following its passage, be communicated by them to every Clergyman and Parish in the Diocese, by letter, by mail, and published in three or more public papers. In the choice of a Bishop, no person shall be elected until he shall have received the votes of the majority of the Clergy and of the Parishes entitled to seats in the Convention.

ARTICLE XII.

The mode of altering the Constitution shall be as follows: A proposition for an amendment shall be introduced in writing, and considered in the Convention; and, if approved of, shall lie over to the next stated Convention; and, if again approved of in the next ensuing Convention by a majority of the two orders voting thereon separately and concurring, the change shall take place, and the Constitution so altered shall be valid and obligatory.

Canons

OF THE

PROTESTANT EPISCOPAL CHURCH

IN THE

DIOCESE OF MISSOURI.

CANON I.

Of a List of the Clergy.

Section 1. Within one week before the meeting of every Convention of this Diocese, the Bishop, or, in his absence, the Standing Committee, shall cause to be prepared a list of all Ministers canonically resident in the Diocese, annexing the name of their respective Cures, Parishes or Stations, or of the Institutions of Learning, duly incorporated, in which they are engaged—and in regard to such as are not engaged in Parishes, Missions, Institutions of Learning as above, their places of residence only—specifying, at the same time, who, of any class, are Deacons; but no Clergyman, while suspended from the Ministry, shall have a place on such list. And such list shall be laid before the Convention immediately after it shall have been called to order, and the names of the clerical members called therefrom; and those entitled by the Fourth Article of the Constitution, shall thereupon take their seats. The same shall be prefixed to the Journal and form a part thereof.

Sec. 2. When the right of any Clergyman to a seat in this Convention is disputed, it shall be determined by the Convention itself, whether his name be inserted in the list aforesaid or omitted.

CANON II.

Of Members of the Convention.

Section 1. The evidence of the regular admision of a Clergyman into the Diocese, and the evidence of settlement in a Parish thereof, shall consist in proof satisfactory to the Convention of a compliance with the Canons of this Diocese, and the Canons of the General Convention in that behalf for the time being. In all cases of a contested right to a seat, the evidence of employment as a Missionary shall consist in the certificate of the Bishop, or, in case of a vacancy in the Episcopate, of the President

of the Standing Committee. The evidence of the connection of a Clergyman with a Seminary of Learning duly incorporated, and under the control of the Protestant Episcopal Church, shall consist, also, in the certificate of the Bishop; or, in case of a vacancy in the Episcopate, of the President of the Standing Committee.

SEC. 2. The appointment of a Lay-Delegate to the Convention of this Diocese shall be certified in writing by the Rector of the Parish of which he is a Representative, or by one of the Wardens, or by the Secretary of the Vestry of such Parish; and no Lay-Delegate shall be entitled to a seat in the Convention unless he be entitled to vote for Wardens and Vestrymen of the Parish which he is appointed to represent; and no candidate for Holy Orders in the Church shall be entitled to a seat as a Lay-Delegate to this Convention.

CANON III.

Of Admission into Union with the Diocese.

To enable a Parish or Congregation to be received into Union with the Church in this Diocese, it shall be necessary that the Vestry submit to the Convention their Articles of Association; and further, that it be made to appear that such Parish or Congregation has acceded to the doctrines, discipline and worship of the Protestant Episcopal Church in the United States, and the Constitution and Canons in this Diocese. A certificate shall also be produced from the Bishop, or, in case of his absence, or of a vacancy in the Episcopate, from a majority in the Standing Committee, that notice has been given him or them of the organization having taken place, and of his or their approval of the same.

CANON IV.

Of Election of Vestries.

Section 1. On Easter Monday, in every year, the parishioners of each Parish shall elect a Vestry, to consist of not less than three, nor more than thirteen members.

SEC. 2. From their number, the Rector shall appoint a Senior Warden, and the Vestry shall elect a Junior Warden; one of whom shall preside in the absence of the Rector. They shall also elect a Secretary, whose duty it shall be to take minutes of the proceedings of the Vestry, and to perform such other duties as shall be legally assigned him, and faithfully deliver into the hands of his successor all books and papers relative to the concerns of the Church which may be in his possession.

SEC. 3. The Vestry shall continue in office until their successors shall be appointed.

SEC. 4. The duties of the Vestry shall be to take charge of the property of the Parish; attend to and regulate all its temporal concerns; to

CANONS. 85

provide for the support of the Rector, and, in case of his death, resignation or removal, with the advice and consent of the Bishop, to supply his place as soon as possible.

CANON V.

Of Deputies to the General Convention.

SECTION 1. The Convention shall, at each regular annual meeting, elect, by concurrent ballot of the clerical and lay members, four Clergymen and four Laymen, to act as Deputies from this Diocese in the General Convention.

SEC. 2. One month before the meeting of the General Convention, should either of said Delegates find himself unable to attend, he shall signify his inability to the Bishop, or, if there be no Bishop, to the President of the Standing Committee; whereupon it shall be the duty of said Committee, with the consent of the Bishop, if there be one, to supply the vacancy or vacancies so created.

CANON VI.

Of Parish Registers and Parochial Reports.

Section 1. The Parish Register, required by the Canon of the General Convention, shall specify the name and time of the birth of the child baptized, with the names of the parents and sponsors; the name of the adult baptized; the names of the parties married, and the place where the marriage was solemnized; the names of the persons buried; and also the time when each rite was performed. These registers shall be kept by the Minister in a book, to be provided for that purpose, belonging to the Vestry of each Parish; which book shall be the Parish Register, and shall be preserved by the Vestry as a part of the records of the Parish. The list of communicants shall embrace all within his Cure, as nearly as can be ascertained; and in his Annual Parochial Report, he shall distinguish the additions, removals, and deaths, since the last Report. He shall also keep a list of the families and adult persons in his Cure, so far as practicable, and also an accurate list of persons confirmed from time to time by the Bishop.

Sec. 2. In every case where a Parish is destitute of a Minister, the Register contemplated by this Canon shall be kept by the Wardens, or by

some person appointed by the Vestry for that purpose.

Sec. 3. Whenever a Clergyman shall perform any service in a Parish of which he has not the charge, the records required by the Canons of the General Convention shall be made in the Register of that Parish. But if the acts performed be beyond the limits of any Parish where there is a Book of Records, then they shall be recorded in the Register of the Parish of which he has charge, and the record shall state where the acts were performed; and if the acts be performed by a Minister who has

no regular Cure, and beyond the limits of any Parish, then, in addition to the private register required by the General Convention, he shall report all baptisms so performed, in writing, to this Convention, which report shall be a complete copy of the record, and contain the name of the place where each act was performed. And it shall be the duty of the Secretary of this Convention to copy the same into a book to be kept for that purpose.

CANON VII.

Of the Standing Committee.

Section 1. In case of a vacancy in the Episcopate, the powers and duties to be performed by the Bishop, in matters of dicipline, shall be performed by the Standing Committee, except those cases where such powers and duties are, or may be, especially delegated to, or enjoined upon the clerical members of said Committee; in which cases such powers and duties shall be exercised by said clerical members alone: provided that no sentence shall be pronounced upon a Clergyman but by a Bishop.

SEC. 2. In addition to the usual duties of the Standing Committee, they shall have power to make drafts upon the Treasurer for all moneys appropriated by the Convention, and these drafts shall always be signed by the President or Chairman of the Committee.

CANON VIII.

Of Vacant Parishes.

Section 1. Whenever a Parish becomes vacant, it shall be the duty of the Vestry to give immediate notice thereof to the Bishop.

Sec. 2. The Bishop shall appoint those of the Clergy in the Diocese who can, with most convenience, discharge the duty, to supply such vacant Parishes as have been reported to him, at such times as may be deemed convenient and proper. It shall be the duty of such vacant Parishes thus supplied, to defray all the expenses incident to such occasional services.

SEC. 3. No Clergyman shall take charge of any Parish in this Diocese, or be a Minister or Assistant Minister in any Parish, without having first obtained the written consent of the Bishop, or, in case there be no Bishop, of the Standing Committee of the Diocese. Nor shall any Clergyman, having the charge of a Parish, relinquish the same without the written consent of the Bishop, or, if there be no Bishop, of the Standing Committee.

CANON IX.

Of Elections.

All the officers of this Convention shall be elected by ballot, and shall continue in office until others shall be chosen; provided, that, by unanimous consent, elections by ballot may be dispensed with.

CANON X.

Of the Treasurer.

Section 1. At every stated Convention, there shall be chosen a Treasurer of the Convention. It shall be his duty to receive and disburse all moneys collected under the authority of the Convention, and of which the collection and distribution shall not be otherwise regulated. He shall be subject to the direction of the Standing Committee in relation to the mode and place of depositing the funds received by him, and the manner of paying them out; and his accounts and books shall be at all times subject to the inspection of the Standing Committee, or any member thereof. Before entering on the duties of his office, he shall give a bond to the Standing Committee, in such penalty and with such surety as they shall direct, conditioned for the faithful performance of his duties, and for the delivery over to his successor of all funds, securities, books and papers pertaining to his office.

Sec. 2. His accounts shall be rendered annually to the Convention, and shall be examined by a Committee appointed for the purpose, who shall

report upon the same to the Convention.

Sec. 3. In case of a vacancy in the office of Treasurer, it shall be supplied by an appointment, to be made by the Standing Committee of the Diocese, and the person so appointed shall continue to act until an appointment is made by the Convention. The Treasurer may be removed at any time from his office, by the Standing Committee, for any neglect or misconduct, of which they shall be judges.

CANON XI.

Of the Secretary of the Convention.

Section 1. In addition to the duties of the Secretary prescribed in the Eighth Article of the Constitution, he shall transmit, annually, to each of the Bishops of the Protestant Episcopal Church in the United States, and to the Secretary of the last House of Clerical and Lay-Delegates in the General Convention, and to the Secretary of every Diocesan Convention, a copy of the Journal of the Convention; and shall request the last to send copies of their respective Journals in exchange. He shall also transmit a copy to each Clergyman in the Diocese, and to each Lay-Deputy attending the Convention; and forward by mail, unless otherwise directed, ten copies to each Parish in the Diocese.

Sec. 2. He shall also transmit to every General Convention, in addition to the documents called for by the Canons of the General Convention, a certificate, to be signed by himself, containing a list of Clergymen in this Diocese, and the amount of the funds paid, or secured to be paid (distinguishing them), to the General Theological Seminary, together with the nomination of Trustees of that Seminary; and also a like certificate of the appointment of Clerical and Lay-Deputies.

Sec. 3. Any expense incurred by a compliance with the sections of this Canon shall be paid out of the Diocesan Fund.

Sec. 4. Whenever there shall be a vacancy in the office of Secretary of the Convention, the duty thereof shall devolve upon the Secretary of the Standing Committee.

CANON XII.

Of Attending the Meetings of the Convention.

Section 1. Whereas the regular attendance of the Clergy and Laity at the meetings of the Convention is of essential consequence to the interests of the Church, this duty is hereby enjoined upon them.

Sec. 2. And whereas it is often necessary to travel a considerable distance to the place of meeting of the Convention, it is hereby made the duty of the different Parishes to make provision for the expenses of their Clergy in attending the Convention.

SEC. 3. No member of this Convention shall leave the same during its session without having applied for and obtained leave of absence.

CANON XIII.

Of the Mode of Trying Clergymen.

Section 1. If any Clergyman of this Church offend in any one or more of the particulars enumerated in the Canons of the General Convention, or of this Convention, complaint may be made to the Bishop, which shall be done in writing by two Presbyters or three Laymen, being communicants of the Church.

SEC. 2. In every complaint, the charge or charges shall be distinctly specified.

Sec. 3. The Bishop shall, if he think fit, appoint at least three Presbyters, who shall constitute a Court for trying the accused person, and who shall be judges both of the law and the facts.

SEC. 4. A copy of the charges and specifications, and also sixty days' notice of the time and place of trial, shall be given to the accused.

Sec. 5. If the accused fail to appear, without reasonable excuse his default shall be entered, and he shall be suspended from the exercise of his clerical functions for the space of six months; and if, during that period, he shall not apply for a trial, he shall then, if the Bishop think proper, be degraded from the Ministry.

Sec. 6. All testimony, whether oral or by deposition, shall be under oath or affirmation, administered by some officer authorized by law to administer oaths.

SEC. 7. Depositions may be taken by either party, if it be made to appear satisfactorily to the Bishop that any material witness can not be procured upon the trial; and, in every such case, the Bishop shall appoint a commissary to take the same; and the notice and proceedings shall, as near as may be, conform to the laws of the State and practice of the civil courts.

CANONS. 89

SEC. 8. All testimony shall be reduced to writing and signed by the witnesses.

SEC. 9. The accused may, at his option, appear by counsel, and, in such case, the same privilege shall be allowed the prosecution; which counsel shall, in all cases, be communicants of the Protestant Episcopal Church.

SEC. 10. If the Bishop approves of the judgment, he shall, within thirty days, proceed to administer the discipline recommended by the Court; provided that the Bishop shall have the power to diminish the penalty recommended by the Court.

SEC. 11. The judgment of the Court shall, in all cases, be made known in writing to the accused, and to the Vestry of his Parish, if he be a

Parochial Minister.

Sec. 12. If, within the time aforesaid, the accused apply for a new trial, and the Bishop is of the opinion that there be reasonable cause therefor, he shall summon a new Court and order a new trial.

SEC. 13. The Court shall keep a full record of their proceedings, which shall be deposited among the archives of the Diocese after the trial is closed.

CANON XIV.

Of Contingent Expenses.

Section 1. At each stated meeting of the Convention, a Committee shall be appointed for the purpose of assessing upon the several Parishes in the Diocese a sum sufficient to defray the contingent expenses of the Convention.

Sec. 2. The Vestry of each Parish shall pay to the Treasurer of the Convention, within three months after the time of the stated meeting of the same, its assessment for contingent expenses. The Treasurer shall regularly charge the said assessments upon his books against each Vestry, crediting the same with payments when made; and shall report annually to the Convention the state of his accounts with each Parish, which Report shall be entered upon the Journal of the Convention.

CANON XV.

Of Appointments under the Canons.

Whenever a Clergyman shall refuse or neglect to discharge any duties growing out of an appointment under the Canons, without assigning to the ecclesiastical authority sufficient and satisfactory reasons for such neglect, he shall be liable to ecclesiastical proceedings or censure.

CANON XVI.

Of Support of the Episcopate.

At each stated meeting of the Convention, a Committee shall be appointed for the purpose of assessing upon the several Parishes in the Diocese the amount to be paid for the support of the Bishop, which amount shall be collected by the Vestries of the Parishes and paid semi-annually to the Treasurer of the Convention.

CANON XVII.

Of Permanent Fund for the Support of the Episcopate.

It shall be the duty of the Minister of every Parish in this Diocese to make at least one collection in each year, in aid of the formation of a Permanent Fund for the Support of the Episcopate.

CANON XVIII.

Of Alterations and Amendments.

No proposed alteration or addition to the Canons shall hereafter be considered by the Convention, unless at least one day's previous notice be given thereof in open Convention, and, unless by unanimous consent, until such alteration or addition shall have been referred to, and reported upon, by a Committee on Constitution and Canons.

Articles of Association for Organizing a Parish

IN CONNECTION WITH THE

PROTESTANT EPISCOPAL CHURCH IN THE DIOCESE OF MISSOURI.

ARTICLE 1. The name of this Association shall be "The Rector, Church

Wardens and Vestrymen of ———."

ART. 2. This Parish acknowledges itself to be a member of, and to belong to, the Protestant Episcopal Church of the United States of America; and, as such, it accedes to, recognizes and adopts the Canons, doctrines, discipline and worship of that Church, and acknowledges its authority accordingly. Any member who shall disclaim or refuse conformity to the said authority shall not be elected, or vote in the election of Vestrymen, Rector or Minister, or exercise any office or function in, concerning, or connected with, the said Parish or Association.

ART. 3. Provision for the compensation of the Rector, and the expenses of the said Association, shall be made by the Vestry in such way as they

may deem advisable to the best interests of the Church.

ART. 4. The Vestry of this Parish shall consist of not less than three, nor more than thirteen persons, who shall continue in office until others be chosen; and the election of such Vestry shall be made on Easter Monday of each year, by a majority of male communicants of full age, and who have been communicants not less than three months previously to the time of election (and all such other persons as the Parish may here designate).

ART. 5. The Rector of this Church shall be elected by a majority of twothirds of the Wardens and Vestrymen, at a meeting duly convened.

ART. 6. No person shall be Rector or Minister of this Church, or allowed to execute any of the functions of the same, unless he shall have had

Episcopal ordination, and be in full standing with the Protestant Episcopal Church in the United States of America, and recognized as a Minister in good standing, of the said Church, by the Bishop of the Diocese, or, if there be no Bishop, by the Standing Committee.

ART. 7. The Vestry shall have power to choose their own officers, fill vacancies in their own body, and to perform all other duties usually appertaining to their body. They shall choose one of their own number to be Church Warden, and the Rector (for the time being) shall appoint another of the said Vestry to be the other Church Warden, and the Warden appointed by the Rector shall be the presiding officer of the Vestry in the absence of the Rector; and in case of a vacancy in the office of Rector at the time of an election, or a failure on his part to appoint, then the other Church Warden shall be appointed by the Vestry, and both of the Church Wardens shall be communicants of the Church.

ART. 8. No conveyance of any lands or tenements, belonging to said Parish or Association, shall be made without a vote of the Vestry, two-thirds being present and concurring.

ART. 10. Amendments to these Articles of Association shall be submitted in writing to the Congregation at the Annual Meeting for the election of the Vestry, and shall lie over for consideration until the next Annual Meeting; but no alteration shall be made except by vote of two-thirds of the members present.
