Born December 24, 1789

Consecrated Missionary Bishop September 25, 1835

Translated to Wisconsin in 1854

Died May 24, 1870

### **First Bishop**

**The Rt. Rev. Cicero Stephens Hawks, DD**

Born May 26, 1812

Consecrated October 20, 1844

Died April 18, 1868

### **Second Bishop**

**The Rt. Rev. Charles Franklin Robertson, DD, STD, LLD**

Born March 2, 1835

Consecrated October 25, 1868

Died May 1, 1886

### **Third Bishop**

**The Rt. Rev. Daniel Sylvester Tuttle, DD, STD, DCL, LLD**

Born January 26, 1837

Consecrated Missionary Bishop May 1, 1867

Elected Bishop of Missouri August 9, 1886

Succeeded as Presiding Bishop September 7, 1903

Died April 17, 1923

### **Fourth Bishop**

**The Rt. Rev. Frederick Foote Johnson, DD**

Born April 23, 1866

Consecrated November 2, 1905 - Bishop of South Dakota, 1905-1911

Bishop Coadjutor of Missouri 1912-1923

Succeeded as Bishop of Missouri April 17, 1923

Retired November 8, 1933

Died May 9, 1943

### **Fifth Bishop**

**The Rt. Rev. William Scarlett, DD, LLD**

Born October 3, 1883

Consecrated May 6, 1930 - Bishop Coadjutor 1930-1933

Succeeded as Bishop of Missouri November 8, 1933

Retired November 1, 1952

Died March 28, 1973

### **Sixth Bishop**

**The Rt. Rev. Arthur Carl Lichtenberger, DD, STD, LLD, LHD, DCL, JCD**

Born January 8, 1900

Consecrated April 5, 1951 - Bishop Coadjutor 1951-1952

Succeeded as Bishop of Missouri, November 1, 1952

Elected Presiding Bishop October 11, 1958

Assumed Duties of Presiding Bishop November 15, 1958

Resigned as Bishop of Missouri May 15, 1959

Retired as Presiding Bishop October 12, 1964

Died September 3, 1968

### **Seventh Bishop**

**The Rt. Rev. George Leslie Cadigan, DD**

Born April 12, 1910

Consecrated April 16, 1959

Succeeded as Bishop of Missouri May 15, 1959

Retired April 16, 1975

Consecrated Bishop of Missouri May 3, 1975

Retired January 21, 1993

Bishop Coadjutor 1991-1993

Succeeded as Bishop of Missouri January 21, 1993

## **RULES OF ORDER**

Adopted by the 165th Convention:

1. The Presiding Officer shall appoint members of Permanent Committees at each Meeting of Convention.
2. All resolutions from the floor shall be reduced to writing, presented to the Secretary, and read to Convention. A resolution from the floor that is not a part of a committee report may be introduced only at the time indicated in the Order of Business. All resolutions from the floor, whether or not a part of a committee report, after receiving a short explanation from the presenter, must receive a 2/3 majority vote of Convention before it may be considered by Convention.
3. When any member speaks to Convention, he shall address himself to the Presiding Officer, state his name and church, and confine himself to the point in debate.
4. A member, other than the Chairman of the Committee whose report is under consideration, shall not speak more than twice in the same debate, nor longer than five minutes at a time, without leave of the House.
5. Any member of the House may call for a vote by hands or standing vote. Every member who may be in the House when such a vote is called shall be counted unless he/she be excused by Convention.
6. When a question has once been determined it shall stand as the judgment of the House, and shall not again be drawn into debate except on motion of reconsideration which must be made by a member who had previously voted in the majority.
7. All questions of parliamentary law not resolved by reference to the Canons or these General Rules shall be decided under Robert's Rules of Order.
8. All questions of order shall be decided in the first instance by the Presiding Officer, without debate; an appeal may be made to Convention by any member.
9. The reports of all Committees shall be in writing, and shall be received without motion for acceptance, unless recommitted by a vote of the House. All reports recommending or requiring any action or expression of opinion by the House shall be accompanied by a resolution for the action of the House thereon. All annual reports shall be received and filed by the Secretary as presented before or during Convention, and may be called upon motion to be read and considered at any time during Convention.
10. The names of movers of resolutions shall appear in the minutes of Convention.
11. All motions and resolutions requiring reference shall be referred, so far as possible, to the Permanent Committees of Convention.
12. Except in cases where majority vote is required, all elections shall be by Preferential Aggregate Transfer Ballot:
  - a) Each elector shall mark his or her ballot by numbering the names of all the candidates for each office in order of preference, with the preferred name being numbered 1. The elector shall not give more than one number to any name, nor shall any name be left unnumbered. Any ballot which does not comply with the directions given in this section will be invalid and will not be counted.
  - b) The persons appointed by the Presiding Officer to conduct the election shall count each valid ballot by assigning to each candidate that candidate's rank-ordered number on the ballot.
  - c) The candidates shall then be ranked according to the respective sums of their rank-ordered numbers, beginning with the lowest sum, and the candidate or candidates with the lowest sums shall be elected, according to the number of vacancies to be filled.
  - d) In case of a tie in which one or more candidates must be selected, that candidate or candidates with the highest number of first-place ballots shall be elected; and if the tied candidates have the same number of first place ballots, then the candidate or candidates having the highest number of second place ballots shall be elected, and so forth; and if the tied candidates have the same number of ballots at every rank, then the candidate or candidates to be elected shall be chosen by the toss of a coin.
13. The Presiding Officer may, having left the chair, enter into the debate on any question, but shall not then resume the chair until the main motion under consideration has been disposed of.
14. Once the Order of Business has been approved it may not be altered except by 2/3 majority vote of Convention, provided that the Presiding Officer may re-order agenda items at any time.

**November 19-20, 2004**

**Millennium Student Center - University of Missouri-St. Louis**

### **Call to Order**

Having been informed by the Secretary of Convention that a quorum was present, the Rt. Rev. George Wayne Smith, tenth Bishop of Missouri, declared the 165<sup>th</sup> Meeting of the Convention of the Episcopal Church in the Diocese of Missouri in session at 2 p.m.

### **Opening Prayer**

The Bishop called on the Rev. Jason Samuel, Vicar of the Church of the Transfiguration, Lake St. Louis, to lead the opening prayers.

### **Report of the Committee on Lay Credentials and Admission of New Parishes**

The Rev. Dr. Peter Van Horne, Secretary of Convention, reported that in accordance with Article III.3, Section 6, two-thirds of the Convention may vote to give seat, voice, and vote to the Lay Delegates of St. Luke's, Manchester, and release the Congregation from payment of its Diocesan assessment. It was moved, seconded, and carried to admit the Lay Delegates of St. Luke's, Manchester.

Convention Banquet. The banquet program featured a presentation by Episcopal City Mission.

### **Saturday, November 20, 2004**

#### **Call to Order**

The second plenary session was called to order by Bishop Smith at 9:03 a.m., and Mr. Ray Figueroa, St. Martin's, Ellisville led the opening prayer in English and Spanish.

#### **Elections**

The Rev. Tamsen Whistler explained the Preferential Aggregate Transfer Balloting System. She instructed delegates to add the name of the Rev. Robert Rhodes to the ballot for General Convention Clergy Deputy. It was moved, seconded, and carried unanimously to cast a unanimous ballot for the Rev. Melanie Barbarito and Mr. Sandy Peters for election to the Chapter of Christ Church Cathedral. Balloting for General Convention Deputy, members of the Standing Committee and the Diocesan Council continued until 9:31 a.m.

The Bishop reported that the previous night's offering at the Convention Eucharist was \$1,403 and is designated for Camp Phoenix. The Bishop also reported that an anonymous gift of \$5,000 was received for the same purpose.

On behalf of the Resolutions Committee, the Rev. Dr. Crews moved adoption of a resolution commending Mr. Richard Clark, Diocesan Treasurer, for his service (this was his last Convention as Treasurer). The resolution was approved with a standing ovation.

#### **Workshops and Lunch**

At 11 a.m. the Bishop recessed the Convention for a Stewardship Workshop. That was followed by a buffet lunch.

#### **Plenary Session III**

Bishop Smith called the Convention to order and the Rev. Nathaniel Pyron, Rector of St. Matthew's in Warson Woods, led the Convention in prayer to begin the afternoon's work.

#### **Address by the Vice Chancellor of the University of the South**

Dr. Joel Cunningham, Vice chancellor of the University of the South, addressed the Convention on the seminary's work and relationship to the Diocese of Missouri.

#### **Report of the Resolutions Committee**

The following resolutions were introduced and voted upon: (*See Appendix 1 for the full text of all resolutions.*)

##### **Resolution A-165: 2005 Standard Base Compensation for Clergy.**

The resolution was approved by a majority vote without discussion.

**Resolution B-165: Representation by the Congregations to Diocesan Convention.** The resolution was approved by a majority vote without discussion.

**Resolution C-165: Year of the Baptismal Covenant.** The resolution was approved by a majority vote without discussion.

**Resolution D-165: Exploration of the Role of the Church in Marriage.** The Rev. Robert Towner, Rector of Christ Church in Cape Girardeau, moved to separate the sixth resolve from the remainder of the resolution so that we could study marriage apart from clergy continuing to act as civil servants in marriage. The motion to separate the sixth resolve from the resolution was approved by a majority vote. After further discussion, Resolution D was amended and approved on a vote of 78 to 57.

The vote was followed by discussion of the sixth resolve of Resolution D-165. Ms. Lisa Fox, a member of Grace Church in Jefferson City, moved a friendly amendment so that the paragraph would read:

*"Be it further resolved that the clergy of the Diocese be requested to study the appropriateness of acting on behalf of the state of Missouri."*

The motion to amend was approved by a majority vote. After further discussion, the amended motion was approved by a vote of 67 to 58.

**Resolution E-165: Study and Review of the Budgeting and Assessment Processes of the Diocese.** The resolution was approved by a majority vote of 67 to 58.

**Resolution F-165: Use of Grape Juice at the Eucharist.** The Very Rev. Ronald Clingenpeel, Dean of Christ Church Cathedral, noted this was an important and sensitive issue, yet this should be a conversation that clergy have with their bishop. He moved to table the resolution. The motion was approved by a majority vote.

**Resolution G-165: Episcopal City Mission Sunday.** The resolution was approved by a majority vote without discussion.

**Resolution H-165: Development of a Diocesan Strategic Plan.** The Resolution as amended was approved by a majority vote. The amended resolution reads:

*"Resolved, that this 165<sup>th</sup> Convention of the Diocese of Missouri respectfully requests that the Bishop of Missouri appoint a task force or assign the task to an existing body to prepare a strategic direction for a period of time to be determined by the task force or existing body for the Diocese of Missouri, which would include the programmatic and administrative units of the Diocese and would explore how the congregations and convocations of the Diocese would participate in that plan; and that the task force or assigned body would report its recommendations to the 166<sup>th</sup> Convention.*

*"Resolved, that the committee appointed for this purpose coordinate the committees appointed to carry out resolutions B-165 and E-165."*

**Resolution I-165:** *Support of the Church of the Good Shepherd.*  
The motion was approved unanimously without discussion.

#### **Resolutions from the Floor**

**Resolution J-165:** *Dissolution of St. Barnabas' Episcopal Church, Moberly.* It was voted unanimously to consider the resolution. The resolution was approved by a majority vote after discussion and an expression of regret at having to dissolve a congregation.

**Resolution K-165:** *Bishop James Theodore Holly of Haiti added to the Church Calendar.* A majority voted to consider the resolution. An amendment was approved by a majority vote and the resolution as amended was approved unanimously. The resolution reads:

*"Be it resolved that the 165<sup>th</sup> Convention of the Diocese of Missouri supports adding Bishop James Theodore Holly to our diocesan calendar on Nov. 8 in recognition of his contributions to the Episcopal Church, and be it further resolved that we memorialize Bishop Holly by asking the General Convention in 2006 to add Bishop Holly to Lesser Feasts and Fasts."*

**Resolution L-165:** *Joint Convention with the Diocese of West Missouri.* A motion to consider the resolution failed to gain the necessary majority to be considered.

#### **Special Order of Business from the Diocese of Puerto Rico**

The Bishop and Delegates welcomed a delegation from the Diocese of Puerto Rico who representatives spoke of the importance of the Companion Diocese relationship to the people of the Diocese of Puerto Rico. The representatives presented a ceramic work of art to the Diocese of Missouri in gratitude for the nine years of the relationship.

The date and site for the 166<sup>th</sup> Convention was set as Nov. 18-19, 2005, in Columbia as the guests of the West Convocation. The motion was seconded and approved by a majority vote.

### **Appendix 1**

#### **Resolutions of this Convention**

#### **A-165 - 2005 Standard Base Compensation for Clergy; Submitted by Diocesan Council**

1 BE IT RESOLVED BY THE 165th CONVENTION OF THE DIOCESE OF MISSOURI that the annual, standard base compensation for full-time clergy in 2005 will be:  
CASH SALARY \$33,800  
HOUSING ALLOWANCE \$12,000  
[The actual compensation should be determined by Resolution of the Vestry/Bishop's Committee, in consultation with the clergy] and be it further  
2 RESOLVED, that the Church Pension Fund assessment will be paid by the congregation; and be it further  
3 RESOLVED, that \$50,000 group life will be paid by the congregation; and be it further  
4 RESOLVED, that medical coverage for clergy and eligible dependents, will be paid by the congregation; and be it further  
5 RESOLVED, that a standard of ten days per calendar year and \$500 will be provided for continuing education; and be it further  
6 RESOLVED, that the standard auto allowance will be \$2,000 per year; and be it further  
7 RESOLVED, that all parishes and missions encourage their full-time clergy to set aside two days each week for personal time.

#### **RATIONALE**

1. 2004 cash salary plus housing allowance was - Priest \$44,500. The recommendation for 2005 reflects a three percent increase.
2. The Canons of the Episcopal Church mandate that pension assessments be paid by congregations (assessment = 18 percent of cash salary plus housing and utilities allowance).
3. Provides for \$50,000 of term life insurance for active clergy. (In addition, all active clergy are eligible to receive an additional \$50,000 term life insurance benefit from the Church Pension Fund.)
4. The following group medical plans will be offered to diocesan employees – clergy (and lay) in 2005:

5. Congregations are encouraged to provide both time and financial resources to assist clergy with continuing education opportunities.
6. Standard allowance for auto expense.
7. Congregations are urged to encourage their clergy to take two days for personal time.  
Effective January 1, 2004, the short-term disability benefit, previously obtained through Income Replacement Insurance, became a new benefit for clergy who are actively participating in the Clergy Pension Plan and whose pension assessments are paid to-date.  
This resolution establishes a standard base compensation for clergy. Congregations are urged and invited to compensate clergy beyond the standard. It is understood that under individual circumstances and conditions internal adjustments in the compensation package may be negotiated.  
Note: If Convention adopts the above Resolution, the diocesan clergy standard compensation package in 2005 will be:

#### **COMPENSATION**

Cash Salary \$33,800, Housing Allowance \$12,000, Auto Allowance\* \$2,000

#### **BENEFITS**

Pension \$8,244, \$50,000 Life Insurance \$300, Continuing Education \$500

Subtotal \$56,844

Plus Group Medical/Dental Insurance\*\* \$5,412 to \$19,356

\* Or reimbursed expenses - \*\* Range of premiums for 2005 group medical plans

#### **B-165 - Representation by the Congregations to Diocesan Convention; Submitted by Metro IV**

1 BE IT RESOLVED that the 165th Convention direct Diocesan Council to study existing congregational representation to Diocesan Convention and present a new, more equitable formula to the 166th Convention in 2005 for discussion and vote.

#### RATIONALE

The formula for representation to Diocesan Convention has not been revised in decades. Currently, the parishes and missions of our diocese are now not equitably represented at Diocesan Convention, with hundreds being under-represented.

We are working toward the ECUSA 20/20 goal of increasing membership in our parishes and missions. It is imperative that we provide for fair and adequate representation of all members of the Episcopal Church to Convention, lest we inadvertently sabotage growth efforts.

As our power is not primarily temporal, but rather through the Holy Spirit, the presence of more members of the Body of Christ at the table can only increase and strengthen our effectiveness in the world.

The people of Metro IV have undertaken a study of other dioceses of like size and composition and have compiled the necessary data to review representation in this diocese which they can provide to Diocesan Council for their work.

#### **C-165 - Year of the Baptismal Covenant; Submitted by Commission on Ministry and Metro IV**

1 BE IT RESOLVED THAT this the 165th Convention of the Diocese of Missouri declares 2005 the Year of the Baptismal Covenant in the Diocese of Missouri.

2 BE IT FURTHER RESOLVED that we encourage all clergy and congregations to mark this year by offering opportunities for all baptized people to reflect on the new life in Jesus Christ to which we are called by baptism and to understand our call to mission and ministry in the name of the Holy Trinity, including, but not limited to:

3 Reciting the Baptismal Covenant at all services of the Holy Eucharist on the four Sundays recommended for baptisms (Book of Common Prayer, p. 312) whether baptisms are being performed then or not.

4 Teaching the Baptismal Covenant to its members in a format appropriate to its own setting.

5 Encouraging Vestries and Bishop's Committees to use the baptismal covenant as a lens through which to reflect on the congregation's ministry within and outside their community and

6 BE IT FURTHER RESOLVED that each diocesan meeting start with a short reflection on some aspect of the Baptismal Covenant.

#### RATIONALE

The ministers of the Church are lay people, bishops, priests, and deacons. Our understanding of ourselves as Christians is defined in the Baptismal Covenant and our call to mission and ministry is rendered there. We are united to Christ and to one another through baptism, and the Baptismal Covenant defines that union.

If we, as a diocese, endeavor to "read, mark, learn, and inwardly digest" this defining document, we will be more adequately equipped to do the work of ministry to which we are called by

our Lord, Jesus Christ.

Resources and support for these tasks will be provided by the Ministry of the Baptized Committee of the Commission on Ministry.

#### **D-165A - Exploration of the Role of the Church in Marriage; Submitted by the Rev. Roderic Wiltse**

1 BE IT RESOLVED THAT this the 165th Convention of the Diocese of Missouri requests that the community of the Diocese of Missouri begin an ordered, disciplined dialogue to explore the purposes of marriage and the role of the Church in this relationship;

2 BE IT FURTHER RESOLVED THAT the Bishop be requested to appoint a committee from the delegates to this convention to begin immediately such a dialogue and exploration.

3 This committee shall have members from every convocation.

4 A quarterly written report on the progress of its deliberations shall be presented to the Diocese beginning in January 2005;

5 BE IT FURTHER RESOLVED THAT every congregation within the Diocese be requested to initiate a ten-month study of the Sacrament of Holy Matrimony.

#### RATIONALE

The Rev. Dr. William Countryman, professor of New Testament at the Church Divinity School of the Pacific, said in St. Louis in 2002, "Classical Anglicanism is focused not on the detailed and certain knowledge of the mind of God, but on maintaining life and conversation in the faithful community.

"We believe that no one will ever know it all, but that the Spirit will work with us in the unity (not uniformity) of the church to bring us toward truth...Classical Anglicanism values the ongoing life and conversation of the faithful community, however awkward and irritating it may become, far above such doctrinal assurances, attractive though they may seem.

"We are pretty sure that God's help will not fail us if we continue to work and pray together." Our life as Christians, Anglicans, Episcopalians, is the ongoing dialogue that seeks elusive truth. Today we are challenged from all sides as a faith community that holds Holy Matrimony to be an important part of our sacramental life. Today, in the United States over 50 per cent of all marriages end in divorce. (Divorce is not the culprit, but has become an avenue of escape from painful and destructive relationships.) Today, in the United States only 52 per cent of those couples sharing a common roof, a common bed, and a common table, are married. Thirty years ago, in the United States, 70 per cent of couples sharing a common life were married.

#### **D-165B - Study of Role of Clergy as Agents of State; Separated from D-165A by Vote of Convention**

BE IT RESOLVED THAT the clergy of the Diocese be requested to commit themselves to study whether they should end the practice of acting on behalf of the State of Missouri as civil servants in marriage so there may be a clear distinction between The Celebration and Blessing of a Marriage and the

civil union of two persons.

**E-165 - Study and Review of the Budgeting and Assessment Processes of the Diocese; Submitted by the Clergy of Metro II**

1. BE IT RESOLVED, that this Convention of the Diocese of Missouri establishes a task force whose purpose shall be:
- to study and analyze the current assessment system;
  - review the funding of the diocesan budget;
  - review the process of budget formation;
  - review the process of assessment reduction/abatement
2. The task force shall consist of not fewer than eight and not more than 12 members and shall be appointed by the Diocesan Council, with the concurrence of the Bishop of Missouri.
3. Members of the task force shall be communicants in good standing of congregations of the Diocese of Missouri who have experience in financial management and shall represent a geographic, ethnic and gender diversity, as well as representing a variety of congregational sizes.
4. The task force shall be appointed no later than Dec. 31, 2004.
5. The task force shall prepare a report to be submitted to the Convention of the Diocese of Missouri in 2005.

NO RATIONALE WAS SUBMITTED

**F-165 - Use of Grape Juice at the Eucharist; Submitted by the Rev. Seamus Doyle**

THIS RESOLUTION WAS TABLED

1 BE IT RESOLVED that this 165th Convention of the Diocese of Missouri, acknowledging the pastoral concerns involved, wholeheartedly encourages those parishes currently not offering grape juice at the Eucharist to give serious pastoral concern to offering grape juice at the Eucharist to those who desire it with the same pastoral concern with which we offer rice bread to those who suffer celiac disease.

**RATIONALE**

The church has changed much since the Lambeth Conferences of 1898 and 1908. Twenty years of studies have disproved the argument that wine kills bacteria in the common cup and it is now well known there are many individuals, other than alcoholics, who choose not to receive wine for a variety of medical reasons just as there are those who receive rice bread instead of wheat.

Research into this issue has shown that the practice in a number of dioceses is for priests to use grape juice with or without the permission of the Bishop and in some dioceses the Bishop permits the use of grape juice except when he is present at a parish Eucharist.

Convention passage of this resolution will give a clear message to all members of our church and those visiting that everyone is welcome to the table of the Lord and that no one is left out at the Lord's Table because we are a "wine only" church.

The symbolism of the common cup is not lost because the unity of the content of the cups is more biblically sound in that Jesus

said; "I am the vine and you are the branches."

**G-165 - Episcopal City Mission Sunday; Submitted by Metro III**

1 BE IT RESOLVED THAT this 165th Convention of the Diocese of Missouri ask the congregations of the Diocese to observe the Last Sunday after Epiphany each year (or the nearest Sunday that the congregation's calendar allows) as Episcopal City Mission Sunday to recognize and support Episcopal City Mission's ministry of chaplaincy to children in detention.

**RATIONALE**

In 2004, Episcopal City Mission is marking its 50th year as an independent corporation providing chaplaincy to children in the detention centers of St. Louis City and County.

In 1894, members of the Episcopal Diocese of Missouri began providing ministry to people confined in public hospitals, the St. Louis City Jail and the St. Louis City Poor House. In 1935, Episcopal City Mission was formed as an independent agency to continue that purpose.

In 1952, the Metropolitan Church Federation reorganized the community services being provided by various church-related agencies. The Diocese of Missouri elected to continue ministering to troubled young people under the auspices of Episcopal City Mission. This ministry originally included chaplaincy at the Meramec Hills School for Girls and the Missouri Hills School for Boys (both now closed).

Fifty years ago, Episcopal City Mission took on its present day function of providing chaplaincy to youth detained by the courts of St. Louis City and County, and since then has been the only agency authorized by the courts to have offices in the detention centers.

ECM is also the only diocesan ministry in this country whose sole mission is to provide for the spiritual needs of troubled children confined in detention centers. No other diocese in this country attempts to do what this diocese has been doing for the past 50 years.

The Board of ECM gives thanks for the 50 years of strong support provided by the diocese and congregations of the Diocese of Missouri and looks forward to continuing this ministry into the future.

The observance of ECM Sunday in 2004 helped us spread the good news of the work being done in the detention centers in the name of the Diocese of Missouri. An annual observance will keep this work in the attention of the Diocese in years to come.

To facilitate this annual observance, Episcopal City Mission will provide congregations with camera-ready bulletin inserts, possible prayers and/or forms of the Prayers of the People and other materials each year appropriate to such an occasion.

**H-165 - Development of a Diocesan Strategic Direction; Submitted by Metro III**

1 RESOLVED, that this the 165th Convention of the Diocese of Missouri respectfully requests that the Bishop of Missouri appoint a task force or assign the task to an existing body to prepare a strategic direction for a period of time to be determined by the task force or existing body for the Diocese of Missouri, which would include the programmatic and administrative units of the Diocese and would explore how the congregations and convocations of the Diocese would participate

in that plan; and that the task force or assigned body would report its recommendations to the 166th Convention. The task force is required to coordinate its work with those bodies set forth in B-165 and E-165.

#### RATIONALE

In a time of limited resources and controversy over national and international issues it would be especially valuable to have a clear vision of the mission of the Diocese and how we intend to proceed towards implementing it in the next three years. We recognize that this work of clarifying and strategizing is being done in many quarters. A Diocesan Strategic Plan would pull these efforts together, and make them highly visible to all in the Diocese.

#### **I-165 - Support of the Church of the Good Shepherd; Submitted by Metro III**

1 RESOLVED, that the 165th Annual Convention of the Episcopal Diocese of Missouri express its appreciation for the leadership and dedication of Wardens and Vestry of the Church of the Good Shepherd, Town and Country, as they have worked to continue regular worship services and fellowship beyond the four corners of their church property; and be it further  
2 RESOLVED, that the 165th Annual Convention of the Episcopal Diocese of Missouri express its support for the faithful members of The Church of the Good Shepherd as they continue to address the challenges of resurrecting their parish from divisive actions of the recent past and work to rebuild the parish's financial foundation.

NO RATIONALE WAS SUBMITTED

#### **J-165 - The Dissolution of St. Barnabas' Episcopal Church, Moberly, Missouri; Submitted by the Bishop's Committee of St. Barnabas'**

1. WHEREAS, the Bishop's Committee of the Mission, St. Barnabas' Episcopal Church, Moberly, Missouri, has voted to dissolve by closing its operations complete, and  
2. WHEREAS, the Bishop has indicated his willingness to approve the dissolution of St. Barnabas' Episcopal Church, Moberly;

3. BE IT RESOLVED by the 166<sup>th</sup> Meeting of the Convention of the Diocese of Missouri, that, pursuant to Diocesan Canon IV.16, Section 1, this 165th Annual Convention of the Diocese of Missouri hereby approves with regret the dissolution of St. Barnabas' Episcopal Church, Moberly, Missouri, a mission, subject to the Bishop's final approval of such dissolution, and compliance with the applicable provisions of Canon IV/16 as determined by the Bishop in consultation with the Standing Committee; and

4. BE IT FURTHER RESOLVED that the Chancellor and other appropriate officers and agents of the Diocese be and they are hereby authorized and directed to take whatever other further actions that they may deem necessary or desirable in order to implement both the spirit and letter of the foregoing Resolution.

#### **K-165 - Support of a Resolution before General Convention Regarding Bishop James Holly; Submitted by the Companion Diocese Committee**

BE IT RESOLVED that the 165th Convention of the Diocese of Missouri supports adding Bishop James Theodore Holly to our diocesan calendar on November 8 in recognition of his contribution to the Episcopal Church, and be it further resolved that we memorialize the General Convention in 2006 to add Bishop Holly to the Lesser Feasts and Fasts.

#### **L-165 - Quadrennial Meeting With Diocese of West Missouri; Submitted by the Rev. Seamus Doyle**

**Appendix 3**

**Bishop's Address**

To the faithful in the Episcopal Diocese of Missouri: Grace to you and peace from God our Father and the Lord Jesus Christ.

In my address to you a year ago, I could not in good conscience do what I am going to do today. Last year, I could not devote the bulk of my address to naming before you the challenges and possibilities that are ours in mission and ministry.

This year, I get to follow my heart's desire.

Which does not mean that I am going to ignore the plain truth or pretend that denial serves anyone well. The bonds of affection and belonging have been tested—in this Diocese and much more so in the larger Anglican Communion.

The actions of General Convention 2003 and the ordination of Gene Robinson to the episcopate have had their consequences. I am aware that one consequence has come in the cost to my own time and energies. Just the litigation necessary to retain the Church of the Good Shepherd was financially costly, and it had an emotional and spiritual cost for me, and for others.

Ah, but it is so good to point toward the delegation from that Church, to know that they are here, and that they really want to be here.

I am aware of the energy I have expended in addressing conflict, here and there in our Diocese, conflict that is not over. I know the costs many others have likewise borne. I am aware of the

anxieties felt by faithful gay men and lesbians among us, some of whom fear that the Church they love might jettison them.

I am aware of the worries I face in the larger Anglican and little-catholic worlds, as I your bishop carry your needs and concerns with me.

I say all these heavy things with a peculiarly happy realization: You know, we are now at a point where this is not all that I get to do.

I love being a bishop; and more to the point, I love being your bishop.

My passions lie in those things I think you asked me to do, when you elected me, now three years ago.

- I think you asked me to be mission-minded, in all things.
- I think you asked me to dream with you some new ways of engaging in ministry.
- I think you asked me to help shape our church for servant ministry, with a renewed sense of the diaconate.
- I think you asked me to help grow the Church.
- I think you asked me to teach and to learn.
- I think you asked me to be a vision-bearer, and to tell the truth.

These are still the things I most want to be about. After what feels like a lost year, it now feels like I am getting my job back.

No denial of the hard work ahead of us — but I now think that the hard work ahead will no longer have to be the all-consuming issue. I think it can take its place as one issue among others, all of which are about mission and ministry and life together.

The final word I have to say about the past year is forward-looking, and it is a word about the Windsor Report. I am not going to rehearse for you the details in these 93 pages, details you can read for yourself by downloading the document. But briefly, here's how I read it.

The theology of Church that the report lays out is perhaps the most brilliant short treatment of the subject I have read, anywhere. The first third of this paper left me with the humble realization of God's generosity, in the gift of unity, a gift not to be squandered, either in its visible forms or mystical. I also realize that I am not satisfied with mystical and invisible unity alone.

The report has hard words for the Episcopal Church, for the 52 bishops who laid hands on Gene Robinson, and (to a lesser severity and only by extension) for the 62 bishops, including myself, who gave their consent.

The Windsor Report also names practices and enumerates steps necessary to sustain unity, and to restore it when broken, as it is in our current circumstances. The Report sketches a way forward. In consultation with you and as I take my place within the community of bishops, I want you to know that I intend to move in that forward direction the Windsor Report charts out.

I am a catholic Anglican. Communion counts. My ability to stand alongside my friend Bishop Bullen Dolli, from the Diocese of Lui in Southern Sudan, matters a great deal to me. He and the people he serves come as enormous gifts to us.

Balancing justice and compassion for gay and lesbian brothers and sisters among us is necessary, but the balance of justice and compassion must not be done on the backs of the overwhelming numbers of Anglicans in our world, most of whom are poor in things, many of whom are oppressed by their governments, all of whom are part of God's desire and purpose in our broken world.

Sustaining unity has its purpose in the ministries of justice and compassion. Unity, you see, is not something "nice" to have, if you can get it. Unity is a sign of God's restoring broken things, in a broken world. It is a part of our mission and ministry.

Mission and ministry are what I love most about being a bishop. And I have been listening to your articulated dreams, two of which I can name because you name them. There is, I think, a third dream which mostly goes unarticulated.

The first two:

- This Diocese wants to start new Churches.
- And this Diocese wants to strengthen and grow the ones we already have.

This Diocese can't always put it into words, but there is still a third dream, a yearning for what our Prayer Book assumes in a Church built on baptism. The theological term is: Baptismal

Ecclesiology. An understanding Church born through the waters.

First, there is the matter of new Churches. We have to have them. There are places we need to be where we are not. You know that. In starting new churches, we must be as wise as serpents and as gentle as doves. You also know that the Episcopal Church has a track record of getting this backwards, when it comes to Church starts. We have often been about as smart as pigeons — and we have wasted a lot of money in the process.

I remain committed to starting new churches—but to be as savvy as possible, since it is so costly. Laying the groundwork for a church start in Columbia has already begun. I want our work in Columbia to be solid, and I want to do it right.

Starting churches is not a part of the ethos in this diocese, and I want to weave it into our sense of mission and purpose. I do not want starting a church to be something exotic; I want church-plants to become a sustaining part of ministry in our diocese, the missionary fabric of our life.

Frankly, it would be easier just to start a church now and then, here and there. I want this work to be part of who we are, for the sake of Christ Jesus. And we can do it.

Second, growing and strengthening the Churches we have. These are our treasures; you are our treasures.

I had a conversation not long ago with an old friend who wanted me, a bishop of the Church, to tell her what she could do, to make her own Church grow. I know that I frustrated her. Because there is no unambiguous how-to, and that's what she wanted.

There are some practices for us to undertake, but there are no tricks. The issue is nothing less than the conversion of life and the changing of our communities. That is entirely possible for us to do. But it is so hard.

Conversion is like the potter's hand on the lump of clay we are: Smashed down, remolded, no longer the same shape, then fired, burned into something beautiful: That's the conversion God works in us.

It is also about the most interesting work that I get to be a part of. And I get to see remarkable things in our communities of faith. In the past year, I have helped consecrate two new Churches, for Christ Church, Rolla, and for St. Timothy's, Creve Coeur — signs of health in both places. And beautiful buildings, both. Holy Communion in University City and Calvary in Columbia both have splendid new additions. St. Matthew's, Mexico, has increased its average Sunday attendance by 88 percent. Calvary, Louisiana and St. Matthew's, Mexico, have both identified candidates for the priesthood to serve in those places. Candidates from them, for them. A new model for ministry. St. Francis', Wildwood, has increased its giving by 41 percent, so they might do what they think God is asking from them.



The Episcopal School for Ministry continues to grow in enrollment and in excellence. It will provide a steady stream of ministers for some years to come, and it now hosts a school for congregational development, to help parishes do what they need to do in a life of conversion.

Small signs, some not so small, of the conversion God asks from us, and which we must engage.

Third, the need for a true baptismal ecclesiology. I will say what is hard for me to admit, that the most common understanding about ministry is that it requires ordination. Or at least real ministry requires ordination. If this were not the case, there would be little anguish when the outcome in discernment for ministry says: The ministry best suiting you is one that belongs to all the baptized. (No! I've got to be ordained!) If we really understood the dignity of baptism, those certificates would be larger than the one for my ordination to the episcopate.

If we had a true baptismal ecclesiology, there would be no private baptisms, because we would understand that there is everything corporate about the rite, and nothing private at all. If we built our understanding of church on baptism, the boundary between clergy and laity would be a modest boundary, a line and not a chasm, a distinction but never adversarial.

This is what the New Testament passages about ministry teach, and this how our Prayer Book assumes that we will live. We say that we want this in what we pray and in so much of what we say: But how do we get there?

The strategies I can see for us, as we move ahead, as these dreams are in view, are also three in number:

First, I think we need to strengthen our commitment to adult formation. Which I take not to be just about the conveyance of information but the making of disciples. This is a non-negotiable element to a real baptismal understanding of the Church. If we are baptized, then we everyone deserve to know the Bible and the tradition, and to live it. We deserve to learn the practices necessary for us to follow Jesus, which is the obligation of the baptized. Education ministries among children and youth remain crucial pieces of the puzzle. But ministries of formation may not stop there. Or else we end up with what my friend and Canon Dan Smith calls the "Jethro Bodine School of Christian Education."

Jethro, you remember, was the lovable dufus on the Beverly Hillbillies, who graduated from the sixth grade and knew everything he needed to know. That has never been an adequate model for faithful Christians, and it certainly is not adequate in the world we inhabit. You can hardly get a job flipping burgers with a sixth-grade education!

I commit myself to strengthening our ways of adult formation, and I challenge the clergy to join me in the leadership to do the same.

Second, growing the Church and a baptismal understanding of it requires the appropriate care and feeding of clergy. Baptismal ecclesiology is not built on a blurring of distinctions between

clergy and laity; it depends on an appropriate understanding of these distinctions. Ordination is necessary for good order and teaching, for leadership in mission and ministry, and for sacramental modeling. Nothing more or less. The ordained exist for the sake of all the baptized, and not the other way around.

The ordained are crucial for the work of leadership, if we are ever to live our dreams. They are great resources, and they deserve the best tools and they deserve to learn, and to rest and play, and to rest and pray, and to have families—and they deserve your tending and mine. I am not so much interested in a program of clergy care (though we may need something in this line) as I am in growing a culture of it. A culture in which clergy and laity understand one another, and learn how, appropriately, to minister with and care for one another. This is harder than it sounds; but it is imminently do-able. I want to be much more intentional in this work, and I ask you to join me.

Third, we need a better theology of stewardship, and better practices. Which is one of the reasons I asked Terri Parsons to be here among us. The issue is not just one of strapped finances, although it is that, because we sure have some strapped finances these days. The issue goes deeper, to those core beliefs about possessions, and money, and generosity—and giving that takes its cue from the self-giving that we see in Jesus on the cross.

Does our giving come from a commitment to living sacrificially? Or is it about: What's in it for me? What's the pay-off? I believe we must become much clearer in our assessment schedule and accountability, on the one end, and much clearer in the reporting of everything about Diocesan life and ministry, on the other end. Including staff salaries.

You deserve to have whatever data you need, in order to make good decisions for the finances in our diocese.

But it is that underlying attitude toward money that matters most. Andrew Carnegie was perhaps the most munificent giver in American history. And he taught giving the same way he gave: From what is left over. The fortunes that he gave away barely affected his worth, and *never* affected his bottom line. He was not a sacrificial giver, and he did not teach such a thing. Although he did give away fortunes.

Just understand that his ample philanthropic giving was not the same as the gospel standard. Which takes the cross as its full measure.

I believe that we have what it takes to do the things God asks from us, and about which we dream. I believe that as a theological truth and as a practical possibility.

Debbie and I have been tithers for a quarter of a century, and I cannot begin to enumerate what we have given up in making that commitment. It was harder when I was a young priest and we were young parents and Debbie was in graduate school than it is now. But I can also say that with that commitment to giving has come a conversion in attitude toward money. A liberating conversion.

Ultimately, conversion is the purpose of this corner of the church catholic called the Diocese of Missouri. If we make these experiments in conversion, and commit to mission and ministry, then stewardship is going to be a part of what is essentially a package deal.

Last words: I do believe that we are not well organized, as a Diocesan community, to do the work God asks from us. This is to say, I support the resolution before you, asking for a strategic plan. What I have said today is bare bones which may be reshaped and must be fleshed out, to make it ours and not just mine. Planning is necessary.

Very last words: Even on my worst days, these past 18 months (and I have had some worst days, believe me), I have still cherished the work given me. Nothing is more gratifying, I believe, than ministry in the name of Christ Jesus. I discover that I love the people of this Diocese, and I love its parishes. I love being your bishop, and even on those worst days, I cannot imagine any other venue for my life, to shape me into the person God has in mind for me to become.

Conversion of life is never easy. I am grateful to have the privilege of experiencing my continual conversion among you.

We also wish to thank our staff person, the Rev. Dr. Canon Daniel Smith, for his work with us, and the support of his associate, Ms. Emily Peach, and his assistant, Ms. Ann Tolch. Their support keeps the work of the Standing Committee going forward. We want particularly to applaud the work of the chancellor of the Diocese, Mr. Harold R. Burroughs, in an unusually trying year. The role of the Standing Committee of a diocese is to act as a council of advice to the Bishop, and the Bishop does regularly ask for input on pressing matters. Standing Committees also link the dioceses with the larger Church in their role as giving consent to elections of bishops in other dioceses, demonstrating that bishops are elected to serve the entire church. The legal role of the Standing Committee is exercised through its reincarnation each meeting as the Corporation for the Diocese of Missouri (COEDMO). As for the state of the Diocese of Missouri, it is upbeat, hopeful, and spirit-filled. Everyone knows the Episcopal Church and Anglican Communion have divisions and debates at the moment. From the standpoint of an historian, it is helpful for me to realize that this is nothing new or unique. Much of the growth of the Church through the millennia has come through division, debate, prayer, and then, some consensus. We continue to seek that consensus. The Diocese of Missouri has had its share of debate and disagreements in this past year. Through all of that, we have continued to move forward in many areas, and there are many hopeful signs. In this regard, on behalf of the Standing Committee, I want to express appreciation for the leadership and example of Bishop Smith, who has tempered firm commitments and opinions with love and compassion for those who might disagree. We are building fences and healing wounds under his pastoral care. During this year, acting on its canonical responsibility, the Standing committee has agreed to the holding of elections in four dioceses and approved the election of bishops in two dioceses. Those dioceses are listed separately at the end. We have accepted by-law changes at Trinity Church, St. Louis, and Church of the Holy Communion, University City. We have consented to the ordination of nine persons seeking Holy Orders. Their names are listed separately. We approved six grants to seminarians from the Theological Education Fund. We approved a White Fund loan to Holy Communion, University City, for renovations. We rejoice in the generosity of the donors that made this wonderful resource available to the parishes of this Diocese. In our guise as COEDMO, we approved six grants from the Church Assistance Endowment Fund for St. Alban's, Fulton; Trinity, De Soto; Advent, Crestwood; Trinity, Kirksville; St. Barnabas', Florissant; and St. Mark's, St. Louis. These are relatively small grants for plant maintenance. The Standing Committee approved the recommendation of Bishop Smith that the former St. Andrew's, Northwoods, be turned over to the congregation of Ascension, St. Louis, and this transition has taken place. On a more somber note, the Standing Committee watched with great regret the decision of a number of members of the Church of the Good Shepherd and their Rector to secede from the Episcopal Church. The Diocese took legal action to retain the property under the relevant portions of canon law, and this petition was successful in the courts. The

remaining members of the Episcopal Church of the Good Shepherd were able to return to their church home and have begun having regular services there after some months of services in homes. This legal action caused a considerable legal bill for the Diocese. The Standing Committee did receive from Bishop Smith a notice of deposition of the Rev. Paul Walter from the priesthood. The Standing Committee took the planning role in a very successful Leadership Conference (formerly Vestry Conference), and we look forward to another such event coming this fall. The Standing Committee (disguised as COEDMO) has received and accepted the audit accounts for the Diocese. While economies had to be made to meet the decreased revenues, all in all the Diocese remains in good shape financially. We appreciate the work of the Treasurer and the chief Financial Officer of the Diocese. Taking all things into consideration, we conclude that the state of the Diocese of Missouri is good, and we applaud the efforts of all these people, lay and clerical, who help to make it so. On behalf of the Standing Committee, I submit this report to the 165th Convention of the Diocese.

## Appendix 7

### Report of the Diocesan Registrar and Archivist

The Archives of the Diocese of Missouri is the official repository for the historical records of the diocese. Holdings include documents, convention journals, diocesan newspapers, photographs, slides, tape recordings, films, videos, books and some three-dimensional items. At present the collection includes approximately 700 linear feet of materials housed primarily in space leased from St. Louis University. Some records remain in a small office at Bishop Tuttle Memorial.

The archival collection has grown considerably in the last few years with the addition of records from Thompson House, Epiphany, Des Peres; St. Andrew's, Northwoods; St. Stephen's, St. Louis, and St. Barnabas', Moberly, as well as the records of the Lichtenberger Society following its dissolution. Episcopal Church Women has begun sending its past records to the Archives. Staff in the Bishop's Office is history-conscious, and older files are routinely sent to the archives for retention and accession if appropriate.

This fall, I hosted the first, and hopefully annual, Church Archives Workshop for parish and mission archivists, historians and interested volunteers. Lisa Fox, senior conservator at the Missouri State Archives and member of Grace Church, Jefferson City, was the guest speaker. Participants were enthusiastic, and have requested additional training in other areas including archives organization and "hands on" basic preservation techniques. I hope to have representatives of more congregations at future workshops.

I continue to receive requests for letters of transfer from closed churches, and for birth, marriage and burial records as family genealogy becomes a more popular pastime for many. And, of course, I am always happy when I can provide information relating to the history of the Diocese and the many congregations and institutions that have been part of the Diocese during the past 165 years.

loyal member of St. Stephen's, has served on the Mission Committee, and is a member of ECW.

Extra Diocesan Affairs Department on the Committee for Anglican-Lutheran Relations. He is the diocesan representative to the Latin American Council of Churches (CLAI) and chaplain of The Brotherhood of St. Andrew's Cathedral Chapter. Ms. Awilda Torres De Jesús, San Mateo (Peñuelas). Awilda is Senior Warden at San Mateo, a member of ECW and a choir member.

**Three Missourians attend convention in Puerto Rico.** Ms. Christie Boyle (Grace, Kirkwood), Mr. Ray Figueroa (St. Martin's, Ellisville) and Ms. Eunice French (Christ Church, Rolla) were met at the airport in San Juan on Oct.22 by the Rev. Canon Emily Morales and the Rev. Ivette Linares and were given a tour of the spacious new offices of the Episcopal Church of Puerto Rico and the guest house in the building which formerly housed the diocesan offices. They were welcomed by Bishop David A. Álvarez, the Rev. Canon Wilner Millien, and the diocesan staff. Dinner with Bishop and Mrs. Álvarez and Canon Morales provided an opportunity to catch up on news from both dioceses and to speculate on the upcoming elections. Local and island-wide political campaigns are a sight to behold. Sound trucks blaring politicians' messages throughout residential neighborhoods are commonplace. An unexpected privilege was visiting with a new priest who had just moved with his wife and daughter from Colombia, S.A., to become Vicar of the Episcopal church in Vieques. Wilson's gift to the Diocese of Puerto Rico is a hand-carved cross of extraordinary beauty which now hangs in the meeting center where the diocesan convention was held. (Ask at the CDC booth to see a photograph.) With translators to assist them, the Missouri visitors enjoyed the one-day convention and exchanged gifts between the dioceses. Following convention they separated to visit their linked churches and host families for the weekend. Wow, what welcomes they received at St. Stephen's (Guaynabo), San Judas Tadeo (Aibonito), and Santa Hilda (Saint Just). Each had wonderful adventures and are happy to share them. Suffice it to say that they experienced the full depth and warmth of Puerto Rican hospitality.

**Companion relationship closes after nine years.** The Puerto Rico-Missouri Companion Diocese Covenant states "The purpose of this Companion Diocese Relationship is to share the life and work of the Episcopal Church in the two dioceses, to strengthen each other in ministry and mission, and to grow in cultural awareness, understanding and respect of and for each other." People in both dioceses shared, strengthened and grew and will continue to do so informally for years to come. At conventions in both dioceses, we celebrate the companion relationship we have shared with the Episcopal Church of Puerto Rico for nine years. Originating on June 1, 1995, this linkage has enriched us through many friendships and opportunities to observe first-hand the dedication to ministry and mission and the vibrant spirituality of Episcopalians in Puerto Rico. Perhaps the best way to sum up this special relationship is to quote from Missourians who have directly experienced it:

*The Rt. Rev. George Wayne Smith, Bishop of Missouri:* "... The congregation was more than gracious in accepting the accented Spanish from this NorTEAMERICANO. In fact, they were more than gracious in all things... The easy formality of the evening [diocesan celebration in Ponce] captivated me, as did the joy these our friends find in their Church and their families and the regard they showed me, a visitor among them..." *Clergy visitor:* "We met people who are proud and happy to be Episcopalians... Faith, hope, and love have a way of speaking clearly and being understood fully... We were embraced at the Peace and nourished at the Eucharist, which somehow are universally understood..."

*Adult lay visitors:* "All their... efforts are directed toward a coordinated program in which ministry, service and evangelism are the priorities." "... my first experience in a new country with a new language was absolutely wonderful and taught me a great deal about how universal God's love is..." "... ## Appendix 9

### Report of the Episcopal School for Ministry

The Episcopal School for Ministry of the Diocese of Missouri offers educational resources to:

- Deepen the spiritual lives and strengthen the ministries in the church and the world of all who seek to grow in the knowledge and love of God;
- Prepare people to serve the church as priests and deacons;
- Strengthen the ministries of lay and ordained people through continuing education.

**The Episcopal School for Ministry (ESM)** was founded in 1999 for the purpose of training people for ordination as Deacons to serve the Diocese of Missouri. Offering a three-year certificate program, the School has graduated 16 students. Two ESM graduates have been ordained as deacons in this Diocese, another will be ordained in December. Other past and present students are at various points in the discernment process, while many are enrolled in the School simply to learn more about their church, its scripture, history, and liturgy. Led by the Rev. Dr. Warren Crews since its inception, the School offers a curriculum grounded in church scripture, theology, history, and liturgy, with a strong component of training for service ministry. ESM also oversees the Anglican Studies Program at Eden Seminary. During 2004, ESM has moved well beyond its original diaconal training mission to follow the Bishop's earlier charge to serve as a source of learning for all the baptized who are serious about ministry.

Beginning this past September, ESM added a two-year program in Congregational Development Studies, guided by the Rev. Dr. Canon Dan Smith. This program added 30 students from 14 parishes to the School, bringing our total enrollment this fall to 50 students. During the coming year, the School plans to add continuing education courses and workshops for both ordained and lay personnel as well as programs of interest to all adults in the Diocese.

## Appendix 10

### Report of the Commission on Ministry

The Commission on Ministry is charged with identifying and training persons for baptized and ordained ministries. In 2004, as in previous years, we have spent a great deal of time on discernment with persons who believe they are called to priesthood and diaconate and formulating recommendations for the bishop. We enlist members of the Standing Committee and the Diocesan Board of Examining Chaplains to interview with us. In 2004 we have certified to the bishop and Standing Committee the readiness for ordination to the transitional diaconate of Ms. Renee Fenner, Mr. Jay Kanzler, Ms. Beverly

Van Horne, Ms. Sally Weaver and Ms. Doris Westfall, all of whom will be ordained on December 22, 2004. We certified the readiness for ordination to the Diaconate of Ms. Susan Naylor, who was ordained on June 3, 2004. We also certified the readiness for ordination to the Priesthood for the Rev. John Kilgore, who was ordained on March 25, 2004, and the Rev. Jonathan Erdman and the Rev. Teresa Mithen, who were ordained on June 25, 2004. We have recommended eight persons for postulancy for priesthood, one of whom was previously ordained in another tradition. We continue to review

and revise the materials we use for this diocesan level discernment process, so that the congregational discernment group's report, the rector or vicar's recommendation and the diocesan interview teams are all seeking the same qualities or asking similar questions. We seek to move from a process in which we "accept" or "reject" a person's sense of call to a particular ministry to a process in which we help people to discern the ministry to which God is calling them. All Christians are called to ministry; the work of discernment is to find the form and direction of that ministry. We hold an annual discernment conference to help educate the diocese about the work of discernment, the nuts and bolts of the ordination process and the church's understanding of different types of ministry, baptized and ordained. The canons of the national church were revised by the General Convention of 2003 and the ordination process was changed in significant and substantive ways. As a Commission we are continuing to live into the implications of these changes for our work. In particular, the process leading to ordination to the Diaconate (for those called to be Deacons not priests) has been streamlined and the educational expectations have been reconfigured so as to focus much more on the practical areas of diaconal ministry. The Commission on Ministry has also fostered a conversation on using a Portfolio of Gifts and Competencies as a model for preparing people to serve as priests in the congregations in which their calls were discerned. This model can also be used for people preparing for the diaconate and for setting goals for continuing education for those who have trained locally for lay and ordained ministries. A Task Force on Licensed Ministries, chaired by the Rev. Dawn-Victoria Mitchell, was formed to address the new categories of licensed (but not ordained) ministries, such as Licensed Preacher, Eucharistic Visitor, Worship Leader and so on. The Task Force is making recommendations on training and continuing education for people in these roles.

The Standing Committee has delegated to the COM the task of awarding grants from the Fund for Theological Education, but

we wish that more funding was available to encourage people to train in Episcopal Seminaries full time. The subcommittees on Continuing Education for Clergy and Lay People award grants funded by the Diocesan Program Budget to help clergy and lay people get education and training. Again, financial constraints have kept us from helping more people develop and strengthen their skills.

The subcommittee on the Ministry of the Baptized, chaired by Mr. Rick Cotner, has begun to imagine ways of strengthening and affirming the ministry of the baptized. They will be coordinating the Diocesan Discernment Conference on February 5, 2005 on this theme and they are the originators of the resolution on the Baptismal Covenant before us at this convention.

Ahead of us in 2005 is the work of developing new guidelines for Clergy Continuing Education. We also continue to seek ways to communicate to people more and more clearly the work of the priesthood and the diaconate and the qualities we seek in those called to ministry as baptized persons, presbyters and deacons.

In all of our work, we network with members of the Standing Committee, Board of Examining Chaplains and the Episcopal School for Ministry. We are aided immeasurably by the work of Ms. Emily Peach, Diocesan Coordinator for Deployment and Discernment.

#### **About Sewanee**

The University of the South, or Sewanee as it is more popularly known, is home to one of the nation's top liberal arts colleges and a seminary of the Episcopal Church. Since its founding, the College of Arts and Sciences at the University has graduated 24 Rhodes Scholars, 34 Watson Fellows, and 24 NCAA Postgraduate Scholars, while the institution's School of Theology has added to its alumni ranks countless bishops, including three of the last four presiding bishops of the Episcopal Church. The University is located atop the Cumberland Plateau between Nashville and Chattanooga, Tennessee. Sewanee's physical environment, which includes a 10,000-acre campus, provides an unparalleled place in which to study and reflect, and has, over its history, become a meeting

place for some of America's most respected literary figures. In addition to its traditionally strong curriculum in the humanities, Sewanee is fast becoming known for its science programs including the unique interdisciplinary Landscape Analysis Laboratory. But, whether a student is interested in arts or sciences, Sewanee provides a challenging, but nurturing environment that helps all achieve their very best.

### **Sewanee's Relationship to the Episcopal Church**

Founded in 1857 by bishops of the Episcopal Church, Sewanee has a long history of pairing academic excellence with reverent concern for the world. Sewanee is the only University in the country with both a college and graduate seminary established by the Episcopal Church and in which the Episcopal Church is actively involved on its governing board. The chancellor of the University is a bishop of an owning diocese, elected to that position for six years by the University Board of Trustees. The current chancellor is the Rt. Rev. Henry N. Parsley Jr. of the Diocese of Alabama. Lay and clergy trustees are elected from the 28 owning dioceses: Alabama, Arkansas, Atlanta, Central Florida, Central Gulf Coast, Dallas, East Carolina, East Tennessee, Florida, Fort Worth, Georgia, Kentucky, Lexington, Louisiana, Mississippi, Missouri, North Carolina, Northwest Texas, South Carolina, Southeast Florida, Southwest Florida, Tennessee, Texas, Upper South Carolina, West Tennessee, West Texas, Western Louisiana, and Western North Carolina.

### **University Financial Aid**

Sewanee consistently ranks as a top value in higher education. The University is committed to providing need-based financial aid, up to 100 percent of demonstrated need. In the 2004-2005 academic year, 60 percent of the undergraduates received some

form of institutional financial aid. Approximately 97 percent of seminarians received financial aid, depending on need and established institutional guidelines. Scholarships in the amount of \$10.4 million were awarded to undergraduates. The University strives to ensure that accepted students can afford a Sewanee education and that seminarians can graduate with as little education-related debt as possible.

### **Student Life**

During the Class of 2004 Commencement services, 315 students graduated from the College of Arts and Sciences and 48 seminarians were awarded master and doctoral degrees. The School of Theology awarded 32 Master of Divinity degrees, 12 Doctor of Ministry degrees, and one Master of Arts in Theology degree. One graduate earned a Diploma in Anglican Studies, and two earned Master of Sacred Theology degrees. This year's distinguished graduates included William Copeland, Ooltewah, Tenn., the first male athlete to be class valedictorian in 35 years and a two-time Academic All-American in track. Robin Rotman, Lake Bluff, Ill., was named a Rhodes Scholar, and Kate Cummings, Asheville, N.C., received a Watson Fellowship. Fulbright Scholarships were awarded to Jennifer Schneider, Nashville, Tenn., O.J. Reuter, Wartrace, Tenn., Neil Veilleux, Jekyll Island, Ga., and Dr. Charles Brockett, professor of political science. The Rev. Dr. John M. Gessell, professor emeritus of the School of Theology, established the Gessell Fellowship in Social Ethics, an annual award that will be given in alternate years to a Sewanee college student and a seminarian. The first recipient was Thomas C. Purdy from the Episcopal Diocese of Central Pennsylvania. The Rev. Dr. Matilda Greene Dunn became the first African American woman to earn her doctorate at the School of Theology. Sewanee students' commitment to service is expressed by the 80 percent of undergraduates who are involved each year in activities ranging from tutoring elementary school students to working as volunteer firefighters to environmental stewardship. Seminarians and faculty organized multicultural mission trips to Uganda, Russia, Romania, and Canada. Throughout the year, the seminary's active Missions Committee offered food, funds, material goods and manual labor to persons in need.

### **Finances and Academic Grants**

Between July 1, 2003 and June 30, 2004, the Sewanee Fund contributed a record \$2,912,829 for a total of \$12.5 million in gifts to the University from gifts and bequests from alumni, parents and friends. Alumni participation rose three percentage points to 47 percent—an achievement that contributes to Sewanee's top tier position in national college and university rankings. Church giving through the Episcopal One Percent Program, an important part of the Sewanee Fund, eases the financial burden for seminarians and their families through tuition assistance. This year contributions from parishes to the seminary came to \$290,830, a decrease from last year's total of \$360,578. In the 2003-2004 fiscal year, Sewanee's endowment grew from just over \$211 million in June 2003 to almost \$239.9 million in June 2004. In part, this growth came from new endowed accounts established by alumni and other friends of the University, gifts that provided resources for new scholarships as well as program and faculty development. The endowment also grew as a result of improvement in capital markets. The



University's strategic plan calls for doubling the endowment in the next 10 years. The University's 2003-2004 unrestricted operating budget was \$54.1 million. Approximately 65% of revenues to the University come from student funded tuition, room and board and fees. Competitive foundation grantors included the Lilly Endowment, the National Science Foundation, the Andrew W. Mellon Foundation, the Alden Trust, the Jessie Ball DuPont Fund, the Freeman Foundation and the Howard Hughes Medical Institute.

### **Faculty and Administration**

The University completed two successful searches for deans for the seminary and college. The Rev. Dr. William S. Stafford, Vice President and associate dean for academic affairs at Virginia Theological Seminary, was appointed dean of the School of Theology and will assume his new position January 1, 2005. Stafford will succeed Dr. Allan M. Parrent, who has served as the interim dean since February 2003. Dr. Rita Smith Kipp, Oden Professor of Anthropology and associate provost at Kenyon College, was named dean of the College of Arts and Sciences. Kipp succeeded Dr. Douglas Seiters, who had served as interim dean since June 2003. Dr. Elizabeth Mansfield, associate professor of art history and chair of the department of art and art history, was named the 2003 Tennessee Professor of the Year by the Carnegie Foundation for the Advancement of Teaching and the Council for Advancement and Support of Education. Mansfield is the second consecutive Sewanee professor to receive this award. Dr. Bran Potter, Snowden Professor of Geology, was the previous recipient.

### **Campus**

Through the generosity of dioceses, parishes and individual donors, the \$5.5 million renovation of All Saints' Chapel was completed, featuring a rebuilt organ, state-of-the-art lighting and sound systems, air conditioning and ventilation, and beautiful liturgical furnishings. The last two of the eight triptych stained glass windows in All Saints' were installed. A window

commemorating the history of the English Church was given by Ellen and William Raymond Stamler Jr., C'56, as a memorial to their parents, William Raymond and Mary Buford Hodges Stamler, and Charles Monroe and Rosalee Werner Boyd. Elizabeth Weaver Proctor donated the second window, commemorating the history of the pre-Reformation church, in honor of her son, William Cheatham Weaver III, C'64. In February 2004, the School of Theology dedicated its new St. Paul's Organ, made possible by a gift from the congregation of St. Paul's Episcopal Church, Chattanooga, Tenn., in honor of their Rector, the Rev. Dr. H. Hunter Huckabay Jr., T'69, T'84, H'00, and his wife, Prestine Crosby through a gift from Donne Bentley Wright of Chattanooga, Tenn., in honor of her parents, Mildred Virginia Haefner Bentley and George Eli Bentley. Ellen and William R. Stamler, C'56, are helping the University renovate Gailor Hall as the new center for language and literature study.

### **School of Theology**

At the beginning of the 2004-2005 academic year, 33 new seminarians were welcomed to the Sewanee campus. The residential student body of 102 represents 43 Episcopal dioceses from across the nation and the Diocese of Huron in the Anglican Church of Canada. The School of Theology's 2004 Advanced Degrees summer program drew 56 students from 14 states, Canada, South Africa and the West Indies. This specially designed academic program stresses the relationship between the practice of ministry and biblical, historical and theological knowledge. The School of Theology's Programs Center offers spiritual growth and leadership opportunities, education at-a-distance, and continuing education for laity, clergy and congregations. Through Education for Ministry (EFM), the Disciples of Christ in Community (DOCC) and the Center for Ministry in Small Churches (CMSC), the Programs Center annually serves more than 10,000 individuals as well as dioceses and congregations.

These financial statements are the responsibility of the Diocese's management. Our responsibility is to express an opinion on these financial statements based on our audit.

**NOTE 1 – NATURE OF ACTIVITIES**

Organized in 1841, the Diocese of Missouri is a not-for-profit organization, comprised of forty-eight Episcopal congregations in the eastern half of Missouri. The Bishop is the presider and Chief Executive Officer of the Diocese. The Episcopal Church in this Diocese acknowledges its allegiance to the Protestant Episcopal Church in the United States of America and submits to the authority of the General Convention. Part of the worldwide Anglican Communion, the Episcopal Church seeks to fulfill Christ's Mission of redemption through active participation in the world through Christ in the Church.

---

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Financial Statement Presentation*

The Diocese reports its information regarding financial position and activities according to three classes of net assets depending upon the existence or nature of any donor-imposed restrictions. The following is a description of these classes of net assets:

**Unrestricted** – Those resources over which the Diocese has discretionary control. Designated amounts represent those resources that the Diocese has set aside for a particular purpose.

**Temporarily Restricted** – Those resources subject to donor-imposed restrictions that will be satisfied by actions of the Diocese or the passage of time.

**Permanently Restricted** – Those resources subject to donor-imposed restrictions that will be maintained permanently by the Diocese. The donors of these resources permit the Diocese to use all or part of the income earned, including capital appreciation, on related investments for unrestricted or temporarily restricted purposes.

*Investments*

Investments, which include those that belong to the Diocese as well as those held on behalf of others (see Note 4), are stated at year-end market values. The realized and unrealized gains or losses on investments have been reflected in the Statement of Activities, except for those held on behalf of others (see Note 4).

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)***Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

*Land and Buildings*

Management has estimated the investment in land and buildings at acquisition cost and depreciates the assets over the estimated useful lives using the straight-line method. It is the policy of the Diocese not to capitalize purchases of personal property but to include these as expenses in the Statement of Activities. The value of personal property owned by the Diocese is deemed to be immaterial in relation to the total assets of the Diocese.

*Income Taxes*

The Diocese is a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code. As such, the Diocese can only be taxed on income from any activities unrelated to its charitable purpose. The Diocese earned no unrelated business taxable income for the year ended December 31, 2004; therefore, the statements do not include any provision for income taxes.

### NOTE 3 – INVESTMENTS (CONTINUED)

The amounts reported as investment gains (losses) in the accompanying financial statements are a result of the following:

- a) The difference in the market values of investments on hand at the beginning of the year as compared to the end of the year.
- b) The difference between the proceeds of sale of investments and the related market values of those investments at December 31 of the previous year.
- c) The difference between the cost of investments purchased during the year and related market value of those investments at December 31, or between the proceeds of the sale of those investments if sold during the respective year.

#### *Permanently Restricted*

*Frank C. and Mattie H. Thompson Memorial Trust ("Thompson Memorial Trust")*  
This trust was created to continue in perpetuity. Income earned by this trust is to be utilized in any manner so designated by the Bishop of the Diocese. The interest and dividends received from this trust are recorded in the Thompson Income Fund as unrestricted, along with the dividend and interest income relating to the investments held by the Thompson Income Fund.

*Kelton E. White and Alma Mayland White Memorial Trust ("White Memorial Trust")*  
In December 1994, the Diocese was named the recipient of income earned by this trust, beginning in 1995. Income received from this trust is restricted as to use for fixed asset additions and repairs and as such will be recorded as temporarily restricted.

*Shank Memorial Trust* - The Diocese is to receive 5% of the net income of this trust as long as the Diocese remains tax-exempt. The income received from this trust is recorded in the Diocesan Program Support Fund.

Realized and unrealized gains and losses on the underlying investments remain in the trusts pursuant to the terms of the trusts and as such are reflected as permanently restricted within the financial statements.

These permanently restricted assets represent funds held in trust by outside fiscal agents for the benefit of the Diocese. The Diocese is not permitted access to the funds held under the terms of the memorial trusts.

---

**NOTE 4 – CUSTODIAL ASSETS**

The Diocese acts as custodian of cash and investments for several of its mission congregations and various organizations within the Diocese. As such, the Diocese records the cash and investments and a corresponding liability. The investment balances are adjusted each year to reflect the current market value associated with those investments. The custodial cash and investment balances included in unrestricted net assets are as follows:

**NOTE 6 – CONCENTRATIONS OF CREDIT AND MARKET RISK**

Financial instruments that potentially subject the Diocese to concentrations of credit and market risk consist principally of cash and investments. The Diocese places substantially all of its cash with major financial institutions. The accounts in those institutions are insured by the Federal Deposit Insurance Corporation (“FDIC”) up to \$100,000. As of December 31, 2004, the cash accounts included approximately \$149,000 of uninsured funds.

The Diocese has a significant amount of investments that are subject to market risk. Market risk is the possibility that future changes in market price may make a financial instrument less valuable.

---

**NOTE 7 – RETIREMENT PLANS**

The Diocese has adopted a 403(b) defined contribution plan for its non-clergy employees and a defined contribution church pension fund for its clergy employees. For the non-clergy employees, the Diocese contributes 10% the participant’s salary to the plan if the participant has at least one year of service and is 21 years of age or older. For the clergy employees, the Diocese contributes 18% of the participant’s salary to the pension fund if the participant is 21 years of age or older. During 2004, the total amount contributed to these plans was \$75,468.

**NOTE 9 – PRIOR PERIOD ADJUSTMENT**

The accompanying financial statements for the fiscal year ended December 31, 2003, have been restated to correct an error in recording the acquisition cost of land and buildings. Net assets at the beginning of the year have been adjusted by \$747,978 for the correction of this error.

In addition, the accompanying financial statements have been adjusted to correct misclassifications between net asset classes for fiscal year ended December 31, 2003. As of December 31, 2003, \$2,724,445 was reclassified from unrestricted net assets to temporarily restricted net assets. Adjustments to correct this error had no effect on total net asset balances.

**NOTES TO FINANCIAL STATEMENTS**

---

**NOTE 1 – ORGANIZATION OF TRUST**

The Diocesan Investment Trust of the Episcopal Diocese of Missouri was organized on April 15, 1959, under the laws of the State of Missouri by a trust agreement. The Trust was established to invest funds in various marketable securities for the Diocese of Missouri - The Episcopal Church (the "Diocese") and its parishes, missions, and other organizations formed under the Diocese. The Trust is held in one or more common Funds, as determined by the Trustees, and is managed by professional investment managers, who are subject to the Trustees' investment policies. "Shares" are purchased and/or redeemed by such numbers as the parishes, missions, and other organizations, in their discretion, may determine.

---

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Investments*

Marketable securities are purchased and maintained in two separate funds as applicable. Investments are carried at market value which is the last reported closing bid price on the last day of the year. The difference between cost and market value is reflected as unrealized appreciation (depreciation) of investments. The Trust records investment transactions on the settlement date.

Realized gains (losses) from such transactions are determined for financial reporting purposes on the identified cost basis. Dividend income is recognized on the ex-dividend date. Interest income is recognized on the accrual basis. Premiums and discounts, if any, on debt instruments purchased are amortized over the lives of the respective securities.

*Income Taxes*

Pursuant to the terms of the Trust documents and the requisite qualifications of its participants, the Trust is covered by the group exemption from federal income taxes under section 501(c)(3) provided to the Diocese of Missouri - The Episcopal Church by the Internal Revenue Service on February 24, 1971. Accordingly, no provision for federal income taxes has been made in the accompanying financial statements.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts disclosed in the financial statements. Actual results could differ from those estimates.

---

**NOTE 3 – DISTRIBUTIONS OF INCOME AND REDEMPTION OF UNITS**

The Trust agreement requires that the net operating income and net realized capital gains (if any) of the Trust, as well as proceeds from the sale, redemption, or maturity of securities (to the extent that the proceeds are not used to redeem units) be credited to unit holders monthly as cash or additional units. The agreement also requires the Trust to redeem units tendered for redemption on the fifth day following the end of the month at a price determined to be the net asset value of each unit as of the last day of the month. The net asset value of each unit shall be determined by ascertaining the market value of the fund on the last day of the month, plus any accrued income and less any accrued expenses, divided by the total number of units outstanding on the date of determination.

**NOTE 5 – FEES AND OTHER TRANSACTIONS WITH AFFILIATES**

The Trust pays a net principal fee, an activity fee, and an issue maintenance fee to Commerce Bank for custodial services. The Trust also pays a quarterly fee to the investment managers, Loomis Sayles & Company, L.P. and Alliance Capital Management, Inc. In 2003, a fee also was paid to Institutional Shareholder Services for consultative work in connection with monitoring the holdings as they relate to socially responsible investing, for proxy analyses, and vote recommendations and vote executions. The accrued fees charged to the Equity Fund are reflected as a reduction of market value.

---

**NOTE 6 – CONCENTRATIONS OF CREDIT AND MARKET RISK**

Financial instruments that potentially subject the Trust to concentrations of credit and market risk consist principally of cash and investments. The Trust has significant amounts of investments that are subject to market risk. Market risk is the possibility that future changes in market price may make a financial instrument less valuable.

---

**NOTE 7 – REALLOCATION OF FUNDS**

During 2003, the Trustees of the Diocesan Investment Trust shifted the asset allocation of the Equity Fund, which increased the number of outstanding units held in the fund. While the total market value of the Diocesan Investment Trust increased during the year, the per unit market value of the Equity Fund decreased due to the increased number of units.
