Consecrated March 6, 2002  
Bishop Coadjutor March 6–June 6, 2002  
Succeeded as Bishop of Missouri June 6, 2002

### Ninth Bishop

The Rt. Rev. Hays Hamilton Rockwell, DD  
Born August 17, 1936  
Consecrated March 2, 1991  
Bishop Coadjutor 1991–1993  
Succeeded as Bishop of Missouri January 21, 1993  
Retired June 6, 2002

### Eighth Bishop

The Rt. Rev. William Augustus Jones Jr., DD  
Born January 24, 1927  
Consecrated Bishop of Missouri May 3, 1975  
Retired January 21, 1993

### Seventh Bishop

The Rt. Rev. George Leslie Cadigan, DD  
Born April 12, 1910  
Consecrated April 16, 1959  
Succeeded as Bishop of Missouri May 15, 1959  
Retired April 16, 1975  
Died December 14, 2005

### Sixth Bishop

The Rt. Rev. Arthur Carl Lichtenberger,  
DD, STD, LLD, LHD, DCL, JCD  
Born January 8, 1900  
Consecrated April 5, 1951  
Bishop Coadjutor 1951–1952  
Succeeded as Bishop of Missouri, November 1, 1952  
Elected Presiding Bishop October 11, 1958  
Assumed Duties of Presiding Bishop November 15, 1958  
Resigned as Bishop of Missouri May 15, 1959  
Retired as Presiding Bishop October 12, 1964  
Died September 3, 1968

### Fifth Bishop

The Rt. Rev. William Scarlett, DD, LLD  
Born October 3, 1883  
Consecrated May 6, 1930  
Bishop Coadjutor 1930–1933  
Succeeded as Bishop of Missouri November 8, 1933  
Retired November 1, 1952  
Died March 28, 1973

The Rt. Rev. Frederick Foote Johnson, DD  
Born April 23, 1866  
Consecrated November 2, 1905  
Bishop of South Dakota, 1905–1911  
Bishop Coadjutor of Missouri 1912–1923  
Succeeded as Bishop of Missouri April 17, 1923  
Retired November 8, 1933; Died May 9, 1943

### Third Bishop

The Rt. Rev. Daniel Sylvester Tuttle,  
DD, STD, DCL, LLD  
Born January 26, 1837  
Consecrated Missionary Bishop May 1, 1867  
Bishop of Missouri August 9, 1886  
Succeeded as Presiding Bishop September 7, 1903  
Died April 17, 1923

LLD  
Born March 2, 1835  
Consecrated October 25, 1868  
Died May 1, 1886

### First Bishop

Died April 18, 1868

### Missionary Bishop

The Rt. Rev. Jackson Kemper, DD, LLD  
Born December 24, 1789  
Consecrated Missionary Bishop September 25, 1835  
Translated to Wisconsin in 1854  
Died May 24, 1870

### Rules of Order as adopted by the 173<sup>rd</sup> Convention

1. The Presiding Officer shall appoint members of Permanent Committees at each Meeting of Convention.

2. All resolutions from the floor shall be reduced to writing, presented to the Secretary, and read to Convention. A resolution from the floor that is not a part of a committee report may be introduced only at the time indicated in the Order of Business. All resolutions from the floor, whether or not a part of a committee report, after receiving a short explanation from the presenter, must receive a 2/3 majority vote of Convention before it may be considered by Convention.

3. When any member speaks to Convention, he shall address himself to the Presiding Officer, state his name and church, and confine himself to the point in debate.

4. A member, other than the Chairman of the Committee whose report is under consideration, shall not speak more than twice in the same debate, nor longer than five minutes at a time, without leave of the House.

5. Any member of the House may call for a vote by hands or standing vote. Every member who may be in the House when such a vote is called shall be counted unless he/she be excused by Convention.

6. When a question has once been determined it shall stand as the judgment of the House, and shall not again be drawn into debate except on motion of reconsideration which must be made by a member who had previously voted in the majority.

7. All questions of parliamentary law not resolved by reference to the Canons or these General Rules shall be decided under Robert's Rules of Order.

8. All questions of order shall be decided in the first instance by the Presiding Officer, without debate; an appeal may be made to Convention by any member.

9. The reports of all Committees shall be in writing, and shall be received without motion for acceptance, unless recommitted by a vote of the House. All reports recommending or requiring any action or expression of opinion by the House shall be accompanied by a resolution for the action of the House thereon. All annual reports shall be received and filed by the Secretary as presented before or during Convention, and may be called upon motion to be read and considered at any time during Convention.

10. The names of movers of resolutions shall appear in the minutes of Convention.

11. All motions and resolutions requiring reference shall be referred, so far as possible, to the Permanent Committees of Convention.

12. Except in cases where majority vote is required, all elections shall be by Preferential Aggregate Transfer Ballot:

a) Each elector shall mark his or her ballot by numbering the names of all the candidates for each office in order of preference, with the preferred name being numbered 1. The elector shall not give more than one number to any name, nor shall any name be left unnumbered. Any ballot which does not comply with the directions given in this section will be invalid and will not be counted.

b) The persons appointed by the Presiding Officer to conduct the election shall count each valid ballot by assigning to each candidate that candidate's rank-ordered number on the ballot.

c) The candidates shall then be ranked according to the respective sums of their rank-ordered numbers, beginning with the lowest sum, and the candidate or candidates with the lowest sums shall be elected, according to the number of vacancies to be filled.

d) In case of a tie in which one or more candidates must be selected, that candidate or candidates with the highest number of first-place ballots shall be elected; and if the tied candidates have the same number of first place ballots, then the candidate or candidates having the highest number of second place ballots shall be elected, and so forth; and if the tied candidates have the same number of ballots at every rank, then the candidate or candidates to be elected shall be chosen by the toss of a coin.

13. The Presiding Officer may, having left the chair, enter into the debate on any question, but shall not then resume the chair until the main motion under consideration has been disposed of.

14. Once the Order of Business has been approved it may not be altered except by 2/3 majority vote of Convention, provided that the Presiding Officer may reorder agenda items at any time.

#### **Minimum Clergy Compensation**

*Submitted on behalf of the Diocesan Council*

1. **BE IT RESOLVED** that this 173rd Convention of the Episcopal Diocese of Missouri set the annual standard base compensation for full-time clergy in 2013 as follows:  
CASH SALARY & HOUSING ALLOWANCE \$56,650  
[The actual compensation should be determined by Resolution of the Vestry/Bishop's Committee, in consultation with the clergy.]
2. **BE IT FURTHER RESOLVED** that the Church Pension Fund assessment will be paid by the congregation;
3. **BE IT FURTHER RESOLVED** that \$50,000 group life will be paid by the congregation;
4. **BE IT FURTHER RESOLVED** that the medical coverage for clergy be in compliance with Diocesan Resolution A-172;
5. **BE IT FURTHER RESOLVED** that a standard of ten days per calendar year and \$500 will be provided for continuing education;
6. **BE IT FURTHER RESOLVED** that the standard auto allowance will be \$2,000 per year;
7. **BE IT FURTHER RESOLVED** that all parishes and missions encourage their full-time clergy to set aside the equivalent of two days each week for personal time, 24 hours of which must be consecutive;
8. **BE IT FURTHER RESOLVED** that all parishes and missions be strongly encouraged to provide dental insurance for clergy and eligible dependents, or be assured they already have such coverage; and
9. **BE IT FURTHER RESOLVED** that the Clergy in Charge shall accrue two weeks of sabbatical time for each year of service.

#### **RATIONALE**

1. 2012 cash salary plus housing allowance was \$55,370. The recommendation for 2013 reflects a 2.3% increase. This increase is based on the Bureau of Labor Statistics, Consumer Price Index - Midwest Urban Consumers first half of 2011 comparison to the first half of 2012.
2. The Canons of the Episcopal Church mandate that pension assessments be paid by congregations (assessment = 18 percent of cash salary plus housing and utilities allowance).

3. Provides for \$50,000 of term life insurance for active clergy. (In addition, all active clergy are eligible to receive an additional term life insurance benefit from the Church Pension Fund equal to four times total compensation to a maximum of \$100,000).

### **A-172 Implementation of Health Plan**

*Submitted by Diocesan Council*

*as passed by the 172nd Diocesan Convention*

1. BE IT RESOLVED that this 172nd Convention of the Episcopal Diocese of Missouri require Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop to pay 100% of the cost of individual health insurance coverage (selected from the offerings included in the Denominational Health Plan and administered by the Episcopal Church Medical Trust) for all lay and ordained employees working 1,500 or more hours annually, in accordance with Title I, Canon 8 of the Episcopal Church and to be implemented no later than January 1, 2013;
2. BE IT FURTHER RESOLVED that Lay and ordained employees of the Episcopal Diocese of Missouri and the Offices of the Bishop eligible for required individual health insurance coverage under Section 1 of this resolution may elect not to participate in the Denominational Health Plan if they have access to coverage through other approved sources, e.g. Medicare, Tricare, a former employer, or a spouse's or domestic partner's health insurance plan;
3. BE IT FURTHER RESOLVED that Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop shall not reduce existing coverage or increase the cost of existing coverage to employees to comply with A177 or this resolution;
4. BE IT FURTHER RESOLVED that benefit design and premium support parity is required within each congregation of the Episcopal Diocese of Missouri and the Offices of the Bishop in the provision of health insurance coverage for lay and ordained employees;
5. BE IT FURTHER RESOLVED each congregation and the Offices of the Bishop may impose a monthly premium surcharge or incentive to lay and ordained employees who elect coverage for a spouse, domestic partner, or dependent who is eligible for comparable employer-sponsored health insurance (other than the Denominational Health Plan) through an alternate source;
6. BE IT FURTHER RESOLVED that Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop are encouraged, if financially possible, to exceed the minimum standard of health insurance coverage for their lay and ordained employees; and
7. BE IT FURTHER RESOLVED that schools, day care facilities and other congregational and diocesan institutions, regardless of the independence of their incorporation or tax status, are encouraged to adopt the principles articulated in this resolution.
5. Congregations are encouraged to provide both time and financial resources to assist clergy with continuing education opportunities.
6. Standard allowance for auto expense.
7. Congregations are urged to encourage their clergy to take two days of personal time in the manner stated above.
8. A list of dental plans can be obtained from the Office of the Bishop.
9. Per standard clergy letter of agreement.

**This resolution establishes a standard base compensation for clergy. Congregations are urged and invited to compensate clergy beyond the standard. It is understood that under individual circumstances and conditions internal adjustments in the compensation package may be negotiated.**

  - seek to change bystander behavior into ally behavior
  - create partnerships between youth and adults
  - provide intervention and treatment for those who exhibit bullying behavior; and
4. **BE IT FURTHER RESOLVED** that bullying is defined as the recurring use of single or combined written, verbal or electronic expressions or physical acts or gestures, directed at any person that: result in physical or emotional harm to the person or damage to his/her property; places the person in reasonable fear of harm to him/herself or of damage to her/his property; creates an intimidating or hostile environment for the person; and/or impacts the rights of the victim. Bullying shall include cyber-bullying through electronic/social media, telephonic technology or other means; and
5. **BE IT FURTHER RESOLVED** that Convention encourage each congregation to report its progress to its Convocation.

**RATIONALE**

The Episcopal Church calls for a church wide response to the epidemic of bullying, particularly of those perceived as being "different" by virtue of economic, ethnic, racial or physical characteristics, religious status, sexual orientation, gender identity or gender expression

This resolution offers a way for our Diocese to respond to this call by learning about and addressing the issues involved at a local level, where it can make the most difference.

#### RATIONALE

Statement of Anticipated Expense – Captioning software can be used for free, but there is work involved. On-line sites enable the captioning of video posted to YouTube, Google Video and similar sites and work with some formats, such as QuickTime, MP4 and HTML5. Captioning does require the additional work of typing in, editing, and synching the captions with the soundtrack.

TV interviews can be captioned for free, though it is necessary to request this service and remind the reporter about it.

1. **BE IT RESOLVED** that this 173rd Convention of the Episcopal Diocese of Missouri request elected and appointed committees, commissions, boards, and task forces of the Diocese to examine barriers that may pose an obstacle to prevent members of the Diocese from fully participating in their work and meetings in light of resolution A096 of the 2012 General Convention; and,
2. **BE IT FURTHER RESOLVED** that they report their findings to the Diocesan Council, which in turn is asked to provide a summary of their findings to the 174th Diocesan Convention, with recommendations to expand participation in Diocesan bodies.

#### RATIONALE

Resolution A096, passed by the 2012 General Convention of the Episcopal Church, reads in full:

*Resolved*, the House of Deputies concurring, That dioceses and congregations explore creative ways to reduce barriers to participation in Church leadership and governance, which barriers may include time away from home or employment, or the need to care for family members.

It is in the best interest of our diocese for our governance and ministries to reflect the full diversity of the Church. To encourage more diverse participation, this resolution urges diocesan bodies to recognize barriers that exist and to seek creative ways to overcome them. Gifted lay members of the diocese decline service on our diocesan bodies because of the

meeting schedules. Members living far from St. Louis find the time and travel expenses to be prohibitive. Single parents cannot serve because no childcare is provided in some diocesan meetings. A few meeting venues lack accessibility to handicapped persons. Many people decline service on elective or volunteer bodies because of such obstacles. We might become more truly inclusive if each diocesan body would consider how it could make its meetings more accessible to all the members of the diocese.

The resolution carried unanimously.

**E-173****Diocesan Commission on Ministry**

1. **BE IT RESOLVED** that Canon III.14, Section 2 and Section 3 be amended as follows:

CANON III.14 The Diocesan Commission on Ministry

SECTION 1. Pursuant to the Canons of General Convention there shall be a Diocesan Commission on the Ministry, with such duties as may be assigned by Convention or the Bishop.

SEC. 2. The Commission shall be composed of ~~no fewer than six nor more than fifteen persons, at least one third of whom shall be Priests canonically resident in this Diocese and at least one third of whom~~ four (4) clerical members canonically resident and physically domiciled in this Diocese, at least one of whom shall be a Deacon, and four (4) lay members who shall be lay Confirmed Communicants in good standing. Members shall be appointed by the Bishop with the consent of Convention for terms of four (4) years. The terms of the members shall be staggered so that the term of one member in each order shall expire at each annual meeting of the Convention. A member who completes a full term of four (4) years may not be re-appointed until the person has been off the Commission for at least one (1) year. Should a vacancy occur between annual meetings of the Convention, it may be filled for the remainder of the term by appointment of the Bishop and confirmation by the Standing Committee. and shall hold office until their successors are so appointed.

~~SEC. 3. The Commission may appoint from time to time, with the approval of the Bishop, any persons it may need to assist in the performance of its duties. They shall serve at the pleasure of the Commission.~~

**AND BE IT FURTHER RESOLVED** that, upon approval of this resolution, the Bishop shall choose a method that will initially establish the staggered terms of each of the eight (8) members.

**RATIONALE**

The two diocesan entities that have a canonical role in the ordination process are the Standing Committee and the Commission on Ministry. The Standing Committee consists of six (6) clergy and six (6) lay members, each serving a four (4) year term. The Commission on Ministry in this diocese

has grown to a membership of fifteen (15), and some members have served uninterrupted terms in excess of twelve (12) years. This is an unwieldy number of members.

Furthermore, if the resolution is approved, the new term limit of four (4) years will help ensure that new members with new perspectives on the needs of ministry in the diocese can be appointed to serve. The Standing Committee in this diocese already has a similar term limit as proposed in this resolution.

Additionally, the author of this resolution, in the course of assembling a Directory of Diocesan Schools for Ministry, researched the size, composition, and length of terms of members of the Commissions on Ministry in the 100 domestic dioceses of the Episcopal Church and learned that, with very few exceptions, most Commissions have the number of members and the length of terms as proposed by the resolution.

The recommended deletion of Section 3 certainly will not prevent the Commission from consulting from time to time with persons outside the Commission when their expertise is needed. However, these persons should not be a part of the Commission's deliberations, and it is not necessary for the Commission to appoint these persons as members of the Commission. Except when it is necessary for the Bishop and Standing Committee to fill a vacant slot, members of the Commission should be approved by the elected delegates of the Convention.

Tom Gross, Christ Church Cathedral, moved amendment to remove words "and physically domiciled".

The amendment carried but not unanimously.

The Rev. Joseph Chambers then moved to increase the membership of the Commission on Ministry to six clerical and six lay members.

The Rev. Knute Jacobsen then moved to refer the motion to the Committee on Constitution and Canons. This motion was carried by majority vote.

**Bishop Wayne Smith's Address to Convention**

Henry Martyn Robert was a brevet brigadier in the U. S. Army during the Civil War. He was obviously adept at commanding soldiers. But a church meeting was another thing entirely. War was easier.

It was from his frustration with church meetings that General Robert began to develop his Rules, the same we adopted for the meeting of Diocesan Convention: Robert's Rules of Order. We have these rules because a war veteran found church meetings difficult.

You have heard me say that the Church in legislative session is not the Church at its best. Last night (Friday's Ordination and Eucharist on Nov. 16) at Calvary Church comes pretty close to the Church at our best: Gathered with all the baptized, with bishops, priests, and deacons, everyone taking a place. Gathered to make more deacons, but most of all gathered to make Eucharist.

My dream for our time together in Convention is to take some of the energy and joy from those moments into our annual gatherings. And we hear your feedback, that you want more time to be together. I want that too and we can decide for this to happen. I say let's do it.

We will still need to fulfill basic canonical responsibilities in legislative session, and I will trust the chancellor, Standing Committee, Council, and others to help identify these. Legislative session is not bad, and I am grateful to General Robert for acting on his frustration and developing rules.

If we exercise self-discipline, we can keep resolutions to a minimum. If we use the convocations as they are intended, we can allow much of the deliberations to occur. If we do all these things, then we can use our time together in Convention to be with one another over the things that matter to us, and to do so in less formal settings.

Other dioceses have chosen this route, and we in Missouri can surely learn from them. To this end, of having a different sort of convention, I will appoint a task-force to study the possibilities and make recommendations to me, to the Secretary of Convention, and to the Standing Committee no later than July 1, 2013. I am planning for a different kind of convention.

In familiar venues like Lui Diocese in South Sudan, new venues like Old North St. Louis, and

in many locales around our congregations—the work of mission progresses. We in this diocese are privileged to join in God's mission, and to have so many opportunities.

Sometimes there is a false dichotomy imposed between the categories of spirituality and mission—that the one is for monkish introverts and the other for activists. I learned from my teacher Kenneth Leech, and from the writings of Thomas Merton, Dorothy Day, and William Temple that mission and the spiritual life are a package deal.

For the religion of the incarnation, a more robust spiritual life does not result in mere quietism. It becomes the energy for mission. And no one can adequately engage God's mission, without a grounding in the liturgy and in prayer. It is absolutely crucial for the work that I do. Mission, in turn, deepens our sense of life with God—a spiritual life. These pieces of the Christian life make a beautiful feedback loop of grace. And a package deal.

The model for the Deaconess Anne House in the neighborhood of Old North St. Louis explicitly builds on this understanding of the convergence of mission and spirituality. The setting is an intentional Christian community that will house five or so interns beginning next year, in a neighborhood where there is a lot of material need. It's a design for young adults who want something more and something deeper. More and deeper sense of purpose, more and deeper awareness of God, more and deeper clarity of calling. More and deeper experience in the city, and maybe even in the Church.

This will be a house for the interns, and for us, as we explore God's mission and seek a spiritual life—in that desired unity between these two realities. We have heard Jonathan Stratton's report. I like what I hear.

One more time we are sending off a team of missionaries to Lui Diocese. The Bible scholar Phyllis Tribble grew up, as did I, in the Southern Baptist Churches. I heard her say once that the most dangerous people among Southern Baptists are returned missionaries. That is an out-of-fashion word, but, oh my, is she right. People who have visited another part of the world and have seen what God is doing there and witnessed how God's

heart is breaking are dangerous people when they come home. They are dangerous to the status quo, dangerous because of their own conversion. For a century and more they have provided great tonic for Baptist Churches all throughout the American South.

These six missionaries from our Diocese heading to Lui in a couple of weeks are blessed with the opportunity to step into God's mission in South Sudan. By knowing them, we are all of us blessed.

Returned missionaries are some of the best things I remember from my Baptist childhood. There were three of them, all women, in the little farming-community church where I grew up. They were great leaven for the rest of us. So will these missionaries to Lui be for us.

As approved by the General Convention last summer in Indianapolis, there are about two hundred pages of materials forwarded to the rest of the church—Bible studies, theological resources, study guides for congregations, pastoral practices, and the rites themselves. The enabling resolution allows the implementation of these rites in a diocese with the bishop's permission, and under his or her direction. I have decided to permit their use in congregations who are willing to prepare for them, through a season of prayer, study, and discernment. This decision is cause for joy and excitement for many, and consternation or dismay for others. I understand both responses.

Let me tell briefly how my own position on matters of human sexuality has changed. Or rather it is not so much that my position has changed, but the context in which I express my position has shifted markedly. My purpose has been, and still is, to work for the full inclusion of the faithful gay men and lesbians in our church, while at the same time maintaining the highest degree of communion possible within our common life and with the rest of the Anglican world. That is the constant. We are, I think, at that highest possible degree of communion possible, right now. It is not likely to get much better or much worse.

There was a time early in my episcopate when it looked like the choice was either inclusion or communion. It looked binary, with no gradations between these two poles, and it looked as if it might be that way for a long time. The season after

General Convention in 2003 was fractious, to say the least. Now, however, it looks like both inclusion and communion are available to us, at least provisionally. There are still issues of maintaining unity both in our common life in this diocese and in the lives of many of our congregations. I know this. And we must keep an eye on the horizon of the Anglican Communion.

But things are also changing, and changing much more quickly than I could have imagined. In the eighteen months following General Convention in 2003, for example, issues of human sexuality took over my life. Letters, phone calls, meetings, and email. Oh my, the email.

After Mary Glasspool's election and consent to become bishop suffragan in Los Angeles in 2010, only seven years later, I got exactly one email. One. No one even took the trouble to ask me if I gave consent, or not. Something had shifted.

The season of change that I thought would take my entire episcopate, or longer, has been foreshortened. Not completed. Not over and done. But something has changed. The Anglican Communion remains fractured; or, that is not quite the way to say it best. My friend and colleague Ian Douglas, the Bishop of Connecticut, puts it this way: The Anglican Communion is in the process of inventing itself, and asking harder questions about what it means to belong to one another than we have ever before asked. It seems to me that this process of invention is messy and chaotic. Be that as it may, the Episcopal Church has a place at the table and will play a part in whatever the new shape of the Communion will be.

For all of us: I am glad that we remain part of the worldwide Anglican Communion. Belonging to one another—even when we think that we do not—still matters, if God through Jesus Christ is working for the salvation of a whole world. For the faithful gay men and lesbians among us: I am glad for you, and glad for many of us, your straight allies, that we have come to this moment together.

At our Diocesan Convention five years ago we started a painful process of building a responsible budget, and we have continued in that process through the succeeding years. You will receive a balanced budget for your consideration later this morning. The process is not so painful at this juncture. My staff, our treasurer, and Diocesan Council

have taken ownership for responsible budgeting and I am more than grateful for their leadership and diligent work. This manner of budgeting is close to becoming just what we do. There are good payoffs for these choices. Council does not have to spend hours of handwringing, readjusting our spending on the fly. Council meetings are lighter and more creative, as a result.

Another payoff is this. There is no way in the world that we could have undertaken the initiative in Old North Saint Louis apart from the practices of responsible budgeting. We have money available for mission that we would not have had otherwise. And these practices have also made it possible to fund a half-time youth missionary beginning in 2013. He or she will coordinate and plan diocesan events, develop good communications for parishes and youth, and strengthen networks of youth ministries in our diocese. We need this position. We could not have afforded it under previous financial practices. These are

some of the payoffs for the hard work that we have undertaken.

As a diocese, at our best, we are more than a compilation of separate functions—even important ones like what I have just been talking about. At our best, we are more than the mere sum of the individual parts. As I travel from the boot-heel to the Iowa border, from the Mississippi River to Highway 63, I get glimpses of the grace that God pours into the lives of our congregations and ministries here. I get to witness and hear about the desire to belong more to one another; the yearning to participate in what God is doing in the world; the longing to know and be known by God; a hunger for the Eucharist and all that it means.

I love you, the people of this diocese. What God is asking from us is hard but always interesting—but even that, I am learning to love. For the sake of Jesus, risen from the dead. And for the life of the world.

Right Reverend Bishop Smith, Right Reverend Bishop Field, Council Members and Delegates: I am pleased to present the 2012 Report of the Corporation of the Episcopal Diocese of Missouri, Diocesan Council:

In 2012, Council:

- Supported the Bishop in his decision to maintain communication with Bishop Stephen as the Diocese of Lui went through turmoil.
- Reviewed and approved more than \$11,500 in Aged & Infirm Clergy Fund requests to support our clergy with much needed funds for medical issues.
- Elected Ms. Chris Clark and Mr. Jim Brigham to serve two-year terms as co-Trustees of the Diocesan Investment Trust.
- Granted \$30,850 from the Church Assistance Endowment Fund to the following parishes: Calvary, Columbia; Advent, Crestwood; St. Francis, Eureka; All Saints, Farmington; St. Barnabas, Florissant; St. Paul's, Ironton, Transfiguration, Lake St. Louis; St. Mark's, Portland; St. Paul's, Sikeston, and St. Mark's, St. Louis. A special thanks to Jerry Martin, Jeff Klieve and Vicki Myers for refining the guidelines used in considering applicants for the Church Assistance Endowment Fund.
- Approved \$19,500 in Making All Things New requests for the following parishes: All Saints, St. Louis in the amount of \$4,500; Christ Church, Cape Girardeau, in the amount of \$6,000, and Good Shepard, Town and Country, in the amount of \$9,000. Council wishes these parishes continued success in their mission.
- Approved approximately \$19,000 in grants for the New Ventures in Community Ministry program. The Council hopes these funds will assist the parishes in their community outreach efforts.
- Formed the Congregation Audit Process team, which consists of Bishop Smith, Harry Leip, Simone Camp and Jim Furgason.
- Worked industriously to ensure that the 2012 and 2013 Diocesan budgets were thoroughly vetted and submitted to Convention in a timely fashion. Council thanks Tom Hedrick, Desire Viliocco and their team for their hard work and dedication to this task.
- Provided prayerful support to Tom Hedrick and Desire Viliocco in their quest to find a new financial investment manager for the Diocese's portfolio.
- Worked with Bishop Smith to fund a three-quarter time Youth Missioner position for the Diocese. Council appreciates the endeavors of Council members Susan Naylor, Suzanne Wolfenbarger, Rev. Amy Chambers Cortright and Lawrence Hopen in formulating an objective and job description for this new position.
- Approved the withdrawal of up to \$250,000 from the Future Mission/Property Fund for use in purchasing and renovating a home in Old North St. Louis for the Deaconess Anne House.
- Supported the Bishop, the Old North St. Louis Initiative Steering Committee and the Bishop's staff in successfully launching the Deaconess Anne House in Old North St. Louis with Jon Stratton at its helm as the Director. Council is excited and looks forward

to seeing the good and Godly works that Jon will achieve.

### Community of Hope

The Community of Hope (COH) is "a school for God's service" (Prologue, Rule of Benedict). The mission of COH is to help create and sustain Christian communities of volunteer lay pastoral caregivers united in prayer; shaped by Benedictine spirituality; and equipped for and serving in pastoral care ministries. The initial training program of 14 modules is taught by guest lecturers with expertise in particular areas of pastoral ministry and includes practice pastoral visits. Training is offered approximately every two years in one of the three centers in the diocese. Those successfully completing the training are commissioned as lay chaplains and members of The Community of Hope during a Sunday morning Eucharist. After commissioning, chaplains gather monthly in small Circles of Care. These times of togetherness and quarterly meetings with the diocesan COH community offer worship, continuing education, encouragement, and spiritual nurture. This community life is shaped by the principles found in The Rule of Benedict and its commentary by Sister Joan Chittister.

Community members work toward balance and harmony in prayer, worship, silence, holy reading, and serving others through pastoral care ministry. Our lay chaplains provide a ministry of presence, visiting people in homes, hospitals, nursing facilities, shelters, jails, and prisons.

COH training centers are located at The Church of St. Michael and St. George (where Mary Bredenberg organized the first training class in our diocese in 2001 and fostered the

growth of COH when it became a diocesan program), Christ Church Cathedral, and Grace Church in Kirkwood. Trainees represent many Episcopal parishes and other congregations in the St. Louis area. Our diocesan

### Companion Diocese Committee

The Companion Diocese Committee is a group of people who feel a strong commitment to be in relationship with the Diocese of Lui, South Sudan. This relationship was formalized in April 2006 and a covenant agreement was signed by the Diocese of Missouri and the Diocese of Lui, Episcopal Church of Sudan. In November 2011 we welcomed Bishop Stephen Dokolo and his wife Lillian Clement to Missouri. They attended the 172nd Convention which renewed our covenant relationship for another five years.

We have sent 30 missionaries to Lui from the diocese since 2003 and 14 people have made multiple trips. This past year we were disappointed that visas were denied to four Moru brothers and sisters, members of the Diocese of Lui who had planned to travel to Missouri for four weeks. In November 2012 we will send a new team to Lui. This team will consist of all new missionaries to Lui except for the coordinator, Canon to the Ordinary Dan Smith. We continue our partnerships with Diocese of Lund, the Lutheran Church of Sweden and Blackmore Vale Deanery, Diocese of Salisbury, Church of England. Accompanying will be two missionaries from Blackmore Vale and two from the Diocese of Lund. All news about the trips is posted on the mission blog: LuiNetwork.dioocesemo.org.

The Companion Diocese Committee had a year of extreme highs and lows in terms of emotions. We started the year with excitement with the visit from Bishop Stephen Dokolo and his wife Lillian Clement. They attended the 172 Diocesan Convention along with Mrs. Anne Powell from Blackmore Vale, England. Bishop Stephen, Lillian and Anne addressed the convention in St. Louis and were present when the Diocese of Missouri voted to renew its companion relationship with Lui, South Sudan, for another five years.

Bishop Stephen and Lillian visited for four weeks and stayed with Bishop Wayne and Debbie Smith. During their stay they traveled extensively within the diocese renewing friendships made by Stephen when he attended school at Eden Seminary, St. Louis. Bishop Stephen and Lillian attended Sunday visitations with Bishop Smith, attended a clergy day, a Companion Diocese Committee meeting, visited with students at Eden Seminary and Mary Institute/Country Day School, and a St. Louis Juvenile Detention

Center. Bishop Stephen celebrated Eucharist, preached, attended adult forums, pot luck dinners, Advent Lesson and Carols, social gatherings and shared dinner in many homes around the diocese. Both Stephen and Lillian traveled to tourist attractions and visited different several farms (including one century farm) in the diocese.

With the help of Beth Felice, diocesan communications director, and other CDC members, Stephen and Lillian were able to help construct a timeline of the history of the companion relationship, along with a map of Lui, South Sudan. The timeline is posted on the LuiNetwork blog shared by the partners in the companion relationship.

At the beginning of the year we were saddened and deeply hurt by Archbishop Daniel Deng Bull Yak's comments on human sexuality and his disregard of a full inclusive church for all baptized Christians including GLBTQ Christians.

We are equally upset that during the House of Bishops the Episcopal Church of Sudan (ECS) disinvited Presiding Bishop Katharine Jefferts Schori to visit and wrote they recognized "the Anglican Church in North America (ACNA) as the true and faithful Orthodox Church."

We continue to recognize that there are major differences and hurt between ECS and the Episcopal Church but are determined to be faithful to our covenant agreement, even as we work towards a fully inclusive church. The companion relationship we share with Lui, South Sudan, Diocese of Salisbury, in Blackmore Vale, U.K. and Diocese of Lund, Sweden, are important to us and require continued prayer and faithful witness.

Another low point came when four Moru missionaries were not granted visas to travel to the Diocese of Missouri from Lui, South Sudan. We had expected to host four guests from Lui to mirror their counterparts in our diocese, attend workshops, and participate in the life of the church.

After several months of planning word came that the missionaries who had traveled to Nairobi, Kenya, were denied visas to travel to the United States and were returning to South Sudan. Disappointment was shared by our Moru brothers and sisters along with people within our diocese who had anticipated their arrival and planned for months of worship, work, and study together.

During the Spring our partners from Blackmore Vale coordinated a mission trip to Lui primarily to work with the new pre-school being established on the Cathedral grounds. The Rev. Susan Naylor joined this trip as the medic for the mission team. This trip proved to be very successful and laid some groundwork for future trips.

Debbie Smith and I attended General Convention in Indianapolis, Indiana. We worked the American Friends of the Episcopal Church of Sudan (AFRECS) booth in the Convention Center. We attended a luncheon and celebrated the first anniversary of independence of the Republic of South Sudan. AFRECS continues to support peacemaking in areas where violence continues to erupt especially near the border and in the Nuba Mountains. AFRECS advocates for peace in Sudan and desires to help Sudanese bishops to partner with Episcopal diocese and parishes.

Debbie and I answered questions, sold baskets and note cards that we brought with us from Missouri. The baskets came from the Mothers' Union in Lui along with colorful note cards. The designs for the note cards came from the childrens' art project mission trip in 2009. We have continued to sell baskets and note cards at various diocesan events including General Convention reporting sessions, the Mak-

ing Disciples Conference, various churches in the diocese and the annual meeting of the ECW.

Late in November the Diocese of Missouri will coordinate a mission trip to Lui. There will be three primary focuses for this trip. 1. To teach a group of young adults basic carpentry skills and brick laying skills. 2. Continue to work with the pre-school program. 3. On going work with the Diocese of Lui in terms of communication, accountability and computer skills. Two missionaries from Blackmore Vale will be part of the team.

This year we will continue to share information about Lui to congregations and to work with fundraising opportunities within the Diocese of Missouri. CDC hopes to continue to sell baskets and Lui note cards at diocesan events.

The proceeds from the sale of the cards support education and health care and the sale of the baskets will go to the work of the Mothers' Union.

Finally, I would like to thank Debbie Smith for her work on the Companion Diocese Committee. Debbie's leadership and vision has supported the work of the committee and what we have been able to accomplish in this relationship.

Debbie has served in different leadership roles while on the CDC including coordinator of mission trips. I am grateful for her work and passion for the people of South Sudan and sad to see her stepping down.

### Order of the Daughters of the King

The Order of the Daughters of the King® (DOK) is a spiritual sisterhood of women dedicated to a life of prayer, service, and evangelism. We have made a commitment to Jesus as our Savior, and we follow Him as Lord of our lives.

We are an Order for women who are communicants of the Episcopal Church, churches in communion with TEC, or churches in the historic Episcopate. Today our membership includes women in the Anglican, Episcopal, Lutheran (ELCA) and Roman Catholic church. An Order is a community under a religious rule; especially one requiring members to take solemn vows. We don't just enroll as members and attend meetings; we take life-long vows to follow the Rule of Prayer and Rule of Service.

A Rule is a prescribed guide for conduct or action by laws or regulations prescribed by the founder of a religious order for observance by its members.

The Order of the Daughters of the King was founded in 1885 by Margaret J. Franklin at the Church of the Holy Sepulcher in New York City. Members of the Order undertake a Rule of Life, incorporating the Rule of Prayer and Service. By reaffirmation of the promises made at Baptism and Confirmation, a Daughter pledges herself to a life-long program of prayer, service and evangelism, dedicated to the spread of Christ's Kingdom and the strengthening of the spiritual life of her parish.

Daughters of the King chapters, and Junior Daughters of the King Chapters exist in the United States and in Countries all of the Anglican Community. Currently, there are over 3,000 members outside of the U.S. Chapters. They are in Brazil, Cuba, Dominican Republic, Ghana, Haiti, Honduras, India, Israel, Kenya, Malawi, Nigeria, Puerto Rico, South Africa, and Trinidad & Tobago.

The Missouri Diocese has 40 members in 5 chapters.

Current Diocesan officers include Kathy Alexander, President. This year Missouri Daughters will maintain a prayer presence for diocesan convention, both in the chapel set up at convention site in Columbia, and around the diocese.

Missouri daughters will also set up the chapel and pray for the provincial meeting of the Episcopal Church Women in Chesterfield in April 2013.

### Dismantling Racism Commission

Vision: As people living out our Baptismal covenant, we see our diocese reconciled to God by challenging racism in ourselves and society.

Mission: To dismantle racism through education, dialogue and action.

The Commission on Dismantling Racism is charged by the National Church and the Diocese of Missouri to promote racial justice in the Episcopal Church. The Commission expects to realize this result by working toward the above stated vision and mission statements. To fulfill this charge, the Commission has divided its work into four major goals areas:

- Goal 1: Increase the presence of the Commission in Diocesan and Congregational activities.
- Goal 2: Train, educate, and update all members of the Commission on some aspect of racism.
- Goal 3: Educate and inform so to empower others to dismantle racism in the Diocese.
- Goal 4: Increase the active membership of the Commission on Dismantling Racism.

During calendar year, the Commission provided the required fourteen hour training for all ordained and leadership persons in the diocese. This training was held at The Church of the Holy Communion in University City on Friday and Saturday, March 16, and 17, 2012.

In continuing to respond to the National Church resolutions, the Commission on Racism announced and began implementation of **Seeking Our Past: Creating Our Future** in the Diocese of Missouri. This will be a continuing program designed to assist congregations with developing awareness and recognition of their role in shaping the communities that where we all reside.

The Commission also provided various training programs at parishes throughout the diocese including:

- April 29, 2012 Church Visitation at St. John's Episcopal Church

- October 28, 2012 Church Visitation and adult education program at Church of the Good Shepherd

### Episcopal Campus Ministry-Mizzou

The primary mission of Episcopal Campus Ministry is to carry the God news of God's reconciling love to students and young adults in the Columbia, Missouri, area. Our primary mission is carried out by creating and nurturing an open and supportive faith community in which young adults may wrestle with questions about identity, vocation, relationships and sexuality, while sharing the joys and sorrows of life. We strive to live out our baptismal promises through regular worship; group study and reflection; celebration of the Sacraments; community service; and creation of an inclusive and welcoming community.

We worship and fellowship as an intimate community, while reaching out to the larger campus communities in Columbia. In the past year we have:

- Worshipped and studied each week, building com-

munity through regular fellowship and special social gatherings, such as visiting a corn maze, Advent party, etc.

- Cooked and served for the local soup kitchen several times; volunteered at the winter homeless shelter; and held a bake sale to support the Diocesan mission trip to Lui.

- Worked with the United Methodist campus ministry to offer "Ashes to Go" on campus.
- Walked the "Way of the Cross" on campus with the Newman Center, singing and praying our way around the campus.
- Co-sponsored a Holocaust Remembrance Week program with Hillel.
- Worked with a coalition of international and inter-faith student groups to host a "Horn of Africa" fundraising dinner to support development work in Northern Africa.
- Travelled to southern Missouri to spend part of our spring break working on a Habitat for Humanity home (and having a bit of fun!).
- Participated with the LGBTQ Resource Center and Outgrads in "Coming Out Week:" activities.

ECM is committed to the ministry of all the baptized and operates with a leadership team comprised of lay and clergy members; students, faculty and other community members.

In 2012 we established an advisory council to provide guidance and support for our community as we advance our mission. The council works to advise the bishop and chaplain regarding perceived needs and opportunities; assist in the promotion of ECM and recruitment of community members; work with the chaplain to formulate budget and group policies; and, will take on additional responsibilities in the absence of a chaplain to ensure the continuity of the ministry. As part of the effort to strengthen our organizational structure, we have also worked to clarify student leadership roles and responsibilities.

### Episcopal Church Women

The Episcopal Church Women was first established in 1872 which was then called "The Woman's Auxiliary". Mary Emery was hired by the Board of Missions to be in contact with all the parishes and encourage the women to create their own Auxiliary Missionary Society "to aid with sympathy and prayers, time labor and money to the extent of her power." An appeal was made for a \$40-a-year pledge from individual parishes. In 1958, at the 29th Triennial Meeting in Miami Beach, the name changed to the Episcopal Church

Women (ECW).

Today we are Episcopal Church Women of all ages, ethnic origins and socioeconomic backgrounds who hold a variety of views. However, the most common view of our members is the love of God and the wish and desire to do His work.

Diocese of Missouri ECW Board's role is to represent all the women in our diocese; share in communication and leadership, and build support for ECW within our diocese and in the wider church.

Our mission is to offer every woman in the Diocese of Missouri an environment of support and encouragement, education and opportunity for ministry by providing: fellowship, communication, resource materials, and outreach to the diocese, nation and world.

**Projects/Meetings.** This past year Bishop Smith gave the Board the task, led by Cheryl Ward and Jeanne King, to coordinate the effort to the rebuilding of Holy Trinity Cathedral in Haiti by encouraging those in our diocese to purchase a brick for \$10 to help in this rebuilding. We had about 4 months to accomplish this task and it was a huge success.

Four board members attended the 2012 ECW Province V Annual Meeting in South Bend, IN April 27-29, 2012, hosted by the Diocese of Northern Indiana. The total cost of this meeting was \$1350. One board member attended the Church Periodical Club (CPC) Annual Meeting held in Indianapolis, In the week before Triennial. The total cost of this meeting was \$599.00. Three board members attended the 47th Triennial Meeting held in Indiana, IN July 5-12, 2012 the same time as the General Convention. The total cost of this meeting was \$4,579.19. Thanks to the money allotted from the diocesan budget to help defray the cost of these meetings, we were allowed to attend and bring back information to share within our diocese.

The Diocese of Missouri ECW held its annual meeting this year in Fulton, September 7 & 8. Guests were driven to Serenity Valley Winery for some wine tasting and then to Beks Restaurant for dinner and fellowship on Friday evening. The registration, worship service, and business meeting were held at St. Mary of Aldermanbury with the lunch and seminars held at St. Alban's. By having this annual meeting in Fulton, more of the Fulton area was able to attend and share in the fellowship.

**Upcoming Meeting.** The Diocese of Missouri ECW will host the 2013 ECW Province V Annual Meeting to be held at the Doubletree Hotel in Chesterfield April 4-7. The theme of this meeting is "Gather Us Together". Our keynote speaker for this event will be the Rev. Gay Jennings, President House of Deputies. A massage therapist will be available for a slight fee of \$1/hour. A tour to the Missouri Botanical Gardens for an additional cost will be offered to the attendees on Friday, April 5th. Bishop Smith will preside at the Eucharist on Sunday, April 7th. Our goal is to have volunteers from each parish in our diocese to participate and attend the meeting. We hope to receive an amount from the Province V budget to help defray the cost of this meeting.

### Episcopal City Mission

**Introduction.** Episcopal City Mission was founded in 1894 by an Episcopalian lay person who brought together volunteers to visit the less fortunate in St. Louis area institutions.

In 1913, the organization was asked by the court system

to have chaplains available for children detained and awaiting adjudication. We dedicated our work to children in detention in 1954.

Today, ECM provides a chaplain to each of the three detention centers for children in the metropolitan area – St. Louis City, St. Louis County, and Lakeside Center. An ECM chaplain works to fulfill our mission of providing support, hope and healing to children in detention through a ministry of presence and programs designed to help a child make better choices.

Programs cover a wide spectrum of subjects, including self-esteem and healthy relationships, grief and loss, and questions of doubt and faith. ECM chaplains are available to listen when a child wants to talk. Over the course of a year, ECM chaplains will have over 10,000 interactions with children. Those interactions are the only opportunity for confidential conversations with a caring adult that a child has while in detention.

**Report:** In the last year we continued our existing programs:

- Weekly nondenominational chapel services.
- Monthly birthdays which bring adult volunteers to the centers to honor the celebrants.
- Faith movies, faith dance, faith choir which give the children the opportunities to enrich a talent.
- Volunteer visitation; the chaplains are available after a child's visit with family since crisis sometimes happen after these meetings.
- Grief and loss groups which help the youth explore the causes of their anger and behavior.
- Safe conversations with a chaplain.
- Community service: this is only offered at Lakeside where the children can leave the campus with supervision. They have volunteered at a Jewish food pantry, Gateway Greening, Nurses for Newborns, and St. Patrick's Center.
- Bible study based on a book, "Doing Time with God" which has stories by juveniles paired with a Bible passage.
- Motivational movies which give the youth an opportunity to see examples of situations where someone had to make a difficult decision.

We are proud to announce that we were asked to offer chaplain services at the Division of Youth Services in 2012. The Rev. Dietra Wise went to the MET Center and visited with the children in the morning before school. She also went to Bellefontaine Farms and spent time with the girls in one of the cottages.

ECM and the work of our chaplains is being recognized throughout the area. The Rev. Dietra Wise was asked to serve on Mayor Slay's Youth Violence Prevention Task Force. The mission of this task force is to develop and institutionalize a comprehensive youth violence prevention plan modeled on the National Forum for Youth Violence Prevention for the St. Louis region. Chaplain Kevin Aldridge is a member of the Youth Crime and Delinquency Work Group of another initiative in St. Louis called the Youth and Community Empowerment Collaborative.

ECM hosted two fundraising events again this year. Summer Solstice was moved to Grace Episcopal Church in Kirkwood and a record crowd enjoyed this annual family picnic. Additionally, a wonderful group of ECM supporters joined in the celebration at our Moment in Time gala dinner in September. It is our largest fundraising activity.

### Episcopal Presbyterian Health Trust

**Introduction.** The Episcopal Presbyterian Health Trust (EPHT) is a nonprofit, grantmaking foundation established as a joint healthcare mission of the Episcopal Diocese of Missouri, the Presbytery of Giddings-Lovejoy, and St. Luke's Hospital. The purpose of the Trust is to provide healthcare and medical services to uninsured and underserved populations in the city of St. Louis and immediately adjacent areas. The Trust stewards its resources through a grantmaking program that partners with nonprofits addressing the healthcare needs of many who need assistance and support for basic medical needs. Since its inception, the Trust has made in excess of \$5 million in grants to organizations that support the health of individuals and families.

**Yearly Report.** The Trust considers grant requests to expand services, model new approaches to health care delivery, or to build collaborations that address the needs of the underserved. Applications for funding are accepted on an ongoing basis; awards are granted quarterly. So far this year, the Trust has approved responsive grants totaling more than \$100,000. Grants have purchased allergy and asthma supplies, medical equipment, and prescription drugs; paid for training and salaries of mental and physical health professionals; provided health education materials; and helped provide mental and physical health for women in permanent supportive housing.

In addition, the Trust partnered with the Regional Health Commission (RHC) to support the integration of physical and behavioral health care in St. Louis City and County. The purpose of this initiative, known as Building Sustainable & Systemic Integration of Physical Health and Behavioral Health Services, is to increase access to quality behavioral health services in St. Louis City and County by investing in systemic and sustainable changes to integrate behavioral health and primary health care services at community health centers in the region. EPHT and RHC awarded over \$1.4 million dollars to two organizations, Betty Jean Kerr People's Health Centers and St. Louis County Department of Health over the next two years.

### Episcopal School for Ministry

Bishop George Wayne Smith appointed the Rev. Dr. Daniel Handschy as Dean of the Episcopal School for Ministry, effective 1 August 2012. The School, the Board and the Dean would like to thank the Rev. Beverly Van Horne for her service as Interim Dean. Beverly re-energized the Board of Episcopal School for Ministry and helped them focus their work on the Making Disciples Conference.

In September of 2012, the Board of ESM presented "Holy Food and Groceries" as the Making Disciples Conference, led by Sarah Miles, director of the food pantry at St. Gregory's Episcopal Church in San Francisco. One hundred and twenty people attended the conference, and most evaluated it very positively. The Rev. Bob Towner and his crew from the Red Door Church cooked and served lunch and the mission group from the Church of St. Michael and St. George provided breakfast, as well as bringing the St. Michael's bookstore to the event. St. Martin's Church Ellisville provided wonderful hospitality.

The Theological Formation program of ESM continues to meet one weekend a month at the campus of Eden Theological Seminary in Webster Groves. Faculty for 2012 are the Rev. Barbara Willock (Old Testament and Preaching), Dr. Ron Crown (New Testament), the Rev. Dr. Warren Crews (Spirituality), the Rev. Dr. Peter Van Horne (Church History I & II), the Rev. Dr. Dan Handschy (Theology 1, Sacramental Theology and Liturgics). Various guest faculty offer topical sessions on the Friday evenings when the school is in session.

The School graduated four students in September of 2012: Michael Booker, Paula Hartsfield, Cathy Johnston and Andrew Rikand. Congratulations to these graduates.

### Offices of the Bishop: Administration and Congregational Development

Under the supervision of the Rev. Canon Dan Smith, the office of the Canon to the Ordinary continues to supervise the business, legal, property, and congregational matters that make up the day-to-day work of a portion of the Bishop's staff. Ms. Desiree Viliocco continues to lead the daily work with the financial affairs of the Diocese. She is ably assisted by Ms. Rita Benson. Ms. Robin Weisenborn continues as Canon Smith's administrative assistant.

Ms. Weisenborn's responsibilities were increased this year as she serves in support of the Commission on Ministry, working with those in the ordination process, and has increased responsibilities in assisting Canon Smith with the work of transition ministry.

Financial: Ms. Viliocco's work with the financial concerns of the Diocese continues to be exemplary. You will see in the convention journal for last year and this year the auditors continue to praise the work of Ms. Viliocco and her assistant Ms. Benson. Both give a great deal of time to the insurance concerns of both our active and retired clergy.

They continue to give significant support in regard to our companion relationship with the Diocese of Lui, Episcopal Church of Sudan. As noted in last year's report to convention we welcomed Rita Benson to our staff. At convention last year Ms. Benson had been with us for just a couple of weeks. As you might imagine there was a learning curve. As you might imagine there was a learning curve. Ms. Benson has conquered that with grace and skill. She has attended along with Ms. Viliocco a conference hosted by the Medical Trust and now a year into her work with us is fully up to speed. We are delighted to have her. Ms. Viliocco continues to give primary support to the treasurer of the Diocese and to the Diocesan Investment Trust. Please know that our financial staff is always ready to help with questions regarding insurance as well as helping with advice on the financial concerns of the congregations in the Diocese.

Canon Smith continues to have primary responsibility for the Business and Legal affairs of the Diocese. The chancellor, Mr. Hal Burroughs, continues to provide much needed counsel in this area. Unfortunately, this year Mr. Burroughs' help included working with Canon Smith, Intake Officer under the Ecclesiastical Discipline Canons, Title IV of the National Canons on two cases of clergy misconduct. Both of these cases have been brought to a conclusion regarding the canonical process.

Congregations in Transition are a priority in this office. In 2012 we had one search ending in the call of a new rector.

We join in welcoming Mark Koziielek to St. Mark's, St. Louis. Two searches St. Peter's, Ladue and St. Timothy's, Creve Coeur are in high gear working with initial tele-

phone/ skype interviews. Both of those searches should end in the calling of new rectors for each congregation sometime during the first quarter of 2013.

As noted last year, the method of doing searches changed a great deal with the advent of the new Office of Transition Ministry Portfolio for both clergy and congregations. We continue to see good results from this new process.

Canon Smith continues to attend regular conferences with Transition Ministers that allows him to increase his skills in using the new system as well as the valuable networking that occurs at those conferences.

Canon Smith continues to work with the training towards the prevention of sexual abuse, exploitation and harassment in the work environment. He is grateful to Ms. Heidi Clark for the training she completed with the camp staff for Camp Phoenix. Canon Smith believes the most effective trainings are in a group setting, however then on-line training for Safeguarding God's Children has dramatically raised the number of people trained in that program in the diocese.

Canon Smith continues to provide the primary staff support to the Standing Committee and to the Diocesan Council/COEDMO, assisted by Ms. Weisenborn and Ms. Tracy Grigsby.

During the summer of 2012, Canon Smith provided on site logistical support for the Bishop and Deputation at the General Convention of the Episcopal Church. Ms. Weisenborn shared in that responsibility by handling all of the registrations and reservations for the Deputation. During General Convention Canon Smith worked for the Office of Transition Ministry in their booth in the exhibition hall. This provided a valuable opportunity for networking with clergy from all parts of the church.

A highlight of the past year was the opportunity to work with a group of four CORO Fellows. These four young adults spent a month working on the feasibility of the mission initiative in Old North St. Louis; a project you will hear more about during this convention. The energy they brought to the Bishop's office was a joy to all the members of the Bishop's staff.

### Offices of the Bishop: Communications

The Office of Communications in the Offices of the Bishop is comprised of Director of Communications Beth Felice, receptionist and Communications Assistant Tracy Grigsby, and Archivist Sue Rehkopf. Grigsby also assists the Administrative cluster for 2/5 of her time.

The communications group produces four printed newsletters each year, Seek, mailed to 2000 diocesan homes and delivered in bulk to each church for additional distribution. For fifty weeks of the year we produce an emailed weekly newsletter, iSeek. It is available via email, embedded on the diocesan website, and distributed via social media and smart phone widget.

Communications helped diocesan members coordinate time with Bishop Stephen and Lillian Dokolo during their four week stay in Missouri, which began at the end of last year's diocesan convention. Parishes and individual members were able to schedule through the calendar and online community blog Lui Network. This is the same community space where mission partners from the Diocese of Salisbury and the Diocese of Lund participate with Missourians

to inform one another about upcoming trips and needs, and reflect back upon common work. The next trip leaves Nov. 25, and again diocesan members are invited to follow along at [LuiNetwork.diocesemo.org](http://LuiNetwork.diocesemo.org).

As with previous mission trips, we will again pray each day with the missionaries, at 8 AM in Missouri, which is 5 PM in Lui. Communications supports this reflecting daily prayers at this hour through the diocesan Twitter channel @diocesemo and in a Facebook event from the page [facebook.com/EpiscopalDioceseofMissouri](http://facebook.com/EpiscopalDioceseofMissouri).

Communications assisted with the publication and distribution of materials for parish study as gathered by the Anglican Covenant Task Force, convened by Bishop Smith.

After two years of monthly communications meet-ups, first at St. Mark's Church in St. Louis, then at Emmanuel Church in Webster Groves, members opted to move the meeting to an online monthly gathering. No inroads were made with inviting non-Episcopalian communicators into the group.

Communications assisted the Commission on Ministry in their complete overhaul of the discernment process materials, forms, and guidelines, which are now updated and available on the diocesan website.

Communications assisted the Dismantling Racism Commission in publishing the toolkit they designed and offered to parishes to explore their own history with racism. Seeking Our Past, Creating Our Future is now available online in addition to a small quantity in print. One copy was mailed to each diocese and province in the Episcopal Church who actively engages with this work.

Leading up to, during, and after the General Convention of the Episcopal Church held this summer in Indianapolis, communications assisted the deputation of the diocese in communicating through their blog. Live blogging sessions, calendar and worship updates appeared at [missourideputation.blogspot.com](http://missourideputation.blogspot.com). Communications created a yahoo "pipe" which collected the posts of all of the deputations of the Episcopal Church who were actively blogging, and this newsfeed was enjoyed by not only diocesan members, but others in the wider church.

The post-General Convention Seek was noted by some as a meaningful summary of not only the acts of convention, but also for its collection of reflections from Missourians who had visited or participated in convention in various roles.

The Journal of the 171st convention was produced and distributed. A publication with increasing reach is the monthly Bishop's Column. Each month, near the 20th, a column is released to parishes for their next month's newsletters or bulletins. These writings from Bishop Wayne are timely and feedback has been very positive. Communications assists working diocesan groups by maintaining email distribution lists. Communications supported the work of the Making

Disciples conference by creating four short videos of parish feeding ministry programs.

On the first Saturday in October, we held our second communications conference. This year we offered modular units with optional lunch at no cost to participants. The main presenter was copyright specialist John Talbert. A video of his presentation is available to diocesan members to borrow. We also have a new set of web pages with copyright information: [diocesemo.org/copyright](http://diocesemo.org/copyright).

In 2012, also on the first Saturday of October, we'll present our third annual communicators' conference. Our main presented will be Randall Curtis from the Diocese of Arkansas, developer of Faithfully Facebook and the Holy Geek website. We'll also have a session with local journalists on for getting your parish news into local media, and one on content creation.

Communications maintains a visible presence for the diocese in social media. We offer two Twitter channels; @diocesemo offers prayers from the diocesan and Lui cycle, and other prayers. The reach continues to grow and diocesan groups who would like us to send out a prayer or news are encouraged to discuss this. @diomonews offers timely updates. Communications maintains galleries of photos of events in the life of the diocese on [flickr.com/diocesemo](http://flickr.com/diocesemo).

The space is part of the Table Project. A few diocesan members have been testing the space, and it holds some promise as a place that could support the work of groups. Look for news in iSeek and at [diocesemo.org](http://diocesemo.org), or contact Beth Felice.

The table project is one of four new projects slated for this coming year, following convention. In December and early winter, the diocesan website is being moved to an integrated content management system, the open-source Concrete5. From the user's point of view, the design will change some. Under the hood, workflow is simplified. And it is another chance to make things easier to find on the site. As always, your comments are always welcome and if you would like to be a part of the testing team, please contact communications.

Along with internal and external web changes, the iSeek will be redesigned to reflect the new look of the website. It is anticipated that it will employ "responsive" design. This will allow users of tablets, computers, smart phones, netbooks, iPads to have satisfying reading experiences, without having to scroll around and resize screens.

The fourth project is the beginning of digitizing archived diocesan publications. The archives of the diocese have many of the diocesan newspapers on microfilm. As a test, we are digitizing 35 years worth of NOW, the diocesan newspaper from 1956-1989. Each one of the issues will then be catalogued and entered into an online library using the open source application Omeka. This test will give us an idea of the scope of the project, which includes diocesan news dating back to the 1800s and forward to the present day. These years were especially chosen to support the work of the Dismantling Racism Commission and parishes exploring their history with racism. We hope to have the

first group of this set of years online in time for the Absalom Jones celebration in February 2013.

### Archivist and Registrar

The Archives is the repository for all the official and historical records of the Diocese. Our collection includes a library, extensive document and photograph collections, parish registers and a growing collection of three-dimensional items from our closed churches.

The 6th floor of Bishop Tuttle Memorial is home to the Archives. What was originally space designed for three 2-room apartments for unmarried Cathedral clergy at the time the building was constructed, now provides space for our Library with room for reading and research, and for our growing collection of materials on clergy, Standing Committee, Diocesan Council, Parochial Trust Fund and COEDMO, congregations, committees, commissions, task forces, organizations and institutions, and the records of our bishops. The Archives of Christ Church Cathedral also have a room on the 6th floor reserved for their collections.

In 1870, at the instigation of Bishop Robertson, the Diocese began publication of a monthly newspaper called "Church News." The Great Depression signaled the end of this publication in 1932. From 1948 through 1954, "Missouri Forth" was 8 pages in each issue of the national church publication "Forth." In 1956, "NOW" became the official Diocesan publication, followed by "Interim" in 1969.

Most of our diocesan newspapers up through 1989 have been microfilmed for preservation purposes. And now our microfilms are serving another purpose in taking us into the digital world! We're beginning by having microfilms of "NOW" and "Interim" digitized. The next steps will be to index them and make this valuable resource available for reading and research through the Diocesan website.

In August, I was able to attend the annual conference of the National Episcopal Historians and Archivists in Buffalo, New York. This conference provides not only educational opportunities, but also opportunities to meet other diocesan and congregational archivists and historians from around the country, and to learn something of the history of the regions and the dioceses where we meet, as well. The Buffalo Conference 2012 would not have been complete without a side trip to Fort Niagara to visit a site so closely associated with the War of 1812.

The range of requests we receive for historical information continues to amaze me. Because of our long history in the State of Missouri we receive requests for far more than just church information. The search through journals, registers, church newspapers and old records is often as rewarding as finding the needed answer. I continue to receive requests for letters of transfer from closed churches, and for birth, marriage and burial records as family genealogy continues to be a popular and growing pastime for many. If your congregation is interested in establishing archives or in improving your existing archives, I'm happy to provide assistance. And if your congregation is working on writing your congregation's history, the substantial resources in the Diocesan Archives are available to you.

About Sewanee. The University of the South is home to both an outstanding liberal arts college and a seminary of the Episcopal Church. Located atop the Cumberland Plateau between Nashville and Chattanooga, Tenn., Sewanee's 13,000-acre campus, the second largest campus in the United States, provides vast opportunities for research, recreation, and reflection. Within the traditionally strong curriculum of humanities, sciences, and graduate theological studies, Sewanee faculty members promote intellectual growth, critical thinking, and hands-on research. The Board of Regents, to which the Board of Trustees delegates some of its responsibilities for governance, is composed of Episcopal bishops, priests, and lay people, and may include a limited number of members of other Christian bodies. The Chancellor of the University, elected by the Board of Trustees, is a bishop from one of the 28 owning dioceses. and Supervisory CPE. During 2011, St. Luke's added a sixth chaplain resident position to the program. The Center offers the following CPE programs: a 1 to 2-year Residency Program; a 2 to 3-year Supervisory Education Program; an 11-week Summer Program; and a 16-week Extended Program.

Expanding the Healthcare Mission: The Episcopal- Presbyterian Charitable Trust. Another way St. Luke's lives out its Episcopal-Presbyterian heritage and healthcare mission is through the Episcopal-Presbyterian Charitable Trust (EPHT). The nonprofit, grant-making foundation was established twenty years ago as a joint healthcare mission of the Episcopal Church, the Presbyterian Church U.S.A. and St. Luke's Hospital. The Trust has made more than \$5 million in grants to nonprofit healthcare organizations serving the needs of our region's most vulnerable residents. The ministry of the Trust is exemplified through the investments it makes; there are large grants aimed at creating systemic change while a grant program for smaller organizations is intended to support a health ministry for underserved populations.

The mission of EPHT is to support organizations that provide quality healthcare services to St. Louisans. We seek to create partnerships with effective, community-based organizations that work to improve the lives of others through access to health care. The Trust's Board of Directors includes members of the Episcopal Diocese of Missouri, the Presbytery of Giddings-Lovejoy of the Presbyterian Church U.S.A. and two representatives of St. Luke's Hospital. The Trust also partners directly with St. Luke's Hospital through grants to enable the hospital to expand the scope of healthcare services made available to the greater St. Louis area.

The Episcopal Presbyterian Charitable Health and Medical Trust again granted St. Luke's Hospital \$75,000. St

Luke's ministry of healing is dedicated to caring for all persons regardless of their ability to pay. Congruent with this mission, the \$75,000 further contributed to St. Luke's commitment and ability to improve the health of the community in body, mind, and spirit.

### Task Force for the Hungry

The Diocesan Task Force for the Hungry speaks and acts on behalf of hungry people, funds food ministries, raises awareness about hunger and poverty issues, and serves as a resource to food ministries within the Diocese of Missouri.

The food pantries and projects we support operate on a shoestring, but are on the front lines in fighting hunger and homelessness. Our work is to support these groups by providing money that helps keep them viable.

Through 9/30/12 the Task Force has raised and distributed over \$12,000 this calendar year, which goes directly to six food ministries sponsored and run by parishes within the Diocese of Missouri. The Task Force has lost members over the last two years due to death, illness, and retire-

ment, and is in need of replenishing our ranks, hopefully with representatives from multiple parishes. Currently there are few parishes in the diocese that contribute to the Task Force. We are challenged with getting parishes to "buy in" to our mission.

The Task Force is currently made up of Brian Roche, from Grace in Kirkwood, Frank Kohn, from St. Timothy's in Creve Coeur, and Jim Hollenberg from St. Barnabas in Florissant. The Steering Committee of The Oasis Missouri is made up of the Rector/Vicar of the congregation and two lay representatives, to meet as needed to plan our work and ministry. We recognize that fear of, and discrimination against, gay lesbian, bisexual and transgendered people is part of an oppressive history within the Church and society, which distorts our relationship with God and with other people, and diminishes the humanity of us all.

Therefore we feel compelled to make explicit our welcome of gay, lesbian, bisexual and transgendered people into the ministries and life of this congregation, incarnating the message, "The Episcopal Church Welcomes You." We encourage gay, lesbian, bisexual and transgendered people to participate in all aspects of the ministries of this church, by bearing witness to Christ, and fully participating in our life, worship and governance.

Where we see division, we will seek, with God's help to be a people of reconciliation, offering a love that casts out all fear. Where we see injustice and ignorance, we will offer our ministry of advocacy and education, trusting the Holy Spirit to lead us all into truth.

### United Thank Offering

The United Thank Offering is a ministry of The Episcopal Church. Started in the late 1800's, its mission has and continues to be to encourage people to give thanks to God for all the blessings in their lives through prayer and also to drop coins in our UTO Blue Boxes to help others in need.

Once each year the money collected is given out in grants for worthwhile projects in the United States and abroad. At the Episcopal Church Women's Triennial Meeting in Indianapolis in July, it was announced that our diocese was fortunate to be awarded a UTO grant for All Saints Episcopal Church in North St. Louis. Their project

is titled, "Music and Arts Village". It is a project to purchase a digital piano learning lab and guitars for a start-up music program for underprivileged children. It is an after school and summer program for public school students at their church. They received the \$10,000.00 which they requested. The total cost of the program is estimated to be \$20,650.00.

On Sunday, July 8th at the Triennial/General Convention Eucharist there were about 5,000 people attending. The collection that day was for UTO. Over \$34,000.00 was given. The dollar amount of all the grant applications that came in was over four million dollars. Just under one million seven hundred thousand dollars was available so many worthwhile projects could not be funded. The grants funded were:

- 31 Episcopal Church Grants
- 6 Companion Diocese Grants
- 8 International Grants
- 2 Regional Grants (Episcopal Camps & Conference-Centers, Inc.) And (Gifts to Overseas Missionary Personnel).

In our diocese as of October 1, 2012, nineteen congregations have contributed \$9,118.05 this year. In the three years 2009, 2010 and 2011 the Diocese of Missouri contributed \$43,327.13.

There has been a change in the time of the year that Grant Applications will be accepted. It had started on October 1st of each year. The new time will be January 1st of each year starting in 2013. So the 2013 UTO Grant Application will be available on-line on January 1st of next year.

My three year term as Diocesan United Thank Offering Coordinator is coming to an end. I have enjoyed meeting new people, participating in Province V annual meetings in Dearborn, Michigan and South Bend, Indiana and this year at the Triennial in Indianapolis. Taking my place will be Dawn Henry of Transfiguration Episcopal Church. I will continue to work with her at least through the Spring of 2013.
