Born May 26, 1812 Consecrated October 20, 1844 Died April 18, 1868

Second Bishop

The Right Reverend Charles Franklin Robertson, DD, STD, LLD

Born March 2, 1835 Consecrated October 25, 1868 Died May 1, 1886

Third Bishop

The Right Reverend Daniel Sylvester Tuttle, DD, STD, DCL, LLD

Born January 26, 1837 Consecrated Missionary Bishop May 1, 1867 Elected Bishop of Missouri August 9, 1886 Succeeded as Presiding Bishop September 7, 1903 Died April 17, 1923

Fourth Bishop The Right Reverend Frederick Foote Johnson, DD

Born April 23, 1866 Consecrated November 2, 1905 Bishop of South Dakota, 1905–1911 Bishop Coadjutor of Missouri 1912–1923 Succeeded as Bishop of Missouri April 17, 1923 Retired November 8, 1933; Died May 9, 1943

Fifth Bishop

The Right Reverend William Scarlett, DD, LLD

Born October 3, 1883
Consecrated May 6, 1930
Bishop Coadjutor 1930–1933
Succeeded as Bishop of Missouri November 8, 1933
Retired November 1, 1952
Died March 28, 1973

The Right Reverend Arthur Carl Lichtenberger, DD, STD, LLD, LHD, DCL, JCD

Born January 8, 1900
Consecrated April 5, 1951
Bishop Coadjutor 1951–1952
Succeeded as Bishop of Missouri, November 1, 1952
Elected Presiding Bishop October 11, 1958
Assumed Duties of Presiding Bishop November 15, 1958
Resigned as Bishop of Missouri May 15, 1959
Retired as Presiding Bishop October 12, 1964
Died September 3, 1968

The Right Reverend George Leslie Cadigan, DD

Born April 12, 1910 Consecrated April 16, 1959 Succeeded as Bishop of Missouri May 15, 1959 Retired April 16, 1975 Died December 14, 2005

Born January 24, 1927 Consecrated Bishop of Missouri May 3, 1975 Retired January 21, 1993 Died October 11, 2020

Born August 17, 1936 Consecrated March 2, 1991 Bishop Coadjutor 1991–1993 Succeeded as Bishop of Missouri January 21, 1993 Retired June 6, 2002

Born January 29, 1955 Consecrated March 6, 2002 Bishop Coadjutor March 6–June 6, 2002 Succeeded as Bishop of Missouri June 6, 2002

Rules of Order

- 1. The Presiding Officer shall appoint members of the Permanent Committees at each Meeting of Convention.
- 2. All resolutions from the floor shall be reduced to writing, presented to the Secretary, and read to Convention. A resolution from the floor that is not a part of a committee report may be introduced only at the time indicated in the Order of business. All resolutions from the floor, whether or not a part of a committee report, after receiving a short explanation from the presenter, must receive a 2/3 majority vote of Convention before it may be considered by Convention.
- 3. When any member speaks to Convention, he or she shall address himself/herself to the Presiding Officer, state his/her name and church, and confine himself/herself to the point in debate.
- 4. A member, other than the Chairman of the Committee whose report is under consideration, shall not speak more than twice in the same debate, nor longer than five minutes at a time, without leave of Convention.
- 5. Any member of Convention may call for a vote by hands or standing vote. Every member of Convention who may be in attendance when such a vote is called shall be counted unless he/she be excused by Convention.
- 6. When a question has once been determined it shall stand as the judgment of Convention, and shall not again be drawn into debate except on motion of reconsideration which must be made by a member who had previously voted in the majority.
- 7. All questions of parliamentary law not resolved by reference to the Canons or these General Rules shall be decided under Robert's Rules of Order.
- 8. All questions of order shall be decided in the first instance by the Presiding Officer, without debate; an appeal may be made to Convention by any member.
- 9. The reports of all Committee shall be in writing, and shall be received without motion for acceptance, unless recommitted by a vote of Convention. All reports recommending or requiring any action or expression of opinion by Convention shall be accompanied by a resolution for the action of Convention thereon. All annual reports shall be received and filed by the Secretary as presented before or during Convention, and may be called upon motion to be read and considered at any time during Convention.
- 10. The names of movers of resolutions shall appear in the minutes of Convention.
- 11. All motions and resolutions requiring reference shall be referred, so far as possible, to the Permanent Committees of Convention.
- 12. Except in cases where majority vote is required, all elections shall be by Single Transferable Vote Ballot utilizing such online balloting system as the Secretary shall have determined in consultation with the Presiding Officer.
- (a) No later than the day before elections are to occur, the Secretary of Convention or his or her designee shall send an email to every member of Convention setting forth a unique voter access code.

- (b) Each elector shall mark his or her ballot by numbering the names of all the candidates for each office in order of preference, with "1" being the highest (most preferred) ranking. For example, if there are three candidates, the elector places "1" beside their first choice, "2" beside their second choice, and "3" beside their third choice. The elector shall not give more than one number to any name, nor shall any name be left unnumbered. Any ballot which does not comply with the directions given in this section will be invalid and will not be counted.
- (c) The persons appointed by the Presiding Officer to conduct the election shall count each valid ballot.
- (d) Any candidate that receives more than a certain number of first-place votes (a quota based upon the number of electors and number of open positions) is elected. If the elected candidates receive more votes than necessary for the election, their excess votes are distributed to the other candidates in accordance with the second-choice preference of the electors. Once again, any candidate that receives more than a certain number of votes is elected and the redistribution procedure continues. If the redistribution procedures reach a point where there are no more votes to be redistributed and there are still more elected positions to be filled, the candidate with the least votes is eliminated and the votes for that candidate are redistributed.
- 13. The Presiding Officer may, having left the chair, enter into the debate on any question, but shall not then resume the chair until the main motion under consideration has been disposed of.
- 14. Once the Order of Business has been approved it may not be altered except by 2/3 majority vote of Convention, provided that the Presiding Officer may reorder agenda items at any time.

Plenary Session I

Call to Order – Bishop Johnson

Having been informed of a quorum present, the Rt. Rev. Deon K. Johnson called the first Plenary Session of the 184th Convention of the Diocese of Missouri to order at 10:01 A.M. with an opening prayer and words of welcome.

Reminder to Register – Bishop Johnson

Bishop Johnson reminded any Clergy and Lay Delegates present who did not sign in at the Registration Desk to do so as soon as possible in order to receive their voting materials, as there would be voting on matters of substance that morning. He also instructed those addressing the Meeting of Convention, when stepping up to a microphone, to first state their name and their congregation's name and city.

Appointment of a Secretary – Bishop Johnson

Report from Diocesan Council and New Ventures for Community Ministries Grants – Angela Breeher, Vice President

Angela Breeher made the Annual Report of the work of the Diocesan Council during the past year, highlighting examples throughout how participating in the Convocation structure is important to the life of our diocese. The Diocesan Council Ministry Report published in the Records of Convention includes details of what the three working teams of Council have achieved over the past year.

She also announced the ten grants for New Ventures for Community Ministries that have been awarded through the Diocesan Outreach Endowment Fund by the Council for 2024:

- Jubilee Ministry (second year grant): To continue to get the <u>JustFood Truck</u> on the road to provide healthy meals to the poor and unhoused in food deserts in St. Louis City.
- Trinity, St. James & Christ Church, Rolla: To establish a parish nursing program in rural Missouri.
- Emmanuel Church, Webster Grove: to establish a ministry of welcome, service & hospitality to International students in the area.
- Calvary, Columbia: To participate in Partners in Education with local schools.
- Isaiah 58 Ministries: For a Health & Wellness Program aimed at serving the older adult population in South St. Louis.
- Christ Church, Rolla (second year grant): To continue their Laundry Love ministry.
- St. John's, Tower Grove: To establish an ecumenical Youth Group in conjunction with Compton Heights Christian Church and Oak Hill Presbyterian Church (requested by the young people in the three parishes).
- The Journey Church, Fulton: To make buildings handicapped accessible and install a washer, dryer and shower to enable people in need to clean themselves and their clothing.
- Faith Christian Church of India, Manchester: to establish "Aval," a self-help empowerment program to aid Asian Indian Non-Working Women Spouses with microloans and business support, as the women become more independent and contribute to the family income.
- Hope Episcopal Church, Town & Country: To begin a program called Family FUNdamentals, a program which
 includes informative workshops, family focused activities, and a family meal to tie each session together,
 designed to foster healthy relationships in families and raise socially well-rounded children.

Introduction of Diocesan Council Survey regarding Lay Delegations at Convention – Bob Lowe on behalf of Diocesan Council, Vital Communities Team

Bob Lowe introduced a discussion regarding the appropriateness of continuing to use Annual Sunday Attendance (ASA) in determining Lay representation at Convention and for determining just-based minimum

compensations for clergy. A URL and QR code link to a questionnaire was provided to everyone, with the request to provide feedback to the Vital Communities Team that day. The team hopes to use this feedback, along with their own investigations and suggestions, to submit a resolution on this subject to next year's Convention.

Church Plants – Faith Christian Church of India - The Rev. Clive Samson; The Rev. Sujanna Raj

The Reverends Clive Samson and Sujanna Raj reported on the six-year history of Faith Christian Church of India and introduced a short video featuring scenes around, and the members and ministries of, Faith Christian Church of India.

Church Plants - Grace African Christians Connection - Video introduction by Bishop Johnson

Bishop Johnson introduced a video of the Rev. Mtipe Koggani who spoke about the growth of Grace African Christians Connection (GACC) which was just launched at Christ Church Cathedral, St. Louis in October 2022. The parish will begin meeting and worshiping at St. Barnabas in Florissant on November 5, 2023.

After a two-minute stretch break, the session continued at 11:02.

Church Plants - The Journey Episcopal Church - The Rev. Jessica Wachter

The Rev. Jessica Wachter spoke about The Journey Church, which began weekly eucharists in March and is mostly a parish of those experiencing homelessness, poverty, and those living in a local group home of adults with disabilities. She narrated a video that showed the vibrancy and blessings of this newest church plant in the Diocese.

Deaconess Anne House - The Rev. Aaron Rogers

Deaconess Anne House (DAH) has been in a short period of discernment. The Rev. Aaron Rogers informed Convention that they were poised to begin 2024 with a new spirit of renewal, growth and innovation. The advisory council is currently being repopulated and will look at the next phase of the DAH; decreasing the barriers of access by making membership more expansive to touch every part of the Diocese, more diverse, and continuing to form young adults in the rhythm of life that represents the very best of this diocese. This year celebrates the 10-year anniversary of the DAH.

Gathering Space Task Force - Betty Bowersox and The Rev. Kevin McGrane

The task force has determined that it *is* feasible to create a diocesan gathering space. Yet first the Diocese needs to develop a "Gathering Culture", and we need to start small. During 2023 many facilities were researched and Exec Directors interviewed, with properties and several centers visited. In 2024 additional members will be invited to join the task force as they begin to look to partner with existing, established centers where smaller groups can gather, and learn what works for the Diocese and what doesn't before considering moving to a larger gathering space.

Presentation of 2024 Diocesan Budget – Al Ludwig

Al Ludwig, Treasurer of the Diocese of Missouri, stated that we've been fortunate to see a relatively stable financial environment, especially as compared with the last few years. The sources of funding on which the Diocese relies were reviewed. He spoke of the benefit we've had from trusts established in the 1940's and 50's that provide substantial Diocesan investment assets, for which we are grateful for and continue to care for, and went on to explain about these trusts in more detail. Mr. Ludwig presented the 2024 General Operating (balanced) Budget which, after having undergone multiple levels of review and input from across the Diocese, will be voted on tomorrow.

First Report of the Resolutions Committee – Dr. Michael Booker, Chair

Michael Booker presented the following courtesy resolutions recognizing clergy anniversaries in the Diocese of Missouri.

John C. Danforth

WHEREAS the Rev. John C. Danforth was ordained Transitional Deacon on September 15, 1963, and Priest on March 1, 1964, by the Rt. Rev. George Cadigan in the Diocese of Missouri; and

WHEREAS John served in the U.S. Senate from 1976-1995, and also as a United Nations ambassador, Attorney General of Missouri, and author,

BE IT RESOLVED that this 184th Diocesan Convention extend its prayers and thanksgiving for John's ministry as he celebrates 60 years of ordained ministry.

James P. Metzger

WHEREAS the Rev. James P. Metzger was ordained Transitional Deacon on January 15, 1963, and Priest on December 1, 1963, by the Rt. Rev. Roger Blanchard in the Diocese of Southern Ohio; and

WHEREAS Jim served in parishes in the Dioceses of Rochester, Southern Ohio, and Missouri, then continued his ministry as a nonprofit fundraiser and marriage and family therapist,

BE IT RESOLVED that this 184th Convention of the Diocese of Missouri extends its prayers and thanksgiving for Jim's ministry as he celebrates 60 years of ordained ministry.

Dr. Richard L. Valantasis

WHEREAS the Rev. Dr. Richard L. Valantasis was ordained Transitional Deacon on June 9th, 1973, and Priest on March 1, 1974, by Bishop John Burgess in the Diocese of Massachusetts; and

WHEREAS Richard earned his Doctor of Theology from Harvard Divinity School in 1988, taught Theological Studies at St. Louis University between 1992 and 1998, was Received into the Diocese of Missouri in 1993, and is now widely known as "an Episcopal Priest, historian, educator and author,"

BE IT RESOLVED that this 184th Diocesan Convention extend its prayers and thanksgiving for Richard's ministry as he celebrates 50 years of ordained ministry.

Wilson Nathaniel Pyron Jr

WHEREAS the Rev. Wilson Nathaniel Pyron Jr was ordained Transitional Deacon on June 25th, 1973, and Priest on March 23, 1974, by Bishop Christoph Keller Jr in the Diocese of Arkansas and after leading several smaller churches in Arkansas was Received into the Diocese of Missouri in September 1996; and

WHEREAS Nathaniel served parishes in Sikeston and Caruthersville before becoming Rector of St. Matthews-Warson Woods in 1999 through 2005, then was Associate/Assistant at Emmanual-Webster Groves, Church of the Advent-Crestwood, and St. Timothy's-Creve Coeur,

BE IT RESOLVED that this 184th Diocesan Convention extend its prayers and thanksgiving for Nathaniel's ministry as he celebrates 50 years of ordained ministry.

Following a second, these resolutions were approved with applause.

Announcements – Chancellor Burroughs

Following announcements by the Chancellor, Bishop Johnson concluded Plenary Session I at 11:40 A.M. and announced that Convention would stand in recess until 2:30 this afternoon.

Working Lunch with Keynote Speaker

The Rev. Deacon Dr. Deb Goldfeder introduced the keynote speaker's video on behalf of the Companion Diocese Committee: The Rt. Rev. Rafael Morales Maldonado of the Diocese of Puerto Rico. Bishop Morales' keynote was followed by table discussion. A Budget Hearing and Open Resolution Committees meetings followed prior to the start of the second plenary session.

Plenary Session II

Call to Order – Bishop Johnson

Having been informed of a quorum present, the Rt. Rev. Deon Johnson called the second Plenary Session of the 184th Convention of the Diocese of Missouri to order at 2:33 P.M.

Report from the Diocesan Missioner for Gun Violence Prevention Advocacy - The Rev. Mary Haggerty

The Rev. Mary Haggerty indicated that efforts have been focused on lament, education, and advocacy. For lament, the Diocese is hosting an interfaith prayer vigil of lament and remembrance, joint with the Roman Catholic Archdiocese, on December 10th. Regarding education, community members are being trained to present the 20-minute "Be SMART" presentation to our parishes. Be Smart is a public awareness

campaign geared toward adults to promote responsible gun ownership and to keep children safe from gun violence. For Advocacy, parishes are being asked to send letters to the leaders of both MO Legislative Offices, asking that in 2024, reasonable and sensible gun bills that are written be assigned to committee with enough time for public input, legislative debate, and a floor vote: this has not happened in prior years. Each parish was provided with a packet of preprinted letters and address labels, and envelopes, and asked to host a letter-sending event on December 10th.

Report from the Diocesan Missioner for Public Advocacy — The Rev. Dr. Teresa Danieley

The Rev. Dr. Teresa Danieley spoke enthusiastically on Imagining a Church Grounded in Justice as Christian Ministry. She is working toward being able to purchase Voter Voice to help equip missioners and mission groups with a tool to facilitate communication with MO legislators and increase the network of Episcopalians engaged in public advocacy. With greater resources she'd like to train volunteers to be ready to testify in the legislature every week of the session, being voices of the faithful. The Rev. Danieley stressed that we cannot allow systemic, economic, and political injustices to continue to exacerbate the poverty and inequality that cause fellow human beings to suffer and die. She concluded with the hope that Episcopalians in Missouri, because of our hope in Christ, will no longer put up with reality as it is, but begin to contradict it until the state motto is true that the welfare of the people shall be the supreme law, and all Missourians can thrive with dignity, respect, justice, and peace.

Report from the Diocesan Missioner for LGBTQIA+ Engagement - DeWayne Trainer

DeWayne Trainer spoke about the efforts and progress made to date after recently taking the lead in this important mission. He noted that there are people that don't know what to do about LGBTQ+ or are uncomfortable in that realm, so he provided his contact information so that everyone had it if they wanted to talk with him about these issues. They held mass on the grass at Tower Grove Pride September and had their first meeting in October. Mr. Trainer shared that data shows that by just having one person in your life that is affirming of you as a LGBTQ person, chances of even attempting or committing suicide decrease by about 30 to 40 percent. So be that one person for someone!

Announcements – Chancellor Burroughs

Following announcements by the Chancellor, Bishop Johnson concluded the second Plenary Session of the 184th Meeting of Convention at 3:01 P.M. and announced that Convention Eucharist would be celebrated at 4:00 in the afternoon with dinner and other activities starting at 6:30 P.M. The meeting stands in recess until 9:30 A.M. on Saturday, November 4, 2023.

SATURDAY, NOVEMBER 4, 2023

Plenary Session III

Call to Order – Bishop Johnson

Having been informed of a quorum present, the Rt. Rev. Deon Johnson called the third Plenary Session of the 184th Convention of the Diocese of Missouri to order at 9:30 A.M.

Report from the Diocesan Missioner for Creation Care - The Rev. Kevin McGrane, Sr

The Rev. Kevin McGrane announced that Bishop Deon approved the creation care liturgies written by the Rev. Margaret Bullitt Jonas, Director of Creation Care for the Diocese of MA. These would be good to use for the Creation Care season and also in November during Thanksgiving times. There was an update to the information in the Creation Care Ministry Report regarding the Solar Program, as negotiations for the agreement have now reached the point where it's been forwarded to the Bishop and Diocesan Council for their reviews. The Rev. Kevin McGrane then made a presentation regarding the tiny forest initiative, which began in Japan, that creates small patches of sacred spaces full of pollinators and small wildlife. He proposes that each Convocation identify a place to begin their own tiny forest.

Explanation of the Single Transferable Vote Balloting System - The Rev. Tamsen Whistler

The Rev. Tamsen Whistler, Chair of the Committee on Nominations and Election Procedures, explained the Single Transferable Vote Balloting and instructions on the use of the electronic balloting system.

Balloting for Members of Cathedral Chapter, Diocesan Council, Disciplinary Board, and Standing Committee.

Time was allowed for the elections by preferential ballot.

Discipleship Development - Children & Youth Ministry - The Rev. Erin Pickersgill

The Rev. Erin Pickersgill, Diocesan Ministry Developer for Children and Youth, asked that everyone visit the formation table and sign up for the newsletter. A video highlighting the experiences of three youths from the Diocese who attended the Episcopal Youth Event (EYE23) in Baltimore this year was shown. Next year there will be a youth presence at the Revival in March and there will be Summer Camp offered at Camp Wyman in August. Camp Phoenix will be relaunched in the future under a different name *that the kids get to choose*!

Discipleship Development – Campus Ministry - The Rev. Hope Jernagan

The Rev. Hope Jernagan is the Chaplain for Rockwell House Episcopal Campus Ministry in St. Louis, and unofficial coordinator of campus ministry across the Diocese. Currently the Diocese of MO has a presence on eight universities and even though some of them are not robust, these are places where there is desire and a need for this presence. These are places where a student can take care of basic needs; get food, find a quiet place to study, get away from a roommate, or get a winter coat if they don't own one. Plus there's spiritual growth and development. Two others joined Chaplain Jernagan to provide their perspective of campus ministry; Bill, a Student Chaplain at the University of Missouri in Columbia and Percy, a student at Washington University. They shared a video showing Rockwell House before and after its recent renovation work and the dedication of their outside chapel area in mid-September.

Discipleship Development - Young Adult Ministry - The Rev. Aaron Rogers

The Rev. Aaron Rogers, Diocesan Ministry Developer for Young Adult Ministry, clarified that the age range for young adults in the Diocese is 18 through 40. The office of Young Adult Ministry will amplify the voices of young adults across the Diocese, and help connect and network young adults, and also young adult ministry practitioners. It will support those doing ministry to young adults and help others who want to do ministry to young adults develop those ministries and create those ministries. They're also going to support leadership development for young adults. All this, plus having fun doing it! He introduced the Young Adult Advisory Council via slides, and showed a video where we heard from young adults in the Diocese.

Discipleship Development - Requiem or Renaissance - The Rev. Canon Whitney Rice

The Rev. Canon Whitney Rice, Canon for Evangelism & Discipleship Development, updated Convention as to the status of the Requiem or Renaissance project by showing a video of several participants being interviewed about their experience with the program. Bishop Deon had each congregation involved in Cohort 1 and then Cohort 2 stand up to be recognized.

1. BE IT RESOLVED that this 184th Convention of the Episcopal Diocese of Missouri set the annual standard base compensation for full-time clergy in 2024 as follows:

- **2. BE IT FURTHER RESOLVED** that the Church Pension Fund assessment will be paid by the congregation;
- **3. BE IT FURTHER RESOLVED** that \$50,000 group life will be paid by the congregation;
- **4. BE IT FURTHER RESOLVED** that the medical coverage for clergy be in compliance with Diocesan Resolution A-172;
- **5. BE IT FURTHER RESOLVED** that a standard of ten days per calendar year and \$500 will be provided for continuing education;
- **6. BE IT FURTHER RESOLVED** that the standard auto allowance will be \$2,000 per year;
- **7. BE IT FURTHER RESOLVED** that all parishes and missions encourage their full-time clergy to set aside the equivalent of two days each week for personal time, 24 hours of which must be consecutive;
- **8. BE IT FURTHER RESOLVED** that all parishes and missions be strongly encouraged to provide dental insurance for clergy and eligible dependents, or be assured they already have such coverage;
- **9. BE IT FURTHER RESOLVED** that the Clergy in Charge shall accrue two weeks of sabbatical time for each year of service; and
- **10. BE IT FURTHER RESOLVED** that all parishes and missions be encouraged to reimburse deacons and non-stipendiary clergy for reasonable expenses incurred in connection with continuing education and diocesan clergy retreats, including mileage, professional memberships and publications. (See also requirement in Title III Canon III.2 Sec 4 of the Constitution and Canons of the Episcopal Church in the Diocese of Missouri).

RATIONALE

The recommendation for 2024 reflects a 4.6% increase. This increase is based on the Bureau of Labor Statistics, Consumer Price Index-Midwest Urban Consumers.

Diocesan Resolution A-172, Implementation of Health Plan Submitted by Diocesan Council (referenced above in FURTHER RESOLVED #4) is reprinted here for reference:

- 1. **BE IT RESOLVED** that this 172nd Convention of the Episcopal Diocese of Missouri require Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop to pay 100% of the cost of individual health insurance coverage (selected from the offerings included in the Denominational Health Plan and administered by the Episcopal Church Medical Trust) for all lay and ordained employees working 1,500 or more hours annually, in accordance with Title I, Canon 8 of the Episcopal Church and to be implemented no later than January 1, 2013;
- 2. **BE IT FURTHER RESOLVED** that Lay and ordained employees of the Episcopal Diocese of Missouri and the Offices of the Bishop eligible for required individual health insurance coverage under Section 1 of this resolution may elect not to participate in the Denominational Health Plan if they have access to coverage through other approved sources, e.g. Medicare, Tricare, a former employer, or a spouse's or domestic partner's health insurance plan;
- 3. **BE IT FURTHER RESOLVED** that Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop shall not reduce existing coverage or increase the cost of existing coverage to employees to comply with A177 or this resolution;
- 4. **BE IT FURTHER RESOLVED** that benefit design and premium support parity is required within each congregation of the Episcopal Diocese of Missouri and the Offices of the Bishop in the provision of health insurance coverage for lay and ordained employees;
- 5. **BE IT FURTHER RESOLVED** each congregation and the Offices of the Bishop may impose a monthly premium surcharge or incentive to lay and ordained employees who elect coverage for a spouse, domestic partner, or dependent who is eligible for comparable employer-sponsored health insurance (other than the Denominational Health Plan) through an alternate source;
- 6. **BE IT FURTHER RESOLVED** that Congregations within the Episcopal Diocese of Missouri and the Offices of the Bishop are encouraged, if financially possible, to exceed the minimum standard of health insurance coverage for their lay and ordained employees; and
- 7. **BE IT FURTHER RESOLVED** that schools, day care facilities and other congregational and diocesan institutions, regardless of the independence of their incorporation or tax status, are encouraged to adopt the principles articulated in this resolution.

Resolution A-184 was moved by Dr. Booker and was seconded and approved unanimously.

Dr. Booker presented Resolution B-184

B-184 Resolution calling for a Sunday Observation of "Gun Violence Prevention Awareness" in congregations within the Episcopal Diocese of Missouri - Submitted by the Gun Violence Prevention Advisory Committee.

BE IT RESOLVED THAT this 184th Convention of the Diocese of Missouri asks that the congregations of the diocese observe Sunday December 10th, 2023 (the closest Sunday preceding the anniversary of the mass shooting at Sandy Hook Elementary in Newtown CT) as **Gun Violence Prevention Awareness Sunday** in support of the Diocese's efforts to end the pandemic of gun violence in our communities.

RATIONALE

The nation was stunned with the news on December 14, 2012 that 26 people (20 of them children) had been killed at Sandy Hook Elementary School, plus two others killed and two injured, in a mass shooting in Newtown, CT. This sparked a short-lived but futile debate about the need for stricter, or more common sense, gun laws. Mass shootings in the country have alarmingly increased in the years since the federal assault weapons ban lapsed in 2004 and was not renewed.

During the 183rd Convention of this Diocese The Right Reverend Deon K. Johnson appointed a Diocesan Missioner for Gun Violence Prevention who, with a team serving as the Gun Violence Prevention Advisory Committee, is engaging in efforts to raise awareness and help bring an end to gun violence in our communities. The work centers on promoting gun safety, legislative advocacy, and education within the Diocese. The observance of a **Gun Violence Prevention Awareness Sunday** by congregations aids in sharing ways that advocacy, prayer, public witness, and pastoral care can help to end the pandemic of gun violence.

To facilitate this observance, the Gun Violence Prevention Ministry of the Diocese of MO, with the support of Bishop Deon, will be rolling out a letter writing campaign for congregations to begin on December 10th, with resources provided. The goal is to encourage Missouri's 2024 Legislative Leaders to assign bills that are proposed for sensible gun laws to committee in a timely manner so that hearings can be held.

Other resources will also be available for congregations to use on December 10th, such as print-ready bulletin inserts, prayers and/or modified forms of the Prayers of the People.

Resolution B-184 was moved by Dr. Booker, seconded and approved.

Report of the Committee on Constitution and Canons: Consideration of Resolutions E-183 and D-182B - Chancellor Burroughs

Resolution E-183: A Resolution of the Committee on Constitution and Canons to Address Impairment of Average Sunday Attendance Calculations

WHEREAS, pursuant to Article III.6.a of the Constitution of the Episcopal Church in this diocese, Lay representation at Convention in this diocese is based upon average Sunday attendance during the immediately preceding calendar year; and

WHEREAS, church closures and worship restrictions during the coronavirus pandemic artificially suppressed average Sunday attendance calculations; and

WHEREAS, it is in the best interests of the Diocese to establish a means to address future possible disruptions to Church attendance and preserve the legislative balance of Convention;

NOW, THEREFORE, BE IT RESOLVED that Article III.6 of the Constitution of the Episcopal Church in this diocese be amended by adding a new Section 6.d. thereof which shall read as follows:

SEC. 6.d. In the event that any occurrence or circumstance temporarily impairs a Congregation from normal gathering for worship in the year otherwise counted, the Diocesan Council, or the ecclesiastical authority of the Diocese with the Diocesan Council's consent, may accord the Congregation the number of Convention delegates determined pursuant to subsection a above for the year before the impairment.

Rationale: The resolution largely speaks for itself. Average Sunday attendance calculations based upon the period when the Diocese was unable to accommodate in-person worship were distorted relative to historical attendance experience. Relying upon such figures would have greatly suppressed Lay participation in Convention and resulted in an imbalance in representation by Order at Convention.

Chancellor Burroughs moved the adoption of Resolution B-183 on second reading.

Motion to dispense with roll call and vote by rising.

Bishop Johnson reminded Convention that the Diocesan Constitution (Article V.2) requires Constitutional amendments coming for a second vote be acted on separately by each Order, needing a simple majority vote in each Order to give effect to the amendments. Article III.5, Section 5, of our Constitution provides that all votes by Orders shall be by roll call unless two-thirds of the Voting Members consent to substitute a rising vote taken separately by Orders.

Bishop Johnson entertained a motion to dispense with a roll call and vote by rising. This motion was moved, seconded, and passed by more than two-thirds of the vote (the vote was unanimous). The vote on the amendment was thus to be by rising vote of each Order voting separately.

Bishop Johnson then entertained discussion on the motion to amend the Constitution as recommended by the Committee on Constitution and Canons in E-183.

Vote on the Motion to approve Resolution E-183 (on second reading).

- The rising vote passed unanimously in the Lay Order in favor of the Amendment.
- The rising vote passed unanimously in the Clergy Order in favor of the Amendment.

Having the Bishop's approval, the Amendment passed and the Constitution was so amended.

Resolution D-182B: A resolution of the Committee on Constitution and Canons to effect certain amendments to the Constitution and Canons of the Episcopal Church in the Diocese of Missouri

WHEREAS, the 182nd Convention of the Episcopal Church in the Diocese of Missouri (the "Diocese") voted to postpone consideration of Resolution D-182B until the 183rd Convention of this diocese; and

WHEREAS, the 183rd Convention of the Episcopal Church in the Diocese of Missouri (the "Diocese") voted to postpone consideration of Resolution D-182B until the 184th Convention of this diocese; and

WHEREAS, in consultation with the Offices of the Bishop and in consideration of practices and procedures enacted in other dioceses of the Protestant Episcopal Church in the United States of America, the Committee on Constitution and Canons drafted a proposed new Canon IV.22 to articulate more clearly the manner in which the resources of the Diocese may be best employed to assist a Parish confronting existential challenges;

NOW, THEREFORE, BE IT RESOLVED that the Constitution and Canons of the Episcopal Church in the Diocese of Missouri be amended as follows:

Canon IV.22 is hereby added in its proper numerical order and shall read in its entirety as follows:

CANON IV.22 Of Restoring Congregational Health

SECTION 1. Concerning all that follows, it shall be the intention and obligation of all parties to labor to restore any Parish under Review to a greater degree of health, setting forth problems to be addressed in an open, honest manner and working toward the resolution of such problems in a climate of respect, charity, and collaborative power sharing.

SECTION 2. Action under this Canon may be initiated in any of the following ways:

- (a) The Rector or Vestry of any such Congregation may invite the pastoral intervention of the Bishop.
- (b) The Bishop, being aware of the conditions enumerated in Section 3 of this Canon, and acting in his or her capacity as Pastor of the Church in this diocese, may appoint a committee of three persons to seek amelioration of the condition(s), and to report to the Bishop thereon.

- (c) The Standing Committee may initiate the pastoral intervention of the Bishop upon the affirmative vote of two-thirds of the members of the Standing Committee (or as determined by the Standing Committee acting unanimously, if it then be the Ecclesiastical Authority of the Diocese).
- SECTION 3. Following the initiation of any action under this Canon pursuant to the procedures set forth in Section 2 above, the Bishop, with the advice and consent of the Standing Committee, may declare a Congregation to be a "Parish under Review" when two or more of the following conditions shall exist:
- (a) The Parish fails to assemble and elect a Vestry, as provided in these Canons; or fails to send delegates to any Convention of this diocese; or shall fail to pay diocesan assessments in a timely manner.
 - (b) The Parish fails to search for and elect a Rector after a reasonable period of time.
- (c) The Parish fails to compensate its Clergy with at least the minimum recommended stipends and allowances set forth in accordance with the compensation guidelines of the Diocese, or does not pay canonically required pension assessments for its Clergy and eligible lay employees, or does not maintain adequate insurance for the property of the Parish.
- (d) The Parish fails to make timely reports or to submit a certificate of audit as required by CANON IV.10.
- (e) Financial reports reveal invasion of the principal portion of endowment funds, or other evidence of financial instability sufficient, in the judgment of the Bishop and Standing Committee, to warrant action under this canon.
- (f) The Parish attempts to or effects an alienation or encumbrance of the real property of the Parish in violation of CANON IV.11.
- (g) The Parish permits its property to be used for purposes incompatible with its consecration; or the Parish engages in any persistent course inconsistent with the doctrine, discipline or form of worship of this Church.
- SECTION 4. In the event that the Bishop, with the advice and consent of the Standing Committee, shall have declared a Congregation to be a Parish under Review pursuant to Section 3 of this Canon, the Bishop, with the advice and consent of the Standing Committee, may require the application of one or more of the following measures to restore health to the Congregation:
- (a) appointment by the Bishop of five or more adult Communicants of the Parish to govern the affairs of the Parish as the Vestry during the pendency of the specified condition(s), notwithstanding any other provisions in these Canons for (i) such governance, or (ii) the election of a Vestry;
- (b) designation of the Rector of the Parish as Vicar, during the pendency of the specified condition(s);
- (c) conveyance of title of all real property to the Trustees of COEDMO, who shall hold the same in trust during the pendency of the specified condition(s);

(d) such other measures, during the pendency of the specified condition(s), as the Bishop, with the advice and consent of the Standing Committee, shall determine.

SECTION 5. When any Parish fails to elect a Vestry, the Bishop, with the advice and consent of the Standing Committee, may appoint at least three trustees to take charge of the property of the Parish and exercise the rights and functions of a Vestry, until the earlier of (i) the Parish shall have elected a Vestry in accordance with the provisions of CANON IV.5 or (ii) the appointment of a new Vestry under Section 4(a) of this Canon.

SECTION 6. When, in the judgment of the Bishop, with the advice and consent of the Standing Committee and in consultation with the Parish under Review in question, a Parish under Review has either completed its mission or exhausted its resources, the Bishop may end the existence of the Parish, and its property and other assets shall be transferred to the Trustees of COEDMO. The Diocese will take appropriate steps to conclude the affairs of the Parish. The Diocese shall assist the people and Clergy of the affected Parish in continuing their lives in faith in the Diocese.

SECTION 7. The Bishop, with the advice and consent of the Standing Committee and in consultation with the Parish under Review in question, may remove a Parish's designation as a Parish under Review, thereby terminating any actions or restrictions imposed upon it under this Canon during the period of time it was deemed a Parish under Review.

Resolution D-182B was moved by Chancellor Burroughs, and was passed unanimously.

Report of the Standing Committee - Dr. Carter Whitson

Dr. Carter Whitson made the Annual Report of the work of the Standing Committee during the past year, referring to the Standing Committee Ministry Report for all the details.

WHEREAS the Diocese of Missouri has been led by dedicated and faithful bishops; and

WHEREAS Bishop Rockwell's tenure was characterized by an influx of new rectors, the restructuring of the diocesan staff, and placing an emphasis on congregational development,

BE IT RESOLVED that this 184th Convention of the Episcopal Diocese of Missouri sends its warm greetings and best wishes to the Rt. Rev. Hays Rockwell and Linda Rockwell, wishing them continued health and happy retirement.

Bishop George W. Smith

WHEREAS the Diocese of Missouri has been led by dedicated and faithful bishops; and

WHEREAS the 10th Bishop Diocesan in the Diocese of Missouri, The Rt. Rev. George Wayne Smith, served from 2002 through 2020; and

WHEREAS the Diocese of Missouri experienced a financial turn-around and years of growth under his leadership; and

WHEREAS the Diocese of Missouri created guidelines for the blessing of same sex couples in 2012; and

WHEREAS the Rt. Rev. George Wayne Smith continues his ministry as the Provisional Bishop of the Diocese of Southern Ohio pending the ordination of Bishop-Elect the Rev. Canon Kristin Uffelman White in February of 2024,

BE IT RESOLVED that this 184th Convention of the Diocese of Missouri sends it warm greetings to Bishop and Debbie Smith and gives thanks for their gracious, generous, and continuing service to the people of The Episcopal Church.

WHEREAS the staff of the Diocese of Missouri has toiled diligently to prepare for this 184th Convention,

Further Report from the Committee on Nominations and Election Procedures: Election Results - The Rev. Tamsen Whistler.

Bishop Johnson encouraged all those at Convention to consider service to this diocese and this Church through participation in the election process and an elected office.

Bishop's Report - Bishop Deon K. Johnson

Bishop Johnson reported on many things, beginning with stating we have faced many post-pandemic challenges, and have survived. However, what we need to survive is not what we need to thrive. What will we work on in 2024?

- Our vision of a diocese and "A world transformed by God's love, justice and peace" must be our guiding principle for the way ahead; we must embrace change.
- Promote and educate Lay-Led, Clergy-Supported ministry models. The Commission on Ministry will lay the groundwork for a process in 2024 to encourage and support calls to ministry within the laity, piloting the Lay Associate Minister [LAM] Program working with the Bishop Kemper School for Ministry.
- Continue to discern ways to support those primarily rural communities by looking at new models of ministry such as The Mutual Ministry or Total Ministry model.
- Camp Phoenix will be re-launched, a new course will be charted for Deaconess Anne House, and we'll bring the "Happening" ministry program of music, worship and caring into the life of our young adults.
- Review and revamp as necessary all forms of communication to better serve the needs of the Diocese.
- Faith communities within the Diocese will be paired together for 2-3 years in the Companion Communities program, building on the sense of togetherness and mutual thriving.
- To deepen our spirituality and widen our circle of prayer, every Episcopalian will be invited to be a part of the Diocesan Rule of Life.

Bishop Johnson invited Sister Donna Ruth Hawk-Rienhard, a member of the Anamchara Fellowship, to make a presentation explaining what a rule of life is. Sister Donna Ruth reflected on the work already done by our various religious communities this year and explained how the discernment process to

develop a diocesan rule of life – based on the Diocesan Mission and Vision Statements – will progress through 2024.

- While we face many challenges, we also face many opportunities; yet we must let some things die to be open to resurrection and those new opportunities.
- The Diocese of MO has been called to lead the Episcopal church in a revival of hope; of joy; of love and to continue being faithful, fierce, and feisty followers of Jesus.

Michael Reiser from Christ Church Cathedral, St Louis and The Very Rev. Shug Goodlow, Interim Priestin-Charge, Christ Episcopal Church, Rolla, provided a preview of an Episcopal revival in the Diocese of
MO scheduled for Friday, March 15, 2024, thanking the Rev. Ann Dieterle for all the work that's been
done leading up to this point. A short video on Episcopal Revivals and being part of the Jesus
movement was shown, including a welcome and invitation from Presiding Bishop Curry to Bishop Deon,
delegates to the annual convention and the people of the Diocese of MO to the upcoming Revival.

Announcements – Chancellor Burroughs [and Bishop Johnson]

After Chancellor Burroughs' announcements, Bishop Johnson announced that the water gathered from across the Diocese had been separated into small containers so every congregation in the Diocese had some of that water to take back with them for baptisms. or whatever use deemed, as a reminder that

we are all one church in many locations. He also invited people to join him in the parking lot immediately after Convention adjournment where the JustFood Truck would be blessed and dedicated.

Following the announcements Bishop Johnson asked if there was any other business to come before the meeting of Convention.

The Bishop's Convention Address

by the Rt. Rev. Deon K. Johnson, Bishop of The Diocese of Missouri

presented Nov. 3, 2023 at the 184th Convention of The Episcopal Diocese of Missouri

Now the eleven disciples went to Galilee, to the mountain to which Jesus had directed them. When they saw him, they worshiped him, but they doubted. And Jesus came and said to them, "All authority in heaven and on earth has been given to me. Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age."

-Matthew 28:16-20

In the name of the One, Holy, & Living God. Amen.

One of the constants in my childhood was my grandmother. Coincidentally her name was Constance Katherine Murrell Johnson. Her singing voice was the soundtrack to my childhood. I often woke up to her singing or humming a spiritual or a hymn. Many mornings I woke up to her singing and many nights her voice was the last thing I heard. She died in 2001 and I imagine her in heaven among the celestial voices,

"When I'm happy hear me sing, When I'm happy hear me sing, When I'm happy hear me sing, give me Jesus. Give me Jesus, give me Jesus. You may have all this world, Give me Jesus.[1]"

She sparked my faith. She ignited the ember of God's love and joy for me, not because of what she said, but because of how she treated others. No one was beyond saving and no one was outside the realm of loving.

She welcomed strangers and friends into our house so much so that everyone called her Mother. My story of faith began and continues because of her story. I got my courage from her, my strength from her, my inspiration from her. She sparked my faith with her stories. She did not just tell me stories of faith, she showed me what it meant to be faith-full! Constance was not a woman of great learning, she only had an 8th grade education, but she was full of wisdom. She knew who she was and more importantly, she knew whose she was. She knew without a doubt that she was a part of God's unfolding love story for her and for the world. She knew Jesus, not as a distant figure in a far-off place, but as a constant companion and friend along every journey, every highway, and every byway.

- Who sparked your faith?
- Who brought the story of God's love, grace, and forgiveness alive for you?

Whose story are you sparking with your life of faith?

We find Jesus in our gospel for today gathered with the often-bumbling and somewhat dimwitted (duh-ciples) disciples. Jesus has been preaching and teaching. He had healed the sick, cured the broken, and centered the marginalized. Jesus had upset the status quo, cleansed the temple, and found himself hanging on a Roman cross. Today he stands with the disciples on the other side of the resurrection, sending them out into the world with his final blessing.

On the Mount of the Ascension Jesus sends his disciples out into the world, not with a snazzy program, a beautiful building, or a well-balanced budget. Jesus didn't send them out with a great Sunday School program, a well-organized young adult engagement series, or even a steering committee (thank God Jesus didn't give us a committee). Jesus sent them out with something far less tangible, but infinitely more beautiful and compelling. Jesus sent his disciples out into the world with clothes on their backs, a staff in their hands, shoes on their feet, and a story in their hearts. Jesus sent them out as sheep among wolves with a story, a powerful story of God's love and care for All, ALL God's people. Jesus said to them and to us, "Go! Go therefore and make disciples of all nations!" Notice Jesus did not say, "Wait for them to come to you!" "Stay where you are and make Episcopalians!" Jesus sends them and sends us with the transformational love story of God to make disciples, to look like Jesus, to act like Jesus, and if we are careful, to smell like Jesus. Knowing the promise and the blessed assurance that we remember, "I am with you always, to the end of the age."

- What more do we need to proclaim the Good News of Jesus?
- What more do we need to transform our communities, neighborhoods, and cities?
- What more do we need to be outposts of hope and waystations of love?

Like the disciples, we are sent with nothing but the story of God's transformative love made real and tangible in Jesus the Anointed One. Now, more than ever we need to be bearers, keepers, and sharers of the story.

I am convinced that for the times in which we live, and move and have our being, the church is at its best as a Church in the streets, with the incense of justice billowing about us. The church at its best is the church in the gutter when we reek of hope as we lift up those who have been abandoned and forgotten. The church at its best is the church in the barrio and the ghetto, in the hamlet and the village, where Jesus' siblings struggle and we are called to wash their feet. The church at its best is the church that prays as St. Augustine posited, "Pray as though everything depended on God. Work as though everything depended on you."

We must learn a new language of prayer and a new way of being. We must learn to pray with our feet and go where God already lives among the places and people who are hurting and lost. We must pray with our hands and reach out in compassion to those in greatest need, healing and making whole that which is broken. We must pray with her eyes to see the division and disunity present in our communities and become agents of healing and wholeness. We must pray with our ears and listen for the cries of injustice, oppression, and segregation so that we may step out in faith and be Christ on

the margins. We must pray with our hearts and sit in the hard uncomfortable place of forgiveness, asking that our past hurts may be forgiven as we move forward. We must pray with our very being, knowing that the only gospel some people will meet, the only Christ people encounter today is you. We must pray with our very selves and be present in the world in desperate need.

We as a diocese face many challenges. We have seen, like much of the Church, a decline in attendance and engagement. Many of our communities face financial deficits and fear for our futures. We face head-on the mistrust and at times disdain for organized religion that has come to characterize modern American life. We have too often taken on the fear and despair that has infected our society as our own. We face many challenges. Nevertheless, we will not be defined by the number of butts in pews. We will not be limited to our bottom lines. The biggest challenge facing the church is not the decline of our numbers, our lack of funds, or even fear of the institution. Our biggest challenge is our insistence on clinging to the stories that defined us in the glorious 1950s and our unwillingness to adapt our stories for today. We must be willing to hold tightly to the Jesus of the Gospels who transformed lives and shared love and let go of the stories that no longer give life because we are closer to 2050 than we are to 1950! We must let go of the false narrative that our best days as communities of faith are behind us because God is always, always, in all ways in the business of resurrection.

You are a witness to the resurrection! You have known the pain, and hurt, and loss of Good Friday! You have walked the hard road of Holy Saturday! You have come with despair to the garden like Mary Magdalene looking for death and finding life. Your story, your life, is the story of bearing witness to the spectacularly unexpected grace of resurrection! How dare we keep silent! How do we who have borne witness to the transformational power of God working in, on, and through us in so many ways keep silent? We have a story to tell, perhaps we should tell our story and let God worry about the rest.

In 1868 Bishop Charles Robertson and his wife Rebecca arrived in St. Louis to serve as the second Bishop of Missouri. Bishop Robertson was at the ripe old age of 33 when he was elected and upon arrival in Missouri found, "21 parishes and 6 missions stations supplied with 28 clergy, with some 2500 communicants" across the entire state. In his memoir, he wrote, "The people were discouraged, and the parishes burdened with debt.[2]"

Later on in 1873, Rebecca Robertson, upon finding out that the Cathedral was on the verge of closing, and by extension the Diocese, made a visit to every member of the vestry and any clergy that would listen to her, to remind them of their Christian call to follow Jesus and to support the work of spreading the gospel. Almost singlehandedly she saved the Cathedral and reset the life of the Diocese. Her writing desk lives in my office as a reminder of the spiritual DNA that animates us today.

Like our spiritual ancestors, we are writing a new story out of the ashes and loss of the old. We cannot be agents of gospel change if we are not willing to change for the gospel.

We lose sight of the gospel when we become more concerned about the walls that we have built than going out the doors from which we are sent. We lose sight of the Gospel when we are so concerned about being holy and not concerned with those who need to be housed.

When we are more concerned about our image than seeking the image of Christ in the poor and the rejected, we have lost sight of the gospel. When we are more concerned about balancing our budgets and our bottom line than we are about those who were born into poverty, we have lost sight of the gospel.

Perhaps it is time to move from comfort to conviction. We cannot be agents of gospel change if we are not willing to change for the gospel.

Our faith at its core is <u>not</u> about affirming us as we are, but transforming our lives as we could be in the love of Jesus. That is what Jesus offered to the disciples on the Mount of the Ascension. That is what Jesus offers to us here and now.

Building on the stories of faithful followers of Jesus who called Missouri their home, we are shaping a new story for our Diocese that is centered on love, compassion, and justice. These stories shape our identities. They provide a mirror through which we see our own experiences reflected, helping us make sense of our lives. Whether they are passed down through generations, etched on the pages of books, or depicted on screens, stories are a testament to our innate need for narrative.

We are bringing to life the desires and dreams of God's people with God's vision for our communities and neighborhoods as we craft and create a new story. We are defining and refining the story of God's love in countless ways across this diocese! We are living and sharing the stories of Christ's compassion, hope, and joy in the many lives our communities of faith touch in immeasurable ways. I love to tell the story of this diocese!

I love to tell others about the amazing things and the life-giving ministries present here in our corner of the kin-dom. Through community outreach, new church planting, and reorientation towards deepening spirituality, we are a church writing a new chapter in the way of Jesus.

From the giving gardens in our communities including, St. Paul's in Sikeston, St. Mark's in St. Louis, Trinity in St. Charles, St. Martin's in Ellisville, Hope in Town & Country, and St. Barnabas in Florissant we are caring for God's creation and feeding bodies and souls. Through community meal programs at St. John's in Tower Groves, Christ Church in Rolla, and St. Francis, in Eureka we are deepening the bonds of community and feeding Christ in the guise of strangers and friends.

We donned orange across the diocese to amplify and lift up the stories of those who lost their lives to gun violence. We remember those killed in the City of St. Louis each week in the votive lights on the high altar of the Cathedral.

In mid-summer, eleven congregations participating in Requiem or Renaissance gathered in retreat to bear witness to the transformative power of collaboration and holy hospitality. Each faith community reminds us that God's work is in our hands and that even though we may not see the clear path ahead, we walk by faith and not by sight into the Christ-centered future.

We cannot be agents of gospel change if we are not willing to change for the gospel. Change is happening!

We cannot rest on what we have done and we dare not stay how we have always been. This moment calls for us, like the disciples, to **go** out into the world and worry less about growing our church and worry more about showing Jesus!

We must become a nimble church! A nimble church that walks out to meet people in the midst of their story. A nimble church is a church willing to go out into the streets and engage with a hurting world. A nimble church is one that is focused on Jesus, willing to take risks, fails spectacularly, and loves relentlessly. We must put away all that weighs us down and holds us back as we go to make disciples. We cannot be agents of gospel change if we are not willing to change for the gospel.

Earlier this year, I visited the Rev. Richard Tudor as he prepared for his final journey. We talked about many things; I gave him the last rites and a final blessing. He stopped me and told me about his first call after ordination. In the pulpit of the church in a spot only the preacher could see was engraved the words from John's gospel, "Sir, we would see Jesus!" Rich said to me, "I hope that in my life and my ministry, I showed Jesus." I assured him that he did. Rich died a few days later.

"Sir we would see Jesus!" That is my prayer, my dream, my hope for us, for such a time as this that we can boldly and proudly say, that in us, through us, by us, we have shown the world Jesus. That with Constance and all those who have sparked our faith we can join and sing:

As we're going hear us sing, As we're going hear us sing, As we're going hear us sing, Give me Jesus. Give me Jesus, give me Jesus, You may have all this world Give me Jesus.

Inch by inch, story by story, community by community, we move forward toward a new future, a new chapter in the story of God, where love is paramount and justice stands firm, where hope is our currency and joy is our language. We move forward toward a Christ-centered story where the pandemic of fear is vanquished and the tightrope of hope is our lifeline.

Now is the time. This is the moment. Amen!

"Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age." Amen.
